**Meeting was called to order at 5:34 p.m.**

**Sign Orders:**

- ❖ Orders were approved and signed by the Board unanimously for the Treasurer.

**Minutes from April 14, 2022:**

- ❖ Minutes from April 14, 2022 were approved by the Board unanimously.

**Other Business:**

- ❖ Ryan Kneeland, resident, joined the meeting to request signatures from the Selectboard for a ROW (Right of Way) agreement for power. The Board reviewed the document and signed the agreement.
- ❖ Steve Mason, School Board Chair, join the meeting to ask permission to speak a little at Town meeting and to allow some students to show about a 15-minute presentation. The Board agreed this would be okay.

- ❖ Jason Powers, resident, came to report a truck that has been in the Town right of way all winter and it is also partially on his property. He stated that the truck belonged to his neighbor Ken Canning and would like the Board to talk to Mr. Canning about getting it moved. He also stated that if the Board sends Mr. Canning a letter that he would also like a copy of the letter sent to him. The Board told Jason that they would look into it and see if they can get Mr. Canning to move it.
- ❖ UPDATE: Jennifer Blay, Science Teacher, joined the meeting to notify the Board that she had finished staking out the trail, it is a little less than 1800 feet. She stated that she had asked Marc Sicotte to get a few quotes for her on what it would cost to put the running/walking trail in. The Board told Jenn that they would like a little more time to think about it and discuss it before they give her their final decision. Jenn also asked the Board if they would like signage to put up in the Gelo park Trail to alert people of the game cameras and to ask them to carry out what they bring into the trail to help keep it clean. The Board stated that they would like the signage to put up. Jenn also asked if they wanted a sign that said not responsible for accident or injury. The Board stated that they would like to check with VLCT before putting a sign like that on the trail.
- ❖ Truck Weight Permits were approved and signed for the following: **R.L. MORIN & SONS CONSTRUCTION/RICKY MORIN.**
- ❖ Anne Lepeltier sent an email to the Town Clerk addressing the Selectboard of a request. Her request is to ask permission to use the Town green to hold a clothing “pop-up”, for she has done this in several other towns, and it has been very successful. The Board read the email and decided that this would be a fine idea and have granted her permission to do so on the front Lawn of the Clerk’s office provided she doesn’t hold it the Saturday of town meeting May 21, 2022 and that she checks with the school about using their parking lot for extra parking if needed.
- ❖ Rob Young emailed Darren the details of the upcoming culvert project on Irish Hill Road. Darren shared this with the other Board members at the Board meeting. They had to make a decision on whether to sign the agreement. They decided to sign the agreement with the stipulation that the State will be held accountable for any damages to the roads being used for detour during the project.
- ❖ Calvin updated the Board that he had ordered the timbers for the Stewart farm rd. Bridge replacement.
- ❖ Becky updated the Board on the bankruptcy procedures for a town landowner that will have more details coming after the May 17<sup>th</sup> hearing.

**ATV Permits:**

- ❖ The Clerk asked the Board if they had made a decision on whether or not the Town of Lowell was going to continue the distribution of ATV permits for the Town. The Board decided to do away with the permits this year. The only stipulation is that everyone will have to follow VASA rules and VASA dates of trail use for the ATV’s.
