Dear Parents,

I have enclosed a **Student Bus Information Form** and the **Bus Transportation Contract** to be completed and returned to the school office before the first day of school. Drivers this year are Wayne Hughes (407) 730-0120 - Cordele/Wilcox County Route and Wayne Baxter (229-567-5227) - Arabi/Turner County Route,

Please call the driver:

- 1) If your child is not going to ride in the morning so he/she will not wait for a rider who is not coming
- 2) If you are more than 5 minutes beyond normal time the bus will have to leave in order to make it to school on time
- 3) If someone is not on the list to pick up your child – call school and driver
- 4) If you are going to be late for pick-up
- 5) If a situation arises that the bus driver or school need to be aware

The fees this year are \$55.00 per month/1 child from Pinecrest and Arabi, \$70.00 per month/1 child from Pitts, Rochelle, and Ashburn. If you have more than one child the fee is \$100.00 per month per family for either route. Bus fees will not be due until September (no fee for August) because of Thanksgiving and Christmas Holidays.

CRISP ACADEMY BUS TRANSPORTATION CONTRACT

The fees this year are the following:

\$495.00 for one student for the Cordele and Arabi pick up locations

\$630.00 for one student for the Pitts, Rochelle, and Ashburn pick up locations

\$900.00 maximum for more than one student riding for any of the pick up locations

You have the option to pay the total fee by September 1st or monthly based on a 9 month period beginning in September and ending in May.

_____ Nine (9) monthly payments in the amount of \$ _____ due each and every month on the first (1st) day of the month beginning September 1, 2018 and continuing each month with final payment being due on May 1, 2019. Parent understands that Crisp Academy does not mail monthly statements and therefore Parent assumes total responsibility of the due dates for each payments

Regardless of the payment option you choose you are obligated to pay the entire cost for the year whether or not you continue to ride the bus all year.

We do not offer per day or per month rider fees or reimbursements for not riding.

You are responsible for the repair of any damages your child creates on the bus that is outside the normal day to day wear of the school bus.

Your child must abide by the student handbook and behave in a manner that does not distract the driver from his duties or otherwise endanger the safety of your child or other bus passengers.

In consideration of the acceptance of this contract by the School, the undersigned agrees to pay the required TOTAL TRANSPORTATION FEES for the full academic year and any additional fees incurred and agrees to be bound by the provisions of this Contract.
