- 2. GRADE IN SCHOOL

PLEASE NOTE: Names submitted without grade in school will not be entered in the data base and will not be considered a part of your roster! Double check your roster entry before sending it.

Please do not submit your roster early and then make multiple additions or corrections. Please wait until you are very sure that it is relatively stable and unlikely to change much before the first meet.

Please use an upper case first letter and lower case after that. Please do not use all upper-case letters or all lower-case letters or any combination other than the standard English language convention for names. Please take the time and make the effort to do this correctly we do not have the time to correct careless mistakes!
- 2. Your roster submission MUST include each athlete's grade in school. Do not forget this piece of information or your athlete(s) will not be entered in the database.
- 3. Submit your entry no later than 9:00PM, Tuesday, December 6 or you will have no one participating in the first meet!
- 4. REMEMBER: entering your roster is not enough! You must **EXPORT** your roster in order for me to receive it. Make sure you get a confirmation of export from *TrackCentral*.
