

For your dog's protection, as well as the dogs in the kennel, we ask that you provide us with a copy of your dog's health records to ensure that the vaccinations are up to date.

The following vaccinations are **REQUIRED** before we will accept your dog into our kennel: Distemper-Hepatitis, Parainfluenza, Parvovirus, Bordetella (kennel cough), Leptospirosis, and Rabies. A negative Heartworm test a Preventative medication for all internal parasites including heartworms is required. We also recommend vaccination for Lyme disease and Corona Virus.

If your dog is receiving any kind of ongoing medication, vitamins, nutraceuticals or preventatives, we ask that you provide us with the treatments and instructions for administration.

Our fee for gundog/hunt test training is Five Hundred Dollars (\$650.00) per month + 50.00 for food. A deposit of One Hundred Dollars (\$100.00) will reserve a training slot for you if you desire to schedule training for a later date. We do not accept dogs for less than **TWO Months** unless for a specific isolated problem. Special arrangements will then be made. Payment for the first month (or partial month) of training is required upon arrival of the dog. Each additional month's training fee will be due on the first of the month's training.

A fee for live flyers shot for your dog during training will be charged monthly. The charge will be the cost of the flyer to Ringneck Kennel.

When AKC, UKC Hunt tests are involved, owners are responsible for the premium fees. If there are travel expenses they will be divided equally between the numbers of dogs participating in the tests for that trip. Statements for training fee and other charges will be sent to the owners each month.

Basic obedience may take thirty (30) to sixty (60) days depending on the dog's progress learning each command.

Training for hunting and hunting tests may take from eight (8) months to two (2) years, depending on the level of performance to be trained to.

I, the undersigned, owner of the above described animal, do hereby agree that Ringneck Kennel, its agents, servants, and employees, are hereby relieved of legal liability for my animal's health, including illness, disease, and internal condition, accidents resulting in cuts, scratches, bites, broken bones, or death, whether such illness or accident occurs through transportation or otherwise, on or off the premises of Ringneck Kennel.

I specifically authorize Ringneck Kennel to see emergency veterinary care in the event my dog becomes ill or injured while at Ringneck Kennel. All veterinary fees will be paid by the owner(s) of said dog.

If any and all fees are not paid within ten days of the due date, said dog will not be trained but receive adequate food and water. If after thirty (30) days fees are still not paid, the trainer(s) has the right to sell said dog for the sum of any and all fees due.

A defaulting party shall pay all expenses, reasonable attorney fees and court cost incurred in good faith by the other party in enforcing the terms of this contract.

This contract shall be governed by and interpreted in accordance with the laws of the State of Iowa in existence at the time of its execution.
