Positions to Open

Qualifications

- The **Secretary and Treasurer** Officers must have been members in good standing since August 15th, 2021
- Board **Directors** must be members currently in good standing.
- NEA and FEA **Delegates** must be members currently in good standing.

Terms of Office

- The term of office for Secretary, Treasurer, and Director will run for the remainder of the current term ending on May 31, 2023.
- The term of office for NEA and FEA Delegate will be for 2022 only.

NEA Representative Assembly and FEA Delegate Assembly.

- NEA Representative Assembly, July 2nd 6th, 2022, Chicago, Illinois. You can be a locally funded delegate or a state funded delegate. You must declare if you want to be on one or both ballots.
 SECA will fund food, lodging, and travel for the winning Delegate/s (dates and location subject to change)
- FEA Delegate Assembly, October 13th 15th, 2022 in Orlando, FL. You must declare if you want to be on this ballot. SECA will fund food, lodging, and travel for the winning Delegate/s (dates and location subject to change)

Nominations

Nominations open on January 27, 2022 and will close on February 24, 2022.

- Nominations may be made in writing or in person and must be received by the SECA Elections Chairperson at the SECA Office located at 813 Orienta Ave., Altamonte Springs, Florida, no later than **5:00 p.m. on Thursday, February 24, 2022**, via fax, courier, email, regular mail, or hand delivery.
- Members may send email nominations to seminole.uniserv@floridaea.org.
- Nomination forms are available upon request but are not required.
- Any member in good standing can nominate candidates and run for office if they meet the qualifications above.
