1) INTRODUCTION

Welcome to Angel Hearts for Jesus LLC's web site located at www.angelheartsforjesus.com. We recognize that privacy is important, and value the privacy of the users, subscribers, publishers, members, and others who visit and use our site.

This Privacy Policy is incorporated into and is subject to the site's Terms of Service. Your use of AngelHeartsforJesus.com, and any personal information you provide through the site are subject at all times to this Privacy Policy and the Terms of Service. By using the site, you expressly consent to the information handling practices described in this policy.

2) AMENDMENT

This Privacy Policy may be revised periodically; please revisit this page to stay aware of any changes. Your continued use of the site constitutes your agreement to this Privacy Policy and any future revisions.

For revisions to this Privacy Policy that may be materially less restrictive on our use or disclosure of personal information that you have provided to us, we will make reasonable efforts to notify you and obtain your consent before implementing revisions with respect to such information.

3) CHILDREN'S PRIVACY POLICY

If you are under 13 years of age, you should not provide any personally identifiable information to web sites without the knowledge and permission of your parent or guardian. In addition, under the Children's Online Privacy Protection Act (www.coppa.org), it is illegal for web sites to obtain this information without parental consent. Due to the difficulty of this consent process, anyone under the age of 13 is restricted from registering on this site.

4) INFORMATION COLLECTED AND HOW IT IS USED

- **Information you provide** – To help promote the service of others in the example of Christ, Angels Hearts for Jesus LLC encourages the creation of clubs. If you choose to register your club at AngelHeartsforJesus.com, we ask for the Club name, Church/School name, State/Country, a name and email address of the primary club contact (who must be 13 years of age or older), and an example of the club's service. At the time of registration, we provide the club contact an option to share the club's information with others. If the option is selected, Angels Hearts for Jesus LLC will publicly display the Club name, Church/School name, State/Country, and the example of service. The

primary club contact's name and email address will not be disclosed; we use such information only for club correspondence.

- **Expectation of privacy** – When you register a club at AngelHeartsforJesus.com, we strive to protect communications within our website. However, do not expect any communications within our website to be exclusive to any single user or administrator.
- **Cookies** – When you access AngelHeartsforJesus.com, we may store some information on your computer. This information will be in the form of a 'Cookie' which allows us to tailor our web site to better match your interests and preferences. Cookies also remember your information so that you will not have to re-enter it during your visit or the next time you access the site. However, please be advised that with most Internet Browsers, you can erase Cookies from your computer hard drive, block all Cookies, or receive a warning before a Cookie is stored. Please refer to your Browser instructions or help screen to learn more about these functions.
- **Log information** – When you access AngelHeartsforJesus.com, we may automatically record information that your browser sends whenever you visit our website. These server logs may include information such as your Internet Protocol address (IP address), browser type, browser language, the content and pages that you access on the site, and the dates and times that you visit the site.
- **User communications** – When you send email or other communications to Angel Hearts for Jesus LLC, we may retain those communications in order to process your inquiries, respond to your requests, and improve our services.

5) INFORMATION SHARING
