



2019 CAMBERSHIP APPLICATION

The Three Fires Council Campership Committee is comprised of volunteers from the council. Camperships can be requested for:

- Registered Three Fires Council Scouts for use at Scouts BSA and Webelos Summer Camp sessions at Camp Freeland Leslie. Camperships are limited to a **maximum of 50% of the Early Bird Registration Fee** for any CFL Scouts BSA/Webelos session the Scout is attending.
- Registered Three Fires Council Scouts and siblings from the same family for Three Fires Council Day Camps. Camperships are limited to a **maximum of 50% of the Early Bird Registration Fee** for any Day Camp a Cub Scout or a sibling in the same family is attending.
- Campership funds **are not provided to adults** due to limited funds.

If applying for a campership, please register the camper at <http://threefirescouncil.org/our-camps/> Go all the way through the online registration process and select the "Pay Later" payment option. After the campership application is received, the amount requested will be entered into the online registration system. You will then receive an email from the Council Program department: *"Campership (PENDING): for _____ Your Campership of \$ _____ has been temporarily applied pending approval from the Campership committee. Leaders and parents will be notified via email when approved. We are advising you the amount early so that your payments will not exceed the balance with the pending campership applied if approved."*

Decisions will be made and communicated to the contact person listed below by the week of April 23, 2019. If additional funds are due, the contact person will receive an email stating the balance due. Please make this final payment online or at the Norris Scout Shop either in person or over the phone.

PLEASE READ: In order to receive the Early Bird rate, the campership application must be submitted to the Norris Scout Service Center by **April 2, 2019**. Applications received by this date will be assured the Early Bird Rate even if not fully paid by this date.

Any Campership Application received on or after April 2, 2019 will not be awarded more than the maximum percentage of the Early Bird Rate. The fee increase will be the responsibility of the applicant. Due to limited funds, applications received on or after April 2, 2019 may go on a campership waiting list.

NOTE: Campership funds are not transferable to another person, event or refundable. If circumstances change and the amount is not needed/ cannot attend, please notify the email above so that the funds can be used for a camper that is on the waiting list.
