Dear Governor Cuomo, Greetings to you;

I AM Paulett Angella Hemmings EARTH, CHREATOR OF THESE EARTHS AND THE ONLY CHREATOR OVER ALL CHREATIONS. I AM THE CHREATOR OF LIFE AND OVER ALL LIFE, DEATH, AND ANYTHING INBETWEEN. NO PERSON OR THING IS HIGHER THAN I AM.

Immigration

Change of Residency

All peoples looking to live in another State/Country should apply through the immigration process. The immigration can be applied for before entering the State/country. When the application is received, if in person a temporary immigration card is received on that day, with your picture to last two years. If by mail in the same country, the applicant should receive the document no later than two weeks after it was first mailed. If the applicant is in another country, the application for temporary status should not take more than one month (taking into consideration the mail delivery).

If Change of Residency is applied for in the same State/country, the state residency status should not take more than 4 months. If in another country, the residency status should not take more than 6 months.

For all countries/States, all persons who has applied for change of residency must get their residency in the country they reside in and applied for it, unless bad circumstances cause the person to relocate before the change of residence is approved. All application received or mailed by May 15, 2017 must get their residency processed as identified above.

For all Countries/States, all immigration applications pending must get their change of residency, and citizenship approved immediately.

For all Countries, the word citizenship is changed with effect from June 1, 2017. The new name is Permanent State Residency (PSR). There is no more Green Card for the US. Instead of Green Card it is now State Residency (SR).

For all countries, all prior citizenship application pending must get their approval for change of residency with immediate effect. All new applicants from June 16, 2017 will go through the new application period listed above.

Any person who wants to apply for their State Residency can begin the process right now, and those who qualify gets it within the time identified above. If the process take more than as stated, all their fees return to them and a fine of \$200.00 per month is accessed. The processing agency pays the fee to the applicant. This rule goes through the end of May, 2018 and then return to normal operation.

Permanent State Residency

Permanent State Residency is obtained when each person applies for one after two years of residency approval, anywhere in this Earth. The process time is no more than two months with no questions or special ceremony.

Any person who wants to apply for their Permanent/State Residency/Citizenship can begin the process right now, and those who qualify gets it immediately within no more than one month wait time, if the process take more than one month all their fees return to them and a fine of \$200.00 per month is accessed. The processing agency pays the fee to the applicant. This rule goes through the end of May, 2018 and then return to normal operation.

Change of Residence and Marriages

There is no requirement to be married in order to receive a change of residency status or Citizenship since the year 2000.

For the Caribbean/West Indies, including Guyana and Belize, the immigration process for permanent and temporary residency should be the same as is today. However, no Commonwealth status is allowed without visas. All British and Canadian citizens are required to have proper permits like any other outside the Caribbean/West Indies and go through the same immigration procedure as today.

For the Caribbean/West Indies, including Guyana and Belize, all prior citizenship application pending must get their approval for change of residency with immediate effect. All new application starting from June 1, 2017, will follow the prior immigration process.

The fee for change of State Residency is between \$15.00 to \$25.00 US (effective January 2000). The fee for Permanent State Residency is between \$10.00 to \$15.00 US (effective January 2000).

Dual Citizenship

An applicant for change of residency status can retain his or her home state/Country and another state/Country of residency to form a dual citizen. There are some Top Rankings who can live anywhere they choose without the dual citizen restriction, I will identify when I choose.

Visas

Visas fees for all states/countries are reduced 80 percent with effect from January 2,000.

There is no ban on travel to and from any state/country in this Earth, or any earths for residents of each Earth since inception of the Earths. The ban is for insects, animals, species delevs. All residents go through the normal visa application process to enter a state/country.

Deportation

No deportation of anyone who is a resident of an Earth in the natural, real, flesh from any state/country since the Earth open.

Marriages

No more marriages performed by a Clergy or Minister or Pastor or any Religion Representatives with effect from January 2017. Marriages are performed for now by an Attorney/Barrister, Marriage Officiant, Judges, Clerk of the Courts, Notaries, Justices of the Peace, Legal Assistant, Paralegal. No usages of the word God, Jesus, Holy Spirit, Allah, Buddha, Confucius, Akan, and other religious representatives or the Bible or any religious artifacts, songs, poetry, chants, or emblems in marriages.
