**RESOLUTION NO: SL-34-2019** 

- TITLE: Amending and Adding 4 members to the Summit Lake Paiute Tribe's Request for a Secretarial Election Certified Voters List
- WHEREAS, the Summit Lake Paiute Tribe is organized, pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Tribal Council; and
- WHEREAS, the Summit Lake Paiute Tribal Council has the power and duty to represent the Summit Lake Paiute Tribe in negotiations with Federal Governments in matters to benefit the general welfare of its tribal membership; and
- WHEREAS, the Summit Lake Paiute Tribal Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute Reservation; and
- **WHEREAS**, the Council is authorized under Article II Governing Body, Section 1, (h) of the Articles of Association (to establish a membership roll, enact regulations governing the loss of membership, future membership and the adoption of members into the Summit Lake Paiute Tribe...).
- NOW THEREFORE BE IT RESOLVED, that the Summit Lake Paiute Tribal Council approves an amendment of four (4) Summit Lake Tribal Members: Tribal Member 7, Tribal Member 152, Tribal Member 202 and Tribal Member 221 to the Certified Eligible Voters List; and
- **BE IT FINALLY RESOLVED,** that the Tribal Council of the Summit Lake Paiute Tribe hereby certifies the amended Eligible Voters List which will be submitted in an electronically sortable format with names, last known addresses, dates of birth of all tribal members who will be 18 years of age or older within 90 days of the date of this request as required by 25 CFR Part 81.6; and
