The meeting was called to order at 6:40 p.m.

The minutes from last month's board meeting were approved electronically.

# FINANCIAL REPORT: presented by Angie Christensen

- The club currently has \$8, 296.95 savings and \$23,458.57 checking
- The club had a net loss of \$2,769.97 for October some of this was ice time (last payment of August Ice); also paid the yearly clubroom rental fee.

## **MEMBERSHIP:** presented by Crystal Dunn

- The club currently has 92 active members (a copy of membership distribution will be placed in the board meeting minutes folder); in addition, there are approximately 6-8 JAM members that have not been entered.
- The club received a certificate from USFSA for increase in membership.

## JUNIOR BOARD: presented by Kaylee Hatfield and Daryn Smith

- The junior board would like to host the next club social Saturday, December 3. June would like to add an additional Holiday Show rehearsal and could couple the two. The Junior Board suggested a potluck with games. Skaters and junior board members would bring in food.
- Charity event: The Junior Board would like to do a charity event around the holidays. Suggestions made were: caroling for cans, volunteering at the Catholic Action Center (volunteers would bring food to make and serve it), caroling at the UK Children's Hospital or doing a craft with the inpatients, assembling a box of food for a needy family. The Junior Board will need to discuss this further.
- Crystal reminded them that January is National Skate Month so need an activity on their part.

## HOLIDAY SHOW UPDATE: presented by Crystal Dunn and June Warta

- June would like another hour of practice time for some of the bigger group numbers. The rink is hosting a holiday photo booth on November 26<sup>th</sup> and have agreed to provide some free ice time in exchange for volunteers to help run the photo booth.
- The rink has volunteered to pay for fliers to advertise the Holiday Show that will go the public schools as it helps advertise the rink if the school board approves the kids admission will be \$2.00 with a paying adult. They may not approve the \$2.00 charge, however, and, in that case, admission for children would be free. The rink will also pay for the tickets and posters for the show– we will put their logo on them. Have sold several ads in the program.
- Matt Koziatek will do the photography for the show. Information will be sent out to club members. \$45 for action shots/stills (3 poses), a copy of show photos and a group photo. Skaters will get three poses can choose from. Dates for pictures day of full dress rehearsal Monday the 28<sup>th</sup>. Skaters will have to sign up for pictures early or can stay late. Could do some during freestyle and skaters could wear the costume in. If have an additional practice, could do some then as well.

## **TEST SESSION:** presented by Crystal Dunn

- 51 skaters have signed up. Need to be off the ice at 1:15. Are scheduled to go until 1:13 now. Warm up begins at 6:55 p.m. June will open rink at 6:00 a.m. Board members will arrive at 6:15 p.m. The rink has agreed to resurface during the 10:30-11:00 time frame (Crystal will confirm this with Dennis). Cost for resurface will be \$75.00.
- Regina is in charge of hospitality. Will cater in lunch from Panera (soup and sandwiches). Will plan to set up as much of hospitality room as can on Saturday.
- Dodie, the Russels, Joan and Sherri Cary are serving as judges. Dodie would prefer to use back party room for the judges and has requested for the judges sit on lobby side in hockey box. She has requested an electric blanket with an extension cord for use by the judges. Blankets and hard warmers are ready for use as well. Susie will provide bagels.

- There is a current issue with the harness belt –needs replacing. Crystal has spoken with the company from which the harness was purchased. Crystal will also check with the insurance company to see how often the harness has to be inspected as it was inspected only a few years ago. Another option is to purchase a new belt from the manufacturer and replace it. The hardness will not be used until this issue is resolved.
