

AN ORDINANCE VACATING A CERTAIN ALLEY  
IN BOOS' SUBDIVISION TO  
THE CITY OF NEWTON, JASPER COUNTY, ILLINOIS

BE IT ORDAINED by the City Council of the City of Newton, Jasper County, Illinois, that it has been determined that the public interest would be served by vacating the following alley located in the City of Newton, Jasper County, Illinois, legally described as follows, to-wit:

That portion of the Twelve (12) foot wide alley running East and West adjacent to the North end of Lot 7 and Lot 8 in Block 3 of Boos' Subdivision to the City of Newton, Illinois.

Which portion of said alley is hereby vacated. A plat of said Lot 7 and Lot 8 is attached.

Provided, that the City of Newton, Jasper County, Illinois, does hereby reserve and retain the right and easement to place, use, maintain, operate, repair and replace, by itself or by any licensee, or a holder of a franchise from the City, any and all poles, wires, pipes, conduits, sewer mains, water mains, and/or any other facility or equipment for the maintenance or operation of any utility now located or hereafter placed on any part of the alley vacated by this Ordinance.


BE IT FURTHER ORDAINED that at the request of POEHLER PROPERTIES, LLC, owner of the lands that adjoins the North side of that portion of the alley herein vacated, title to the entire vacated portion of the 12 foot alley shall vest in the owners of said Lot 7 and Lot 8 in Block 3 of Boos' Subdivision to the City of Newton, Illinois.

BE IT FURTHER ORDAINED that the City Clerk shall record in the Office of the Recorder of Jasper County, Illinois, a duly certified copy of this Ordinance.

This Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.
