- 9. OLD BUSINESS.
- 10. NEW BUSINESS.
- 11. STATEMENTS BY: COUNCIL MEMBERS, CITY ATTORNEY, CITY TREASURER, CITY CLERK AND MAYOR.
- 12. SCHEDULING OF NEXT REGULAR MEETING AND SCHEDULE COMMITTEE MEETINGS.
- 13. EXECUTIVE SESSION.
- 14. ADJOURNMENT.
