## Grading: Credit/No Credit

At Tuesday's Board meeting, our Board approved a Credit/No Credit component to this spring's report cards for all students. It was the culmination of a month-long collaborative discussion that included District Cabinet and certificated employees, including your LVEA site reps and Executive Board. LVUSD has a unique learning community that needs a comprehensive solution of how to calculate and report grades since instruction was abruptly shifted from classroom to distance learning. With all of the challenges of extending instruction via distance learning, our employees have all done an amazing job of staying focused on what's important - providing the best possible education for your students! Here are the highlights from the Board Resolution:

Elementary: At the conclusion of this trimester, teachers for grades TK-5 will provide feedback on distance learning in the comment section of the report card, as well as goals that will help support students in their academic progress. The "1", "2", or "3" academic indicators will not be used on the spring 2020 standards-based report card.

Secondary: Teachers will continue grading assuming an A-F system for all students. Students and their parents/guardians will be given the opportunity to convert a spring 2020 semester course grade of "A" through "D" to a final mark of "Credit." And a semester course grade of "F" to a final mark of "No Credit." This option will be available for any or all courses for the spring 2020 semester, and the window for students opting for these changes will be June 10-30, 2020. Teachers will not have to make any grade changes to "Credit" or "No Credit" because of this policy.

## Concurrent Enrollment: Is LVUSD Getting Out of the World Languages business?

Agoura and Calabasas High Schools are losing 17 World Languages sections next school year and the total number of sections will be about half what it was just five years ago. LVEA has been concerned for years about the opportunity our Board Policy provides for students to take World Languages and other courses at any one of the pay-for-an-"A" institutions that are available, mostly on-line. While there are some no-charge charter options, most of these organizations are more readily available to our families with more financial means, and this has created a real equity issue. Yes, our World Languages courses are rigorous; however, our families (especially those with more financial resources) are skirting the traditional path by taking a much easier, guaranteed "A" path. What's worse is these courses are embedded in our transcripts and inflating students' LVUSD GPAs. LVEA strongly urges our district to stop allowing these outside, easy courses that diminish the integrity of our transcripts. They are the antithesis of persistence and grit!

# **Increasing Your Salary Column**

Along with years of service, you can increase your yearly salary by completing graduate level courses and/or obtaining an advanced degree; however, shifting to a new salary column is not automatic. On April 23, Sherry Sonne sent everyone an "Intent To Change Salary Classification" email with an attached form that needs to be completed if you want to shift your salary column to the right and increase your income for next school year. If you are planning to or have taken classes and think you may change salary columns for the 2020-21 school year, you need to fill out and submit the form to Sherry by June 1, 2020. Your salary will be enhanced during the summer when the district receives your official transcripts and intent form. The deadline to turn in your official transcripts is October 1, 2020.
