



## Bad Date Sheet – August 15, 2019

Shift publishes the “Bad Date Sheet” as a way for sex workers to share bad experiences and help protect each other. Reports are confidential and can be done anonymously. Staff at SafeWorks and Shift can also take reports directly and provide support to sex workers.

**What is a bad date?** A bad date is anything that you don’t want others to experience. This includes an uneasy or creepy feeling about someone, theft, refusal of payment, threats, and all acts of violence and aggression. *We often have additional information and reports that have not been published, please contact Shift for these details.*

Shift provides support services to adults of all genders who are working (or have worked) in the sex industry. We have a harm reduction and rights-based approach to sex work: this means that the safety and human rights of sex workers are our focus. Our support is here for those wanting to continue working in the industry, get out of the industry, or anything in between.

**Date:** August 12, 2019

**Description of Event:** Client sees sex worker regularly scheduling out calls. One time approached the worker via text asking if she needed somewhere to live and that he could be a possible landlord. This client is known to ask other sex worker in the community this to gain a new sense of power/ control.

**Description of Date:** 45-50 years of age, Caucasian, male, and brown eyes.

**Description of Vehicle:** N/A

**Date:** August 5, 2019

**Description of Event:** Outcall location was arranged, date was from out of town and met the worker at predetermined hotel. Date promised to pay later and the worker never received payment for services.

**Description of Date:** 36-40 years of age, Caucasian, male, long dark hair, scruff, medium build, casual clothing, hat, and brown eyes.

**Description of Vehicle:** car

**Date:** June 17, 2019

**Description of Event:** The date was arranged through an agency at outcall location (hotel), client paid in advance. The client set the room up “romantic dark” however the client’s mood changed drastically he quickly became aggressive and rough, and began smothering and choking the worker. This was not agreed upon in advance, the worker left quickly after the date.

**Description of Date:** 25-28 years of age, Caucasian, young man, clean cut, slim build (150 lbs), glasses, white straight teeth, and brown eyes.

**Description of Vehicle:** N/A

**Date:** June 15, 2019

**Description of Event:** The date was arranged on an outcall basis. The client gave requested unreasonable services and had creepy behaviour. The client also used fake pictures of themselves and requested condomless sex.

**Description of Date:** 18-25 years of age, East Indian, brown eyes

**Description of Vehicle:** N/A

---

**Date:** June 13, 2019

**Description of Event:** The date was arranged through Leo List and a texting app. When the worker arrived the client pretended not to know the worker. The client then became aggressive, took photos of the worker's car and threatened to report the worker to the police.

**Description of Date:** 18-25 years of age, Caucasian, brown eyes

**Description of Vehicle:** Car

**Date:** June 5, 2019

**Description of Event:** The date was arranged at the worker's apartment. The client sexually assaulted the worker. The worker fought their way out and demanded the client leave. The client refused to leave until oral sex was completed.

**Description of Date:** 51-55 years of age, Caucasian, white shorter hair, average build and blue eyes.

**Description of Vehicle:** Car

---

**Date:** May 14, 2019

**Description of Event:** The date was arranged over text. The client asked for rates and after the worker provided them, the client made creepy and violent threats.

**Description of Date:** 18-25 years of age, Caucasian, brown eyes

**Description of Vehicle:** N/A

**Date:** May 3, 2019

**Description of Event:** The date was arranged via text message, client was polite at first. When the worker requested references the client became verbally abusive and threatening. The client threatened to harm the worker if she did not take the booking.

**Description of Date:** 30-35 years of age, Middle Eastern, brown eyes

**Description of Vehicle:** Car

**Date:** Ongoing

**Description of Event:** The dates were arranged at client's home. The client encouraged the worker to become intoxicated before services were completed. The client often offers to pay with drugs instead of money. The client requested unreasonable services. The worker has left the industry and the client continues to stalk her.

**Description of Date:** 51-55 years old, Caucasian, 5', blue eyes

**Description of Vehicle:** Car

**Date:** April 27, 2019

**Description of Event:** The date was arranged on *LeoList*. The client's services ended early, and the client became frustrated and demanded a refund. The worker restated her expectations and boundaries of what was agreed upon in advance. The client became aggressive, the worker followed her safety plan calling a friend who assisted in getting the client to leave.

**Description of Date:** 18-25 years of age, Caucasian, average build, shaggy blonde hair, brown eyes

**Description of Vehicle:** Taxi

---

**Date:** April 5, 2019

**Description of Event:** The two clients picked up two workers from the Forest Lawn stroll and took them to the lookout over Deerfoot Trail. The two clients sexually assaulted one worker, then attempted to assault the other while she fought back. The men physically and sexually assaulted both workers and threw them out of the vehicle and left the scene.

**Description of Date:** 2 males, African/Caribbean/Black, between the ages 25-35

**Description of Vehicle:** Large black truck with canopy and green writing on the side
