# COUNCIL MEETING

JULY 7, 2016

Meeting was called to order by Mayor Patrick Edwards at 7:00 p.m. Roll call: Tom Clark, Cindy Humke, Kent DeGoey, Steve Thomassen, and Cathi Fouts present. DeGoey moved and was seconded by Clark to amend the agenda to include the emergency repair of Thomas Jefferson Road. Motion carried 5-0.

# Guests: None

### New Business:

- a. Thomassen presented a revised bid from Jasper Construction Services, Inc. for Pioneer Drive for \$54,500. The work would include the minimum needed to keep the road from deteriorating further. The Council tabled any further discussion until Edwards has a chance to call the County Engineer to assess the roads and develop a priority list.
- b. Fouts moved and was seconded by Clark to approve Resolution 2016-03 authorizing the transfer of funds into the General Fund. Motion carried 5-0.
- c. DeGoey moved and was seconded by Thomassen to approve Resolution 2016-04 to approve and adopt the Jasper County Multi-Jurisdictional Hazard Mitigation Plan. Motion carried 5-0.
- d. Clark moved and was seconded by Thomassen to accept the bid from Jasper Construction Services, Inc. for Thomas Jefferson Road repairs in the amount of \$16,370. Motion carried 5-0. The work includes a new storm sewer pipe, new intake, and concrete.

Humke moved and was seconded by DeGoey to approve all of the items on the consent agenda including the minutes from the June 2, 2016 meeting, bills, and reconciliation report for June. Motion carried 5-0.

### Staff and commissions reports

Sewers: DeGoey reported that he had received an e-mail from Steve Klocke with Snyder & Associates regarding a sewer line that is not able to be lined by SAK Construction. The line is only a 6" line. The line is functioning with no issues now. Klocke identified two options: 1) fix the section of the pipe that is not allowing for the liner to go through or 2) leave it and replace the pipe when issues arise in the future. DeGoey will follow up with Klocke to see how many feet of pipe is affected.

Tree Steward: Fouts mailed a letter to a resident on Pioneer regarding a dead tree on the property.
