RELEASE AND INDEMNIFICATION. Your signature to this Agreement indicates that you hereby (1) agree that you accept all risks associated with any food items hosted by or associated with Western Ave Rocktoberfest, including, without limitation, theft, electronic theft, destruction or injury to your food truck to vandalism, negligence, natural causes or acts of God, or any bodily injury or property damage caused to a third party by your food truck, (2) irrevocably and unconditionally release, remise, acquit and discharge Western Ave Rocktoberfest, its successors and assigns and their present and former affiliates, officers, directors, shareholders, employees, agents and representatives (collectively, the "Released Parties") of and from all losses claims, liabilities, actions, demands, lawsuits, judgments, damages and expenses (including attorneys fees) of any kind and nature, whether known or unknown, suspected or unsuspected, disclosed or undisclosed, (collectively, "Claims"), that you or your successors or assigns may have been or entitled to claim at any time, now or in the future, or may previously have had or been entitled to claim against any of the Released Parties arising out of or relating to your food truck, or the consumption of your food or drinks, at any time, including, without limitation, any display of the food or seating area, pursuant to this Agreement, and (3) agree to indemnify and hold harmless each of the Released Parties from all Claims of any third party (including, without limitation, any patron, customer or host) that are asserted or that, directly or indirectly, arise out of, relate to, or are connected with (A) any breach of this Agreement by you (B) your food and drinks or (C) food truck or seating area at any time, including without limitation, any display of your food, drinks or food truck pursuant to this agreement.

## Rules

The Historical Avondale Merchants Association is the managing authority for the Western Ave Rocktoberfest for the purpose of holding a salute to our Veterans and First Responders with a Block Party Event on Western Avenue.

1. Required to bring 2 trash containers for public use, this does not include yours for personal use.
2. No microwave ovens allowed.
3. No tent stakes allowed into asphalt, use weights to hold tent/awnings down.
4. Bring your own generator(s). Electricity may be requested at time of registration for a \$100 Fee.
5. Set up begins at 8AM, **no exceptions**
6. Western Ave Rocktoberfest Food Vendor Permits will be issued at the Raffle Booth.
7. Food Vendor Permits must be displayed on the front of your Food Truck.
8. **No parking on Western Ave. with the exception of your food truck!** Additional vehicles must be moved. ***Vehicles not moved will be ticketed!*** No cars will be allowed on Western Avenue after 9am
9. Food Vendor Spaces
  1. Limit one food truck per space.
  2. Eating Area must be kept clean and in good shape.
  3. Food Vendors are responsible for cleaning their space.
  4. Each Food Vendor must bring his or her own displays, and tables.
10. Purchases and Sales Tax
  1. Food Vendors are responsible for accepting payments on their sales. As required by law, each artist is responsible for collecting and turning in state, county, and city taxes.
11. **No refunds under any circumstances, the event will go on rain or shine!**
