

Circle G Arena Rules

1. Any attendee not officially representing NCYRA is considered a spectator and as such is restricted to the SPECIFIC “SPECTATOR AREA” outside the arena and backpens. No Spectators are allowed to enter buildings, barns, pastures, homes, sheds on the property. **SEE MAP**
2. No Spectators are allowed in Contestant Areas or Parking.
3. Children must be supervised by a responsible adult at all times.
4. No alcohol consumption of any type is allowed at the arena.
5. No dogs are allowed. Except for licensed, vested, and certified service dogs. No emotional support animals. Violators will be **fined \$100/ animal** and asked to leave the arena. They must be supervised at all times.
****Circle G Arena reserves the right to reject any service dogs per ADA.gov Article: “If a service animal is out of control and the handler does not take effective action to control it, staff may request that the animal be removed from the premises.”**
6. Individuals will maintain respectful, appropriate conduct while at the property. Circle G Arena reserves the right to deny entry or eject individuals displaying inappropriate behavior as determined by Circle G Arena. This includes, but not limited to: rules violations, offensive behavior, dangerous or damaging actions, annoyance of others, and failure to respond to warning.
7. No fireworks of any kind or other devices which create fire or smoke, or materials which could present a hazard are allowed on the premises. No use of confetti, glitter, tape, nails, etc are permitted at the property. No open campfires allowed on property.
8. No tents may be set up within 20 feet of the arena.
9. No skateboards, bikes, scooters, rollerblades, etc, are allowed. Clear and safe aisle ways must be maintained at all times for safe pedestrian traffic and access for emergency responders.
10. No ATVs are allowed on the PROPERTY.
11. Individuals will maintain a clean, safe environment during the rodeos. Ensuring that trash in and around the arena and parking area is placed in provided garbage

receptacles. Failure to return property to “clean” condition will result in assessment of cleaning fees.

12. NO TRAILERS/CAMPERS will be allowed to park around the arena. **SEE MAP.**

13. Contestant Parking:

1. All Contestants must use the driveway assigned for Contestant Parking.
2. Trucks with Trailers must park in the assigned areas on the MAP.
3. Roughstock Contestants/ CARS must park in the assigned areas on the MAP.
4. Parking is first come first serve.
5. Please be ready to pay for any additional guests and receive armbands when coming to the gate.
6. No Contestants are allowed to park in the Spectator Parking Area. **SEE MAP**
7. Handicapped Parking is available in the Spectator Parking Area. **SEE MAP**

14. OVERNIGHT PARKING: overnight parking is permitted.

1. All trailers staying overnight must park at the top of pasture for Contestant Parking to allow those not staying to exit and enter easily each day.
1. Dry camping only. No Hook-ups.
2. You may build pens beside your trailer.
3. Horses tied to trailers are the owners responsibility to supervise.

15. All animals brought on the PROPERTY for the purpose of the event must be disease free, well supervised, and cared for at all times.

16. Proof of NEGATIVE COGGINS required for all horses.

17. **AT NO TIME MAY HORSES BE TIED TO THE ARENA PANELS, WOOD FENCING ANYWHERE ON THE PROPERTY, OR THE ALLEY WAY.**

18. **NO HORSES are allowed in the SPECTATOR AREA. A \$100 FINE per horse per offense.**

19. All horses should be supervised at all times when tied. You will be responsible for any damages or destruction made by your horses.
