AMANA NEWS AND NOTES

Public Hearing for New Wind Ordinance Set

The Iowa County Board of Supervisors will hold a public hearing regarding the proposed wind turbine ordinance for Iowa County, known as Iowa County Ordinance No. 32

There is one hearing scheduled and it will be Tuesday, Nov. 19 at 10 a.m. at the Iowa County Supervisors boardroom in the courthouse annex in Marengo.

It's not clear from the documents posted on the Iowa County Supervisor's website who wrote this proposed ordinance. In August a citizen's committee was formed to look at a new ordinance but whether or not this is their work is not known. The Amana News and Notes reporter sent emails asking that question to three Iowa County Supervisors but did not hear back before deadline.

The new draft ordinance does not mention the Amana Colonies, nor does it take into account the recommendation of the National Park Service regarding the Amana Colonies and its status as a National Historic Landmark. Compared to an August draft that was rejected by the Iowa County Board of Supervisors, this ordinance reduces the setback for non participating households and does not include a set back for FAA licensed airports.

Compared to the ordinance proposed in August, this draft reduces the set back from "non participating residents (those that are not being paid) from 2,000 feet to 1,800 feet. That reduction, along with other points, has frustrated some Iowa County residents who are asking for a larger setback for non participating residents. The group, which got over 1,000 signatures on a petition asking to limit placement of the turbines in Iowa County, is asking the public to come to the November 19 meeting and, or to contact the Board of Supervisors now regarding the new ordinance.

The new ordinance caps the number of wind turbines at 200 in the county. The August proposal did not include a cap.

Right now 77 are being constructed in the county. These will be 494 feet and 591 feet tall. A map of the wind turbine locations may be viewed on the Supervisor's "Wind Energy Information" page. Those now under construction by Invenergy and MidAmerica are on both side of Interstate 80 from 172 St. on the north to 275th on the south; and from N Ave. on the east to the Iowa- Poweshiek Road on the west.

According to the proposed ordinance, the setback for the Iowa River of 15,840 feet (three miles) has been retained, however the setback for the English River is just 2,640 feet (1/2 mile).

Also the first draft included a set back for airports of 15,840 (three miles). There is nothing in the new draft regarding airport setbacks. Airports and airport safety was not mentioned.

With regard to the Amana Colonies, a National Historic Landmark, there is not a word. As a resident of South Amana noted, "this is disappointing given the very direct and specific input that the National Park Service has made. You would think that would be taken into consideration in this ordinance – the protection of a National Historic Landmark."

In a letter dated August 28, 2019, from Robert U. Bryson, associate regional director resource stewardship, the National Park Service informed the Iowa County Board of Supervisors that the National Park Service supports the Amana Society's request that all wind energy accessory buildings and structures have a setback no less than two miles from the boundary of the Amana Colonies Land Use

District and the Amana Colonies National Historic Landmark.

The letter stated, "Our (the NPS) recommendation, however is that wind turbines would be located well beyond the viewshed and soundscape of the NHL district. These modern intrusions have the potential to adversely affect the setting, evocative feeling, historic character and continuing traditional use of the Amana Colonies."

Furthermore the letter cited, Section 106 of the National Historic Preservation Act, "specifically Section 110(f) of this Act codified in 36 CFR Section 800.10, the NPS shall be contacted if any activity or undertaking uses federal funds or requires a federal permit or license. The erection of the wind turbines may include one or both of these conditions. Thank you for your reconsideration of Ordinance 32 and recommendations to located wind turbines well beyond the boundaries and view of this Iowa treasure."

The letter was addressed to the Iowa County Board of Supervisors with copies sent to Sara Houlihan, DMUS, MidAmerica Energy Company, Sarah Eberly, Invenergy, LLC, Chicago, along with Steven King, Deputy State Historic Preservation Officer, Iowa Dept. of Cultural Affairs and Pete Swisher, Superintendent of the Herbert Hoover NHS, West Branch.

Minutes of the regular meeting – October 28, 2019, 6:30 pm
ACLUD Meeting Room, 4304 220th Trail, Amana
- I. Call Meeting to Order. The regular meeting of the Amana Colonies Land Use District Historic Preservation Commission was called to order at 6:32 p.m. by Historic Preservation Commission Chair Betsy Momany. Present: Momany, Jeff Conquest, Peter Hoehnle and Administrator Ely Hoehnle.
 - II. Set/Amend Agenda. Momany asked that the agenda be amended to include a discussion of the November meeting, and a closed session to discuss a personnel matter at the end of the meeting. Motion by Conquest, second by P. Hoehnle to approve the agenda as amended. Motion passed 3-0.
 - III. Review/Approve minutes of September meeting. Motion by P. Hoehnle, second by Conquest to approve the minutes as presented. Motion passed 3-0.
 - IV. Welcome visitors and allow citizens to speak on items not on the agenda. Chris and Donna Dickel asked about patching holes in the soffit and siding to seal up the Willard Dickel house in Middle before winter. Susan Matrice asked about the number of secondary structures allowed on a property.
 - V. Discussion/Action on the following permit application in a Historic Preservation Zoning District:
 - a. 2019-060 Aktivum Holdings; 2508 220th Trail, Middle. Replace front and back doors, cellar doors, and outbuilding doors and front steps.
 - i. Front and back door: Motion by P. Hoehnle, second by Conquest, to recommend approval for 4-panel steel doors on both the front and back entrances, recommend that they be painted white, gray, tan, or brown, second by Conquest. Motion carried 3-0.
 - ii. Basement door. Motion by P. Hoehnle, second by Conquest, to recommend approval of custom-built doors on the basement entrances, same dimensions as current doors, faced with a tongue & groove siding, duplicate strap hinges and hardware as on current basement doors. Motion carried 3-0. Commissioners state for the record that as the basement doors are not in the visual corridor, they are not making a recommendation on the type of wood.
 - iii. Barn doors: Motion by P. Hoehnle, second by Conquest, to recommend approval of custom-built replacement barn doors to duplicate the appearance of the current doors, faced with a tongue & groove siding, duplicate hardware as current doors, recommend cedar or oak for the barn doors. Motion carried 3-0.
 - iv. Front steps: Motion by Conquest, second by P. Hoehnle to recommend approval of front steps in the style shown on submitted photo of former Birk house in Middle, 2 steps, railing may be on both sides of steps or only one side, treated wood stringers, composite or cedar on steps and railing, may be white, grey, tan or brown. Motion carried 3-0.
 - b. 2019-062 Lynn Trumpold; 2703 220th Trail, Middle. M Motion by P. Hoehnle, second by Conquest to recommend approval of five replacement windows, Marvin wood-clad, 9/6 configuration, to match replacement windows previously approved. Motion carried 3-0.
 - VI. Administrator's Report. No report.
 - VII. Other business.
 - a. Momany noted that the next scheduled meeting is the Monday of Thanksgiving week. Motion by P. Hoehnle, second by Conquest, to move November meeting from Nov. 25 to November 18. Motion carried 3-0
 - VIII. Chairman's Report. No report. The Administrator should remove the HPC application from the website.
 - IX. Motion by P. Hoehnle, second by Conquest to go into closed session, pursuant to Iowa Code Chapter 21.5(i). Motion carried 3-0.
 - X. Adjourn. Motion to adjourn by P. Hoehnle, second by Conquest. The meeting was adjourned at 7:20 p.m.
