1. My Dog(s) is/are properly fitted with a collar or harness and leash, as required. While participating in event(s), leads are to be no longer than 4 feet and attached to a collar or harness. Collar must be secure.
2. I will pick up my dog's poop as a courtesy to others and dispose of it in the trashcans provided on the property.
3. I agree to remove my dog(s) from the property if my dog(s) act aggressively towards other people and/or dogs, pose a safety risk to other people and/or dogs, and/or appear to be unhealthy, giving rise to health concerns.
- 4 Patter Pets, Inc. and their volunteers, agents, and sponsors, in addition to the participating event grounds reserve the right to ask any person and their animal to leave the dog show at any time for any reason.
5. All children on premises must have adult supervision at all times.
6. No animals in heat allowed.
7. No animals will be allowed in the car show area.
8. All dogs must be current on vaccinations.

Participant Agreement and Waiver of Liability:

I, the undersigned, hereby assume all risk of illness or injury as a Dog Show Participant in which I voluntarily participate.
