## PLEASE READ CAREFULLY. BY SIGNING THIS DOCUMENT, YOU CHOOSE TO WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

facilities. In swimming at Oakmo	ore's pool during this time, I recognize and fully understand
certain things, including:

- While swimming there is no official life guard but there is adult supervision, during summer camp days it will be trainer.
- My use or my child's use of the Oakmore's pool facilities involves certain risks, including:
  - o The risk of injury resulting from possible malfunction of the pool equipment;
  - The risk of injuries resulting from tripping or falling over obstacles in the pool area:
  - o The risk of injuries resulting from swimmers colliding or possible horse play;
  - o The risk of other injuries resulting from participating with swimming.
- I recognize and fully understand that the above list is not a complete or exhaustive list of all possible risks; the list only provides examples of types of risks that Oakmore is am assuming.

In exchange for the Oakmore allowing me or my child to participate in swimming, I hereby agree to the conditions below. I and/or my child fully intend and choose to give up the legal rights, as stated below:

- 1. **TO WAIVE ANY AND ALL CLAIMS** that I have or may have in the future against Oakmore, its trainers, staff, employees, agents, or representatives (hereinafter referred to as the "**Releasees**") relating to my and/or my childs participation in swimming;
- 2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury, expense, or other cost that I and/or my child may suffer or that my next of kin may suffer in connection with my and/or my child's participation in swimming due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;
- 3. **TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES** from any and all liability to property, or personal injury to, any third party, resulting from my participation in swimming.



4. That this Waiver, Release, and Agreement is fully effective and shall be effective and binding upon me, and my heirs, next of kin, executors, administrators, and assigns, or anyone else authorized to act on my behalf or on behalf of my estate.

I have read and understood this document. I am aware that by signing this document, I am waiving certain legal rights that I may have against the Releasees, and I fully agree to do so.
