

And / Or: Page 9, Section 4C 1-2

Answer before Question portion: Page 9, Section IV. B-5 Complete entire question portion BEFORE giving the answer. **Incorrect**

Bible Fact Pak: Page 6, Section 3-A All questions & answers must come from Bible Fact Pak

Early Interruption: Page 7, Section 3-I

- Activate equipment after calling “Question” **and** the reading of the 1st word
- Read same question both teams. **FOUL**

Essence Rule: Page 8, Section 4, A-1 Answer contains basic info from Fact-Pak

Fouls (page 11) Section 7

- Quizzer activates equipment during introductory remarks **FOUL**
- Quizzer responds before being recognized (may finish answer) **FOUL**
- Incorrect quizzer responds **see wrong quizzer section below** **FOUL**
- Coach calls 4th time-out **FOUL**
- Coach calls 3rd judges ruling **FOUL**

Help or Hindrance: Page 11-12, Section 7.8 and Section 8.2

Help or hindrance from opposing coach or team, the question is voided, and a new question is read only for the offended team. **FOUL**

Illegal Quizzer: Page 12, Section 8, B.4 Illegal quizzer remains. Responds to a question. All questions voided and substituted.

Incorrect Information Before Correct: Page 8, Section 4B-2 **Incorrect**

Interruption (Early): Page 7, Section 3-I Activate equipment after calling “Question” **and** the reading of the 1st word. Read same question both teams. **FOUL**

Judges Ruling: Page 15, Section 13 A-B x2 per match, get 30 seconds.

- Judges flip coin.
- Not unanimous, judges confer.
- Judges vote again. Does not need to be unanimous.

Judges reverse “correct” decision on an interrupted question. A new question is read only for the *other* team only.

Mispronunciation: Page 8, Section 4-4 Clearly recognizable on both quotation or non-quotation. **Correct**

Negative Quiz-Out or Foul-Out: Page 11, Section 6-I

Three negatives, or three fouls

Question before Answer: Page 9, Section IV. B-5 Complete entire question portion **BEFORE** giving the answer. **Incorrect**

Quizzer Responds (before being recognized): Page 11, Section 7 A-3

Allow to finish answering. **FOUL**

Quotation Question: Page 8, Section 4a-b Reference given before or after question and may be repeated.

Quotation Question: Page 8, Section B3 When a word is omitted, repeated, added or changed
Incorrect

Re-Read (wrong team responds): Page 7, Section 3-G During reread, if quizzer from 1st team buzzes again, reset the equipment, restate which team should answer, and reread question.
No Foul

Tie Game: Page 13, Section A OT match-one 10, 20, 30 point question, 1x time-out
Sudden Death: Page 14, Section 10-B Tie after 1st overtime period, 20-point questions to break tie.

Tie Quizzers (same team): Page 7, Section 3-K Head coach decides which player responds

Wrong Quizzer Responds: Page 13, Section 8, B.8.a-b

- **Opposing team**, quizzer is stopped, question voided, new question for offended team. *FOUL*
- **Same team** as the quizzer, quizzer is stopped, question voided, and a substitute question is read for the opposing team. If done during a reread, the question is voided, no further reread.
