A motion was made by BO and seconded by TD to ratify the expenditure of \$400 to install a remote spigot on the south side of the front entrance by Oasis Irrigation for the purpose of watering the new plantings on the south ledge. The vote was unanimous

### PRESIDENTS REPORT – VP

- -- The front entrance is now finished after a long and drawn out process
- --We have finally received the financials from PSI and VP is sorting through
- --We are actively working on the spillway. SR is heading this committee
- --We will begin to discuss our future with regard to management companies

Website Committee – TD

We have had 3500 hits since the December 2007meeting Homeowners have been using the website to communicate with the BOD

#### Front Entrance Committee – BO

Work was completed about a month ago

We went slightly over budget due to the permit/attorney fees

There is a call in to Oasis to repair the sinkhole made during installation Sprinklers do not reach all plantings so we have installed a spigot on the north ledge and will be installing a spigot on the south ledge to reach these plants

BO will be reducing the frequency of the watering to every other day American Tree and Turf has replaced some of the planting on the Denny/Bliss berm that did not make it through the winter

#### Design/Modification Review Committee – DT

Since the December meeting we have approved 1 wood deck, 1 playset, 2 exterior paint color change and 1 screen porch

## Spillway Committee – SR

The Leonard Dreas estimate was too high and we are looking to others We want to repair the stone walls from the dam to the bridge the area below the dam in the first pool

We would like to install bubblers in the pools to help with the algae We are asking Environmental Aquatics to treat the spillway water along with the lake

We will be using the "design/build" format to obtain proposals for the work and are waiting for one from Blue Hills

We would like to complete the project in August/September when it is dry

It hasn't been determined if we will need a permit from the village. SR is talking to Dave Burroughs at the village on this

#### TREASURER'S REPORT—BO

- -- We have \$102,400 in a CD at Castle Bank
- -- There is \$80,309 in our Chase Bank savings account
- --We have \$67,121 in our Chase checking account
- --There is still \$9,800 at mb Financial Bank until all checks clear and we can transfer it
- --We currently show \$23,982.00 in homeowner delinquencies
