

RESOLUTION 2017-04-02

RESOLUTION OF THE BOARD OF DIRECTORS OF SALTON COMMUNITY SERVICES DISTRICT UPDATING SEWER CONNECTION POLICY

WHEREAS, the Board of Directors of this District establishes policies and guidelines for the District's Architectural Committee; and

WHEREAS, the Board of Directors of this District seats members of the Architectural Committee to uphold said policies and guidelines; and

WHEREAS, the Board of Directors of this District find it necessary to update the Sewer Connection policy as a whole.

NOW THEREFORE, BE IT RESOLVED

Section 1. Sewer Connections to a Six (6) inch main line will be \$2500.00 for any residential building with a depth not to exceed Eight (8) feet in depth.

Section 2. Sewer Connections to a Ten (10) inch main line will be \$2700.00 up to Eight (8) feet in depth.

Section 3. Sewer Connections to a Twelve (12) or Fifteen (15) inch main line up to Eight (8) feet in depth will be \$3000.00, with deeper depths billed accordingly for the additional time required to complete the project.

Section 4. Sewer Connections requiring a street crossing encroachment permit will incur additional costs for the permit fee plus the cost of material to repair the asphalt to Imperial County Public Works Standards. These additional fees will be billed to the sewer permit accordingly

Section 5. Sewer Maintenance Capital Improvement fee of \$200.00 will be charged to each sewer permit.

Section 6. Sewer Construction Capacity fee of \$1000.00 will be charged to each sewer permit.


Section 7. Sewer Connection Permits will be issued once the property owner has received the final inspection of the lateral from the County of Imperial. Sewer Connection Permits are valid for **24 months**. Should the Sewer Connection Permit remain idle beyond the 24 month life of the said permit, the property owner shall forfeit

any fees paid for the Sewer Connection Permit and the said permit shall become null and void.

Section 8. Sewer Connection Permits are non-transferrable and non-refundable. It is the responsibility of the property owner to verify the application has the correct address, lot, block, and tract number, APN number, and any and all other pertinent information.



RESOLUTION NO. 2017-04-03

**A RESOLUTION OF THE BOARD OF DIRECTORS OF
THE SALTON COMMUNITY SERVICES DISTRICT ADJUSTING THE
DEPARTMENTAL ADMINISTRATIVE FEES IN CONJUNCTION WITH THE
AMENDED 2016-2017 BUDGET**

WHEREAS, the District has amended the 2016-2017 budget placing the majority of administrative costs upon the Sewer Maintenance fund; and

WHEREAS, the Sewer Maintenance fund and Sewer Construction fund pays the General fund 28% for administrative fees per Resolution No. 2016-7-5; and

WHEREAS, the Channel Maintenance fund pays the General fund 15% for administrative fees; and

WHEREAS, the Sewer Maintenance fund now, per the amended budget, provides administrative services and other services and incurs costs on behalf of and for the benefit of the General fund, Sewer Construction fund and Channel Maintenance fund; and

WHEREAS, the Board of Directors of this District wishes to adjust the departmental administrative fees to reflect the new role of the Sewer Maintenance fund in carrying the majority of the costs for administrative and other services for the General fund, Sewer Construction fund and Channel Maintenance fund;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE SALTON COMMUNITY SERVICES DISTRICT AS FOLLOWS:

Section 1. The Board of Directors hereby finds and determines that the Recitals are true and correct and are incorporated herein, and that this resolution shall rescind any and all other resolutions regarding administrative fees.


Section 2. The Board of Directors of the District hereby adopts a fee due from the General fund of 5% of the revenue received plus 5% of the wages of the General Manager and Board Secretary to reimburse the Sewer Maintenance fund for the cost of providing such administrative and other services.

Section 3. The Board of Directors of the District hereby adopts a fee due from the Sewer Construction fund of 15% of the revenue to reimburse the Sewer Maintenance fund for the cost of providing such administrative and other services.

Section 4. The Board of Directors of the District hereby adopts a fee due from the Channel Maintenance fund of 15% of the revenue received to reimburse the Sewer Maintenance fund for the cost of providing such administrative and other services.


