OREGON AREA VOTING PROCEDURES

A motion is made:

- If it does not receive a second, it dies. After a second, debate is opened. If a registered voter calls for the question, a second will be required, or debate resumes.
- A question must be called in turn at the mic.
- If the question is seconded a 2/3 majority will end the debate, or debate resumes.
- If the question is not called, debate will go on until there is no one at the mic. Once debate ends, a sense of the group will be taken by a simple majority, to vote or table.

A motion is voted on:

- If it involves expenditure of area funds, the finance committee will be asked to report. It requires a 2/3 majority to pass.
- The losing side will be asked if they wish to speak to their position. The winning side will be asked if there is a motion to re-vote, and requires a second. A simple majority is required to re-vote.

A motion is reconsidered:

- Full debate, pro and con is resumed (please limit discussion to only new considerations).
- The question may again be called, seconded, and requires a 2/3 majority to end debate.
- A sense of the group may be taken by simple majority, to vote or table.
- If voted on, the motion must have a 2/3 majority to pass.

Debate has ended.

• Debate on a tabled motion will be resumed under old business at the next assembly, and the voting process will be the same as above.

Item # 1 - Create YPAA Chairs

Motion:

 Have the Oregon Area create a Young People in Alcoholics Anonymous (YPAA) Committee and appoint a North and South Chair as additional positions to the Area Committee.

Intent/Purpose:

• To create and foster better linkages and unity with Young People in Alcoholics Anonymous committees in the Oregon Area Service Structure.

Current Practice:

• Currently the Oregon Area does not have a Young People in Alcoholics Anonymous Committee or Young People in Alcoholics Anonymous Chair positions.

Budgetary Impact:

• Use the standard Oregon Area Committee budget as follows:

Motion read by Kenji H., Alt. DCM for District 6

Kathleen, GSR for Sober Awakenings, District 19: My group feels strongly that we need to pass this motion. They feel that it would enable the burgeoning group and culture of young people to be represented and we strongly feel that the representation of people should be by those people. In addition the present system puts too much of a burden on the GSRs from young people's groups because they're not only representing their groups, but young people in general, and we need more than that to have the kind of communication we want between the young people's communities and AA as a whole.

Tanner: I wanted to read a letter that Bill wrote, June 15th, 1969. "To my younger friends in AA, on this occasion of your 12th international conference, please have my warmest greetings and congratulations. Besides. I want every one of you to know that in recent years I have found nothing for greater inspiration than the knowledge that AA of tomorrow will be safe, and certainly magnificent, in the keeping of you who are the younger generation of AA today. With great affection for you all, and may God bless you and AA forever. Always devotedly, Bill Wilson." I'm also in District 6 and you know there's a great support from our district and from me personally. Our young people committee is extremely strong. We have a lot of energy, we have a lot of people. When you see it all come together, the amount of things that are accomplished is pretty magnificent. Unfortunately, I show up to Area assemblies, I show up to General Service in our district, but we don't have that young people presence at the General Service level. I'm super fortunate to have gotten involved with the right people. I look around and it's pretty substantial, the difference between the people who do General Service. Those are the guys I look up to, the guys who have 15, 20, 20+ years. My friends, the people who I associate with on a daily basis, don't understand what's happening in these rooms, they don't understand what happens behind the doors of AA. Unfortunately, the way that my friends drink and the way that my friends get sober, unfortunately, it's only a week later before they die. I show up here because I don't want to die, I want to live. Unfortunately that message has yet to be connected for young people down there, it seems like, to General Service. I'm greatly in favor of this and hope we pass it through.

Maggie, GSR for Girls Night Out, District 24: At the last assembly there was a proposed amendment to make this position a liaison position rather than a chair position and that amendment was never addressed by the motion maker. My group felt strongly that they'd prefer this to be a liaison position and so we wanted that amendment to be responded to. Kenji: As District 6, we feel that a committee chair position would better do what we're trying to accomplish, but if a liaison position is necessary we'll start there and go from there. Jim: Is that a yes or a no?

Kenji: No

Kyla, GSR Lost and Found, District 10: My home group discussed this and we enthusiastically and unanimously support this motion.

Robert P.: Nobody I've talked to disagrees that we should support young people in AA, that we should support young people's meetings in AA, and that we should support young people's conferences in AA. But we've had a number of inputs to say that this is kind of a personalities and principles matter. Reilly

addressed this at our September assembly. Who are we when we meet here? We are the Oregon Area General Service Assembly, with the emphasis on General Service. We are part of the AA General Service structure. Why are we here? If we look at the AA Service Manual with the upside down triangle with the groups on the bottom and the GSRs and the DCMs, and the Area, and our Delegate, and the General Service Conference, at those levels, there's no participation for young people's groups. If we look at the Conference, I as a corrections proxy am involved with corrections and there is a conference committee at the General Service Conference that discusses corrections related matters and they bring advisory actions to the voting body. There is no conference on young people's matters. Therefore our delegate cannot be any votes at the General Service Conference on young people's matters. Therefore our delegate cannot bring back information from the General Service Conference in giving the delegate's report. As stated in September, YPAA is a part of Alcoholics Anonymous but if you look at a similar kind of situation, intergroups and central offices are also part of AA, they are not a part of the General Service structure.

Amie, GSR for Nooner meeting, District 22: This is an issue near and dear to my heart. I've actually had talks with Robert where I've heard the arguments that he just made. I'm 47 years old, I look around this room and I see a lot of people who are my age or older. In 1987, the year I graduated from high school, I travelled as a part of the San Francisco bid committee to the International Young People of AA in Boston to bid on the conference. My affiliation with the group of young people in the Bay Area of California kept me sober. I moved to Oregon when I was 19 to go to college. I stopped going to meetings because there were no young people's groups, there were no young people in my meetings, there were no young people dances, there was no young people bid committee and I didn't fit in, in a room full of older people. even in a college town, in Eugene Oregon. Now I'm not blaming that for the reason I went back out and drank for the next 25 years, but what I am saying is that anything we can do to bring more people with young faces into this room and into General Service and into decision-making of AA, serves what I think is our most important Tradition, the 3rd Tradition. We are here to help other alcoholics achieve sobriety. AA alienates a lot of young people. Frankly, you read the book, and it's pretty out of date. But there's a new generation of alcoholics coming on board and they're either going to come into these rooms or not. Their reflection in the organization of AA is what's going to do it. Now I get that there's no upper level GSO vound people's group at the national level in New York City, but I also know that in Oregon we're pioneers and what I'd like to see is Oregon be the ones that start it, pushing it from the bottom up, because it's an upside down triangle. We shouldn't wait for New York to tell us what to do, we should show them how to do it. and that's why I'm voting yes and my group is too.

Jenny, GSR Women Living the Miracle, District 1: Our group was not in favor of a chair. They are, like Robert brought up, in favor of a liaison. Their main reason seems to be a terminal feeling of uniqueness. Are we going to start chairs for retirees, etc...? So that was their rational for not voting for financing a chair specifically for young people.

Teresa, Area Newsletter Chair: I got sober at 25, I've served on four different host committees for young people's conferences, I currently serve on WACYPA Advisory Council, I'm very pro YPAA, but I'm not in favor of this motion because I don't know what the purpose of the chair position would be. We have a number of different service committees here at Oregon Area that do a lot of really valuable work, and what I'm wondering is what this committee chair would be doing that isn't already being done. And if they're doing what is already being done, we are doubling efforts and that's not healthy for AA. My question to the motion makers is what would you be doing that isn't already being done. And if it's to liaison with young people's groups and be a clearing house for information coming and going, I see that as a liaison position. That's already been discarded so I would not be in favor of this motion.

Brendan, GSR for The Book Review Group, District 26: I took this motion to my home group and our business meeting. I took the motion word for word. There were two sentiments. One was, what exactly is this position and what is its function? What does it do exactly? I read the intent, and we dissected it the best we could, but still there was no clear consensus on what exactly their function would be. The

other thing brought up was the first Tradition, Our common welfare should come first, personal growth depends on AA unity. Some of our members felt that the creation of a subgroup or a special interest would have a divisive effect at the Area level.

Jim: Before we move on to the next person, Teresa asked a question, would Kenji like to address the question?

Kenji: Yes, we're talking about the purpose of the position. Here's an example that I have. Say we have a young people's committee for OSYPAA, and they're putting on a statewide conference of young people in AA. They don't have representation at this meeting. What they are trying to accomplish is get more information about safety in AA, which is a huge issue, especially for young people's meetings. They want to get people who are versed and educated from GSO, and try to get them and have a workshop. How would they do that if they don't send people here and they don't know who to talk to. If the area decided to have a committee YPAA chair, that YPAA chair would be in touch with all of the YPAAs in Oregon and that YPAA person would just contact that chair, and that chair would say we have these people, Gus, Vera, Teresa, and they're willing to come down and talk and put on this workshop.

Mike, District 5: I'm going to sound wishy washy on this, I don't think anybody is against ICYPAA, I've been to it, I got sober when I was 18, it's fantastic...I'm not quite understanding, this Is a business committee meeting, ICYPAA is a convention. If we start putting a convention committee on the table, where's it going to stop. I think this is a cork to a genie in a bottle. Once you open it, somebody will say I want my convention committee on this board, and I want this specialty group on this board. Where do we stop? But I support ICYPAA completely, young people's completely, I think there are numerous positions that are starting to be filled by young people, which is fantastic. But again, I think this is kind of a specialty thing. Either way it goes, I love ICYPAA, I would support them no matter what. I just don't feel that it belongs on a business committee.

Reilly, Area Delegate: I was part of the original southern California intergroup that created the first three dozen young people's groups in California, and I've been working with young people's groups since I was 21 years old and sober, so I obviously support young people's groups and everything that they do. But there is no General Service position for special interest groups at the Area level or in the General Service structure. There's no group representation. Those few dozen groups that we created in the 60's elected their GSR's, who then represented those groups and continued to do that in the General Service structure. This motion also opens the door for other special interest groups to ask for a chair position and be double represented, because other special interest groups also have GSRs who are probably represented here in this room today. This is more of a liaison, or a local intergroup or committee matter. The description that Kenji was kind enough to read described an informational dissemination, connection, liaison position that's very easy to create and place in the list of intergroups that work with our area.

Ciara, GSR for Sunday Serenity Sisters, District 9: I'm going to vote for the motion because that's what my group wants and I believe my job as GSR is to represent my group, but I'm personally against it because - I want this to be considered, I feel really strongly about it - I look at all these committees and I see accessibility concerns being addressed. There's nothing to stop young people from coming to meetings, from getting information here at the district assembly. Anyone is allowed to attend the assembly, it's not closed to other members of AA. I would love to see more female representation everywhere, I would love to see more people of color represented everywhere, but there is nothing stopping us from becoming GSR of our group and showing up and representing. There may not be an equal distribution of young people here but we tend to get sober a little later in life in general, so I'm not sure if that argument is logical. Of course I want there to be resources for young people to get and stay sober, but to break it out in demographics seems like a lot more administration than is necessary.

Pharis G., GSR for Woman's Group, District 18. Our group voted to have this for the young people. Out where we're at, there's literally sometimes nothing for the young people. They just don't get the information to them. The women in our group have decided for me to vote yes.

[Jim reminded everyone that only voting members can speak from the mic and asked the next person at the mic not to speak, since he was not a voting member]

Kathleen, GSR for Sicker than Most, District 2: Our vote is Yes, and the reason for that is that when we got to Depot Bay, there was no young people. We live on the coast and you don't. Bye [laughter].

Tim, Hospitals Co-Chair: Some things I'm thinking of right now, there's probably 30 plus districts here, that means there's 30 plus DCMs, so whether this passes or fails, this is also a responsibility that falls on the shoulders of DCMs. You need to be visiting groups and bringing GSR pamphlets, bringing home group pamphlets. I'm personally against the motion, not because ... I'm for young people in AA, but I can't help but feel that it's a little emotionally driven. I hear little flavors of we're not being included. I kind of feel sometimes autonomy has been taken to the point of isolation, and it's feeling like this is an island unto itself. It's like "bring us in, bring us in, bring us in", and it's like "come on in! It's all set up". DCMs, this is your job to visit. It's the hardest part of your job. It won't seem like it in the beginning, but you need to go out and visit groups and start educating. I do believe, a little bit, young people should take a personal inventory and find where their motive is, and say can I accept help from any age. I just wanted to get that out there, because I would feel I should have shared that.

Lisa K., GSR for Young People's Sexual Diversity Roundtable: My group, as you can imagine, was in favor of the motion. We had two discussion sessions at our home group and some of the opinions I got were, first, that it's in the budget and someone is wanting to do it. We went over the discussion that was had at the last assembly and looked at all the opinions. For me personally, I got sober at 19. I was really lucky to get sober in Portland, we have so many different young people organizations and meetings, and so one thing that I wondered about, for different districts that maybe are a little less diverse, a little smaller, a little further away from Portland, it seems like perhaps this chair position... I would suggest that if it happens, they could reach out to some of the districts that don't have as much representation. I've been hearing the term special interest thrown around when it comes to young people. In my opinion, I don't see that, I don't see being a young person a special interest. I would say living on the coast, if we had a coast chairperson... That was a joke [laughter]... would be a special interest. It sounds like there's a lot of interest in this motion. I would love to see reports given by this committee.

Chuck, GSR in District 8: Calls the question. Seconded by Leland District 37

Vote taken to end debate, 2/3 majority achieved. Debate Ends.

Vote taken on the motion, 2/3 majority not achieved. Motion FAILS.

Minority Opinion

Joel S.: Corrections, Treatment Facilities, Accessibility, at some point none of those were at Conference. The need was sensed in those communities for us to reach out, we didn't wait for them to come to us, we didn't wait for them to get GSRs and come to us. We reached out to those communities. We realized that reaching out to those communities may take a special effort and that that was important enough at this level to do that work. Eventually it rose, or sank, to the level of the Conference, because there was enough of a movement towards that. I feel that voting No on this is extremely short sighted as far as that is concerned because there is a lot of work that needs to be done to reach out to a community that is potentially AA's future.

Cindy, GSR for Drifters by the Sea: My birth date is June 3rd, 1991 and I got sober in Poway, California. My first meeting, believe it or not, was a young people's meeting, because it was the only meeting I knew where it was. I didn't know where the adults meetings were. I'll tell you, I was accepted by 8 year olds, 12 year olds, 15 year olds, and 30 year olds at a young people's meeting. At that time the young people's group did not belong to the Area in San Diego. During my time of being a GSR, about 8 years later I served, we did accept the young people's meeting in the area assembly in San Diego Imperial Counties in California. I was thinking this was a beautiful motion to have come forward, I'm sure people have questions that need to be answers and I wish they had come up during the debate. I really would encourage people to support this because the young people's group is a part of the area assembly in San Diego CA, Area 8. I would highly recommend that you change your vote to saying yes.

Kyla: I voted yes on this motion on behalf of my home group Lost and Found in District 10. What I would like to do is highly encourage Kenji to reissue this motion as a liaison position in new business today.

Lisa K.: You guys double clapped me but I'm back [laughter]. As far as all the activities that chair people do at the assemblies, I would love to see young people represented in that. Why not give it a try? What's the worst that can happen?

Kenji: I want to reread the intent/purpose of this motion: "To create and foster better linkages and unity with Young People in Alcoholics Anonymous committees in the Oregon Area service structure". A lot of people talked about how this motion would seem divisive, but I argue that this motion is to foster better unity. As you can see, there's not very many young people here and yes, all of their GSRs could come here, but it's important to think about this committee or this room in 20 years. It will be full of people who started at my age and will hopefully continue to stay sober. We talk a lot about carrying the message of AA to the alcoholic who still suffers. I talked to the Corrections chair last night and he was saying he firmly believes that bringing the message today is about taking it to corrections institutions and treatment centers. But one thing that we left out of that conversation is that a lot of times the alcoholic who still suffers is very young today. I think it's important to recognize that. I also want to address the point about being a pioneer. One thing that we have learned is that Idaho, Area 18, already has this position. They've had this position for 8 years. So it's not that we're the very first Area to do it but I think we could start pushing GSO in the right direction, in my opinion. Another thing that was brought up is ICYPAA is already at the General Service level, like our amazing delegate was saying. This is not about a conference. This is about reaching out to young people who are struggling alcoholism and bringing them into the service structure of AA so we can continue it for future generations.

Kathleen, GSR for Sober Awakenings, District 19: I'm concerned about the young people in towns that do not have a young people's group. There are far fewer young people's groups than there are AA groups. Having a committee at the Area level would mean there would be someone to reach out to them, someone to develop materials of interest for them, someone concerned with bringing them in when there is no young people's group and they would have no other way to, as young people, access the service structure. I think a 16 year old in Depot Bay is going to come into your typical small town group and look around and go away again. We need to reach out to these people, and we need to help them get sober, and it's critical, and it's part of our job.

Grace, District 19: Thank you for this learning experience, it's been really valuable to me. I can see both sides of this and it's hard to know where I fall personally, I just voted for my group. What I can say is now having service in both General Service and YPAA, maybe what we can do as YPAA is look at how we can be more inclusive instead of looking at how you can be more inclusive. If we have an event and you haven't been extended an invitation, you're invited. If you've heard a bunch of acronyms and you're like me and you didn't know what they meant or what the difference was between one or the other, come find out. Maybe we can look at ways that we can make that educational piece a little less confusing. I know that I found it confusing when I started participating there and sometimes I still get confused. That being said, if you've had the types of discussions that I've had with people in my group, if it's had you

asking questions, if there's things that you didn't know how to explain, like me, come find out. Maybe we should look at how we can help you learn.

Debbie, District 29 DCM: My district voted yes on this, reason being, we're way over there in eastern Oregon, we had PI and CPC come do a workshop for us and we learned a whole lot about how to better serve the community. For YPAA, we are excited and we were hoping this would go through because our district is going to work them into our budget for finances so they can go out and carry the message to young people. We have an adolescent center in our county that is from ages 14 to 17. They do not relate to us old people. There is no young people AA over there. We have two members in Wallowa county that are young thanks to the Facebook page that are getting involved, and they want to be part of this committee. We are going to follow suit with whatever Area does to finance them to take the message around to the different counties, to the schools to talk to the young people, those kinds of things. So we were really excited about the finances part of this, that you guys will finance this like you do PI and CPC, to come out and carry the message and the voice of young people in AA, to be a part of, I think the part of is really important. If I went into an adolescent group at treatment center, they're not going to relate to me other than I'm grandma. I think they have a wonderful message to carry and I hope that there are a lot of people that change their mind. Like I said, in eastern Oregon we don't have young people's AA, this is going to be a great avenue for us. I want to thank you guys for what your are doing, I thank you Kenji for having the courage to come up with this motion. I hope you guys change your mind.

Pat, GSR for Sisters in Sobriety, District 8: My group has given me right of decision on this and after listening to the different shares, I was voting in favor of this. What came up for me was a story from our community, which was at our Alano club there was a group of teenagers who got sober through Emergence and they wanted to start a group. They did not want older members in that group. So without any type of reference where we could go get someone, like if I had someone with hearing disabilities, I could call our chairs here, to come and serve us in that area, I had no one to go to say these people need to know what AA is about. What inevitably happened is that they disbanded and none of those children are sober today. I think it's an underserved population, particularly in rural areas, not necessarily so much in metropolitan areas. I would really like those of you who voted against it to consider voting for it.

Ron, GSR for Go to Any Length Group: We normally have about maybe 5 to 11 people that attend the meeting. Each and every one of them are over the age of 30, but we voted for this. I'm a very very young man in sobriety. I came in at 62 ½ years old. I look around and see a lot of people who are older than me and a lot of people who are younger than me. When I attended meetings, I see a lot of people that are way younger than me as far as age is concerned. But I also see people that come in with 30 days, 90 days, 6 months. I'm a baby, I'm only getting up to 4 years. But it's because of the program of AA that I have representation. I say that I'm an alcoholic when I first walk in the doors. Because I'm a GSR as well, I went out and sought it, I sought the position. We have a DCM that just got elected in District 21. There weren't too many young people, including myself at 65 years old, who wanted to step up and be that. But here you have an 80 year old man who stepped up to take the position of DCM. Now there's a lot of young people who can come to our meetings but they're not involved because of the fact that they're college students or they have other things that are pending. Yet if they get the word passed out to them through maybe this organization, you know Alcoholics Anonymous we take care of alcoholics, we take care of our own. If the young people want to have that, then that's probably part of that representation.

Gerald, GSR for Next Generation Group, District 7: I got sober at 20 years old. When I was in a corrections facility, Corrections carried the message of AA to me. When I was in a treatment facility, Treatment carried it in to me. When I got out I was lucky enough to be in an area that had young people's. When I was in those facilities, I was given the message of hope of life after alcohol. When I got out and got connected with the young people's group, I was given the hope of not having to live the rest of my life in despair. I got sober at 20 instead of 30 or 40. That message was crucial to me. We

have a difficulty in getting linked up with eastern Oregon off of the I-5 corridor. Creating this position will help us achieve that in a way because we will have a voice here to send back to each district.

Sandy, GSR for Friday Night Round Table: I don't really see this position as being any different than any of the other chairs in that all of them are with the goal of making sure that AA is where it's needed, fulfilling the responsibility statement. My arguments of need are not so much like other people's, there are just two points to make. One, the young population now, to a much larger extent than historically, is living in homes that are not intact homes. I know for a fact that that goes with a much higher level of alcoholism. The other thing is that young people who drink heavily, as these folks do, end up with damage much sooner and its much more likely to result in long term and potentially irreversible alcoholism.

Brian, GSR for Men's Plant a Seed, District 6: My sponsor always told me if you don't want to get picked off, get in the center of this, so why are we keeping our kids on the outside. Why don't we let them in and get them in the center of this so they don't get picked off.

Marie, GSR for Today Group: I live in a college town so we have a lot of young people who use the revolving door. There are a few that come in and get it and are active in the young people's groups. I'm personally in conversation with some of these young women. What I know is true is that me as an almost 66 year old woman, my approach to life and my background is different from theirs. We have the thing that we're alcoholics in common but a lot of the young people today were raised practically with an iPhone in their pocket; I wasn't, I was pre-computer. That's just one tiny example of the way that young people coming into the program today have a different set of attitudes, challenges, a view of life that may be different from our own. I'm just going to call on everyone who is my age or even 20 years younger to practice a little bit of humility around this and say there may be things that we don't know about what it's like to get sober when you're younger. I see this as the possibility for an educational experience for us as the body of AA and I also want to point out that this can be a financial boost for the young people. They have a little bit more of a challenge I think, especially if they're students, in being able to come to these kinds of events. What we can provide as the Area for these groups to carry the message to young people in AA I think would be invaluable.

Tiffany, District 14 DCM: My district was very undecided. All the groups had fairly different opinions, so as the DCM I didn't really know where my district's vote stood, because everybody was so divided on what they thought or what they wanted for the groups. Hearing everything here swayed my vote to vote in favor. Kenji kind of said it earlier, because this is a new position that we would be creating, if in the creation of that position we realized that a liaison is better fitting, then in creating that it can happen that way. Nothing about how this is going to happen is set in stone yet. In creating a position, it can happen however it needs to happen. I work for a outpatient treatment facility and I work with youth specifically, if I had the kind of information that a liaison or a chair position at the area level would be able to give me, I would be able to reach the 13 and 14 and 12 year olds that are suffering that have no idea who to reach out to and even somebody like me seems older to them, so if I could let them know, this is what's going on in Oregon, this is what's going on in Portland, this is what's going on in my town, I really see that this is a big need and that we haven't really addressed it yet.

Amie, GSR Nooner Group, District 22: I'm a child welfare lawyer and as a lawyer I love rules and I love form and I love procedure but it really seems like all the arguments against creating this position are procedure over substance. That's something we see happen a lot in law. For the people that are talking about young people group and young people groups have GSRs and representation and it's just like any group and this is going to be like a specialized position, I really think that's a Portland centric perspective because I can tell you in Yamhill county there's no young people's group. We've heard from the coast, from Wallowa county, and that's exactly the issue. I came from the Bay Area where the young people's groups were thriving. But I came to Oregon and I didn't have that and there was no outreach to young people and I didn't know where to find the ICYPAAs and those people and this is exactly what this position would do. But at the end of the day, for people who want to vote no, I just ask you to think one thing, and that is if you were a 15 year old alcoholic in eastern Oregon or the coast and your representatives here came back who have put his motion out there and argued it at two assemblies now, if they came back and told you that the service convention, that the assembly, voted against this, how would you feel. Would you feel included? Would you feel like a part of AA? I am responsible whenever anyone anywhere reaches out for help, I want the hand of AA always to be there, and for that I am responsible. I would just ask people to vote out of love and not fear.

Motion to revote made by Billy. Sher seconded.

Vote taken on whether to revote, majority required to pass, majority not achieved.

Motion:

 To fully fund a member of the Corrections Committee to the National Correction Conference. Funding not to exceed \$1500 annually.

Intent/Purpose:

• To allow the Corrections Committee to network and gain knowledge from other Correction Committee members in AA.

Current Practice:

• Corrections Committee is not currently funded to attend any conferences.

Budgetary Impact:

 The budgetary impact will change every year depending on where the Conference is being held. The 2017 National Corrections is in St. Louis, MO. Registration, lodging, airfare and meals is estimated to be about \$1000

Discussion:

Motion Read by Kirk S., Outgoing Corrections Chair

Jim F., Area Chair: Because there is a budgetary impact, we ask the Finance Chair...would the Finance chair come to the mic?

Shane C., Finance Chair: We do have the money.

Motion seconded by Dave, District 37.

Jim: The mics are open to registered voters.

Steve, District 14: I think my home group would like to hear about this motion before we voted on it.

Robert P., proxy voter for Sheridan FCI: Although I'm pretty sure they're going to be in favor of this, they would like to hear the budgetary impact and have the motion tabled and sent back.

Kathleen, District 2, GSR Sicker than Most: I need to take this back to our group and get their consensus.

Roberto F., Corrections Chair: I just want to make sure I understand this right. So we're not asking for any extra money, we're just asking to use our current budget to be able to earmark this? Kirk: No, we would be asking to increase our budget, not to exceed \$1,500 per year for travel.

Stan, District 7: When is the conference? Kirk: November 2017. We have lots of time. Roberto: November 10th, 11th and 12th, 2017.

John A., Area Treasurer: Is the corrections committee asking for a 2017 budget increase? Or are they just wishing just to use the funds out of their corrections committee line to travel. I think that was mentioned but I missed it.

Kirk: At this time, the motion is to fund someone from the corrections committee to go to the National Corrections Conference in 2017. I would say it's an add to the corrections budget for next year. I can tell you that there was \$1,800 in the corrections budget that wasn't spent this year. So if next year goes the same as this year, if the book drive goes well, the money is already there.

Matthew, GSR from District 20: Last assembly, if I recall correctly, we approved a \$300 one-time contribution for the corrections officer to attend this? Was that not approved? Was that a different conference?

Kirk: The \$300, the motion at the last assembly, was to help with seed money for this corrections conference.

Becky, GSR for Sober on Sunday in Coos Bay: We need a little bit more information and I need to take this back to my group; this isn't clear enough to understand one way or another. I think this should be tabled and we get more information and then make a decision.

Marie: That was exactly what I was going to say. I don't understand why we would increase the budget if there's enough budget now to be able to send them. Are there other priorities that you want to be funded? I don't know how to present this to my group without more information.

Kyla, District 10, GSR for Lost and Found: Corrections has a \$4,000 annual budget as it is, of which they've spent only \$2,100 in 2016, giving them a leftover unspent balance of \$1,800. Assuming, as we all do in budgets, that barring anything unforeseen, that the 2017 budget cycle for corrections will follow more or less the same pattern, and that they will have more than \$1,500 already in their budget, I can't really support having \$1,500 more. They'll have a surplus next year of over \$3,000.

Grace: So if I'm understanding correctly, yes, there is enough to go next year in November as it stands within your budget now, but what you're asking is to increase the budget for years to come, to ensure that somebody from the committee can go to this, in case in years to come you don't do as well with the book drive or any of the things that you spend that budget that you already have towards, right? Kirk: Right would be an easy answer. Yes, I'll try and clarify. The budget for corrections committee stands as one thing and I'd like to extend that budget by \$1,500 a year to cover the cost of going to the corrections conference annually. We have different committee expenses than we had this year. So if they go over that threshold of what their budget is, if we use the budget we have now to get there, we may fall

short, and they're going to be at the mic asking for more money. This motion would be to add a max of \$1,500 more to the corrections line item.

Michael G., District 1: I think possibly this is becoming more complicated than it needs to be. I don't think it needs to go back to the groups. It's really pretty simple, "not to exceed \$1,500" means just that, it doesn't mean an additional \$1,500 annually. It means that there's \$1,500 possibly that could be used. And if the cost of going to this conference is within the budget that's already there for corrections, they wouldn't need the \$1,500, they could use what money they have. Am I right? [Feedback was provided that his statement is incorrect]. Ok, well maybe I'm not right either, so maybe it is more complicated than I thought.

Kirk: If we don't put it in the budget, they're going to be at the mic asking for the money.

Mike, District 5: Does that mean they're asking for \$5,500 for the budget and they want to earmark another line item? [Inaudible feedback provided] Not another line item, you just want to increase it to \$5,500. Correct?

Kirk: Yes

Mike: Yes, so, in other words, corrections wants to add to their budget...instead of \$4,000, \$5,500. That's just in case they need it. Right now they don't need it but that's just in case they need it. Am I correct?

Kirk: Yes

Brenda: I started coming to assemblies in 2005 and my personal observation has been that this corrections committee has worked their butts off the last two years and has done more for corrections than has ever been done in this area and I think it's a great idea to continue to support those efforts.

Question Called by Tiffany Seconded by Kathleen, District 19

Vote taken to end debate, 2/3 majority achieved. Debate Ends.

Motion determined by a majority to be neither urgent nor administrative and will be **TABLED until the February 2017 Area Assembly.**

AREA ASSEMBLY - DELEGATE'S REPORT NOVEMBER 20 2016

Hello Oregon Area! My name is Reilly and I am an alcoholic. I currently serve as your Oregon Area 58 Panel 66 Delegate. My home group is Wildlife, in District 13. My sobriety date is August 7, 1966.

Congratulations to new Area Officers and Committee Chairs. Welcome to new DCMs and GSRs. We are all excited about this group of trusted servants who will be working together in the next year. If you're new, take lots of notes to make sure you are accountable to the Districts and Groups that you serve. A lot of GSRs are not able to come to Assemblies, so bringing your notes to District meetings can help fill in missing pieces for other groups.

You'll be hearing about the Area Orientation from Vera, but I want to emphasize how important it is for DCMs and Area Committee Chairs to attend. GSRs get lots of information from GSR schools, but the annual Orientation is the best place for everyone else to start out the new year with the latest information. Mark your calendars for January 14, 2017, and plan to stay all day.

I want to tell you how much I enjoyed traveling to Districts with my Delegate's Report. I met wonderful people, ate great food, and was asked discerning questions everywhere I went. I finished the year so far in Medford, North Bend, and Klamath Falls. In October we returned to Mill Creek at Oregon State Prison, where we had a great discussion with more inmate participation than I've ever seen before.

This year I've driven 8,446 miles on Area business, and flew 10,000 more, to the New York Conference and the Pacific Regional Forum in Hawaii.

This is my report on the Pacific Regional Forum held in Kona, Hawaii. I am keeping it short because I have a lot to tell you today. Please be sure to read the full report in the online full minutes. There's a lot of information in it.

We are fortunate in Oregon to have an Area that funds both Delegate and Chair, as well as their alternates. We embrace the concept of training and educating our trusted servants, and we are grateful for all the opportunities you give us to learn about how to best serve you.

I traveled to Hawaii through Seattle. . I arrived in Seattle early Thursday. As I approached the waiting area for my flight, I noticed what appeared to be a drunk sleeping across a row of chairs. I moved carefully closer and realized it was our own Chair Jim F! He was trying to alleviate the effects of having traveled all night.

Friday evening's presentations were from Class A and Class B Trustees explaining, with great love, the purpose of the entities at the very bottom of the upside down triangle. Vera and I were pleased to note that this is information Area 58 regularly furnishes in our GSR Schools. But nothing is quite like hearing it from the people who do the job.

Joel C welcomed us all. First all the trusted servants were introduced. The really fun part was introducing the Areas. Members from each Area were asked to stand as they were announced and a slide was shown that embodied the spirit of that Area. Area 58's slide was of the 7/14 Challenge Flyer! We have definitely made our mark on A.A. history!

The Forum was wonderful, as usual. GSO staff are all so personable it's a delight to hear all about the services they perform for us. My presentation on Saturday morning was well received, and afterward I was able to relax and enjoy the wonderful presentations by everyone. We will be getting the final report to share with all of you when it's ready. In the meantime we will all try to pull together some of our favorite moments and best quotes to share.

We had to make hard choices when it came to what workshops to attend. Out of a dozen we could only choose two. Vera and I split up so we could cover four workshops. I took "Safety in A.A." and "Leadership". Vera covered "DCMs and GSRs Effective Communication" and "Mental Health".

Here are some highlights from "Safety in A.A.":

Calling it 13th Stepping trivializes predatory behavior.

Groups should form an action plan. Know who does what.

Stick your hand out. Don't automatically assume hugs are okay.

Educate everyone, not just along gender lines.

On physical and emotional violence:

Add a safety statement in group format.

Make a GSC agenda request.

Collect shared experience in districts and areas.

The more you talk about it the more it becomes visible.

Ask them to leave until they can behave appropriately.

Add to announcements "This group wants to maintain a safe and healthy environment. If you need to vent, talk to someone you trust after the meeting."

Here are some highlights from presentations:

Do Directors and Trustees have to be alcoholics? - Yes.

- Could the General Service Conference rotate to other places? we do look at other places. New York has convenient airports and hotels. Send any request for changes in the bylaws to the Conference Committee.
- How do we handle contributions from roundups and events? any A.A. entity, like intergroups, can contribute but are not assigned a group number.
- Why was atheist pamphlet killed? We just published Many Paths to Spirituality. It wasn't the right time for a new one. If you still feel we need that pamphlet, send a request to Conference Committee.
- What do you say to members who say GSO is ineffective or not useful? Ask how their group would translate the Big Book into Russian or print literature.
- Russian and Ukraine members had breakfast together. World peace is not a goal in A.A., just like having a drivers license with your own name on it is not a goal in A.A. ... but it's nice.

I'm embarrassed when I realize I spend more on a pair of shoes than I put in the A.A. basket.

Uganda has over 30 million people, highest per capita drinking problems, 50 A.A. members, and four groups.

- When should a group inventory be scheduled? regularly, before resentments. Take a group conscience to decide how to start. Use outside facilitation.
- Do GSRs vote in the group conscience? in case of ties.

One convention purchased 276 Grapevine subscriptions and gave them to the Corrections Committee. Pacific Region is Grapevine country, with greatest subscriptions by far. Grapevine Reps should register with A.A. Grapevine Office.

I want to thank you again for allowing me to attend these awesome service events. You don't do it so I can go someplace – you send us because you can't all go yourselves. So we try to do our best to bring the flavor of the event and all the information we can give you in order to fulfill our primary purpose in serving Area 58.

The next event to look forward to will be the Area Assembly on February 24th. It's not too early to be talking to your groups about discussions on Conference Agenda Items or planning your District Agenda Item Workshops in March. We already know what some of the Items will be, just not exactly how they will be worded on the Agenda. We do know that we can be talking and getting the opinion of your groups on the Deviation of the D

- 1. Revising the pamphlet on Sponsorship
- 2. Consider revisions to Chapters 2, 3, and 5 of the A.A. Service manual.
- 3. Print the self support packet in Spanish and French.
- 4. Reconsider the recommendation to publish La Viña in 64 pages.
- 5. Consider developing a pamphlet for deaf newcomers.
- 6. Retire the pamphlet "Too Young".
- 7. Revise the Short Form of the Concepts.
- 8. Add a disclaimer to pamphlet "Problems other than Alcohol".
- 9. Develop literature for guidance on personal conduct, safety, and protection.
- 10. Reduce the cost of the General Service Conference by 5% per year.
- 11. Eliminate La Viña spiritual parity with Grapevine.

I have background on most of these topics but it is confidential material and cannot be printed and handed out. So I will send a packet to those DCMs who see me today and give me a valid private email address. In the meantime, I will send a list of these topics to the DCM group address and groups can start discussions.

At the February Assembly you will participate in a mock Conference. Your district will be assigned an agenda item and discuss that item at the Assembly. When you get home, prepare your groups to attend a Conference Item Workshop in your district. Take good notes. We tell you, often, that your group runs A.A., and your voice counts. This is how your group's voice gets to the Conference. Write up the notes. Send them to Vera and me. Write down the comments, the feelings, and the opinions of your group members. This paper is your group's voice, and I carry it to the Conference. You aren't giving me a vote to carry, nor am I bound to vote according to your opinions. What I AM bound to do, is to make sure your voice is heard. I make sure those feelings are represented in the discussion. If your comments are different from other Areas, I make sure yours are added. It is my job to carry your voice, in my pocket, on this piece of paper, to the Conference and tell the rest of the world what you think of these Agenda Items. Then your voice is heard. If you don't hold a Workshop, or don't send in your notes, or don't participate when you have the opportunity, then you have taken away your group's voice from the Conference.

Many questions were asked at the Regional Forum about changing this, or improving that. The answer, time and again, is: If you would like to see changes in Alcoholics Anonymous at any level, send a request to the Conference Committee at GSO. I've heard from some of you about how your groups would like to see some changes. Send those requests to the Conference Committee. December 15th 2016 is the last day that items can be accepted for consideration for the Conference Agenda, so write that letter as soon as you can if you have something to add.

I have the final amount for "7/14 on 7/14" contributions. I know there are some groups who never thought to send me an email total so I know I don't have everything from Oregon. With only the totals that people told me about, I can tell you that Oregon Area contributed \$11,621 to GSO! That represents 1,628 A.A.

members. That makes over 10% of all Oregon A.A. members who contributed their share of GSO Operating expense this year. I spoke to our Treasurer, David M, at the Regional Forum. He insisted that GSO could only identify about \$4,000 as 7/14 contributions. I insisted it was a lot more.

The final word from GSO now is that combined contributions for July, August, and September were about \$300,000 more than was expected! The Board " doesn't have any direct way of knowing the precise impact of the \$7.14 on 7/14 campaign, but these numbers from July through September suggest that this campaign had a positive impact on contributions." The Board sends thanks to Oregon Area.

In other news, there is a plan in the works to allow service committee chairs to opt out of Postal mail and receive material by email.

Service material is being developed about Safety in A.A..

Approval has been given for Guidelines for PSA's on A.A. Websites.

The GV book "Experience, Strength, and Hope" is being translated into Spanish.

Big Book translations in Hebrew, Polish, and Thai are in development. The Navajo project is almost done. A new production in ASL is in progress, with deaf signers in the video, and deaf members involved in the process.

The Grapevine Board sends its gratitude to your Area Grapevine/ La Viña committees and Reps for all your efforts in increasing Grapevine circulation. It appears to be leveling off instead of continuing to decline. Thank you for your hard work. In order to hold off on subscription prices for now, the Board approved a 50 cent increase on all GV and LV books.

A new Board Chair has been elected to succeed Terry Bedient at the end of the 2017 Conference. I am personally excited to welcome Michelle Grinberg as our new Board Chair. Listening to her speak during the 2016 Conference was enlightening, and I had the privilege of getting to know her at breakfast one morning. She will serve us well!

The Feasibility Study is now the Subcommittee on Feasibility and Sustainability. This plan, focusing on the future of A.A., will run alongside the Strategic Plan. A lot of the Strategic Plan comes from the General Service Conference Inventory, so that will be referred to many times in future discussions. Every group was given a copy, but I have a few with me.

The Archives trustees committee forwarded a proposal for a new book, a collection of Bill W's General Service Talks. They also decided not to create a Flickr page for GSO archives.

The latest plan for translation of Conference background material might rely on local volunteers. A more helpful suggestion involves posting background material throughout the year instead of all on one day in February.

The CPC committee developed a new accessibilities checklist for groups and accessibilities committees and should be available in January.

The Corrections committee is gathering shared experience on how literature can help incarcerated indigenous inmates. Members or committees who have related experience please contact Jeff W at GSO. The new video "A New Freedom" is available for \$10 from GSO. We reviewed the video at Mill Creek and they loved it.

This is only part of what's going on in the larger world of A.A.. I hope to have more to share as we approach the February Agenda Item Assembly. I'm looking forward to seeing everyone there!

AA members have a chance to travel no farther than their own Region to participate in terrific workshops and panel discussions.

Joel C, Pacific Region Trustee, asked "What does GSO have to do with the average group?" It's GSO's responsibility to provide services to groups. The voice of the group is carried through the General Service structure and the work is delegated to the Delegate. Groups communicate through the Conference to ask for services they want to have, and GSO carries out those requests.

Ivan L, Class A Trustee, had this to say: Class A Trustees are very much like you, except we don't share the disease of alcoholism. You've trusted us and welcomed us to be part of this great Fellowship. We are your public voice. We have worked the Steps of your Program. And sometimes we make a mistake. You will tell me when I do. And I will learn what your "small t" traditions are."

Joel introduced the GSO staff, directors, and Trustees. He then asked everyone from each Area to stand while a slide was displayed that embodied the spirit of that Area. The slide for Oregon Area 58 was the 7/14 Challenge Flyer. Joel said" If you don't know what this is, ask Reilly." Mid Southern Area 09 slide showed a flyer from the Symposium of Service in Long Beach in 1973 on the Queen Mary, which I attended. That experience remains one of the most significant memories of my service life. Area 93 showed a logo of the Freedom Group - a group that I helped found in 1972. I realized then how close my ties are to the entire Pacific Region, and how grateful I am to be part of AA service no matter where I go.

The Forum was wonderful, as usual. GSO staff are all so personable it's a delight to hear all about the services they perform for us. My presentation on Saturday morning was well received, and afterward I was able to relax and enjoy the wonderful presentations by everyone. We will be getting the final report

to share with all of you when it's ready. In the meantime we will all try to pull together some of our favorite moments and best quotes to share.

We had to make hard choices when it came to what workshops to attend. Out of a dozen we could only choose two. Vera and I split up so we could cover four workshops. I took "Safety in AA" and "Leadership". Vera covered "DCMs and GSRs Effective Communication" and "Mental Health". Here are some highlights from "Safety in AA":

Calling it 13th Stepping trivializes predatory behavior. Groups should form an action plan. Know who does what. It's a problem for all of us, not just for women anymore. Stick your hand out. Don't automatically assume hugs are okay. Observe actions and be ready to help out. Communicate with newcomers. Be honest about known problem areas. Don't protect bad behavior because a person has status. If you see something say something. Back people who take responsibility for action. When introducing people, it's okay to say if they are "safe" or "risky". Promote good sponsorship. Watch subtle behavior. With gay sponsorship gender lines blur. Set an example. Educate everyone, not just along gender lines. On physical and emotional violence: No retribution for disagreements in business meetings. Use group inventory to develop safety guidelines and workshop. Make a GSC agenda request. GSC is not the cure for everything. Should be addressed in literature. Add a safety statement in group format. Create local solutions Collect shared experience in districts and areas. The more you talk about it the more it becomes visible. Do we tell other meetings about restraining orders or historical issues? Ask them to leave until they can behave appropriately. Add to announcements "This group wants to maintain a safe and healthy environment. If you need to vent, talk to someone you trust after the meeting." What would a normal person do if it was me? Pray.

We learned some fun facts from AAWS and Grapevine Directors, Joe D and Lynda B.

Scott H, trustee at large, shared wonderful stories about service meetings in other countries. In spite of language differences, so much is the same.

Russian and Ukraine members had breakfast together. World peace is not a goal in AA, just like having a drivers license with your own name on it is not a goal in AA ... but it's nice.

I'm embarrassed when I realize I spend more on a pair of shoes than I put in the AA basket.

Uganda has over 30 million people, highest per capita drinking problems, 50 AA members, and four groups.

Grapevine Board, Ami B reminded us that the Grapevine was meant to unite the far flung members. A survey said that Grapevine is used first for personal recovery and then for service.

One convention purchased 276 subscriptions and gave them to the Corrections Committee.

Pacific Region is Grapevine country, with greatest subscriptions by far.

Grapevine Reps should register with AA Grapevine Office.

Archives are a special breed of people.

On group inventories - Why are we allowing to go on with our groups that may drive someone away? On Grapevine - I am in prison for life due to alcohol. But I use the lessons I read in Grapevine.

Here are some questions from the General Sharing Sessions:

What about automatic renewals for subscriptions? - the new GV subscription app does that. How can Google get better search results? - we are looking at options to see how Google can be used. Can we publish trustee names in the Service Manual? - all change suggestions to the Service Manual

are welcome, but they must be submitted to the Conference as an Agenda Item.

Do Directors and Trustees have to be alcoholics? - Yes.

Could the General Service Conference rotate to other places? - we do look at other places. New York has convenient airports and hotels. Send any request for changes in the bylaws to the Conference Committee.

What is status on legal issues? - Ontario/Toronto suit against AAWS was brought by an AA member, who claimed discrimination against atheist groups by de-listing from the World Directory.

What is the Class A trustee term? - 3 years, can stand for 3 more years.

- Is there a way to tell if it's an alcoholic trying to make a contribution? it's on the honor system. You are a member if you say you are.
- How do we handle contributions from roundups and events? any AA entity, like intergroups, can contribute but are not assigned a group number.
- Where are we going with internet communications? GSC asked PI Committee to set up Twitter and Google accounts. There is a Linked-in account.
- Why was atheist pamphlet killed? We just published Many Paths to Spirituality. It wasn't the right time for a specific pamphlet for atheists. If you still feel we need that pamphlet, send a request to Conference Committee.
- Is it time to have a 4th edition of Spanish Big Book? Info is being collected on that.
- Non-alcoholics work at GSO. How are AA members anonymity protected? 75% work in support areas. Recovery is covered by AA staff. Info is closely held. Security is tight.
- How can we use Grapevine articles from online archive? one time use for everything.
- Bill used Grapevine as a communication tool. Would trustees use it as such? Articles from trustees are printed now.
- What do you say to members who say GSO is ineffective or not useful? Ask how their group would translate the Big Book into Russian or print literature.
- When should a group inventory be scheduled? regularly, before resentments. Take a group conscience to decide how to start. Use outside facilitation.

Do GSRs vote in the group conscience? - in case of ties.

One aspect of meeting in Hawaii is that we don't wear traditional business suits, and were encouraged to wear Hawaiian shirts. It was especially interesting to see GSO staff and Trustees dressed so casually! And then very casually when we spent an evening on the beach! A local family regularly hosts a fantastic luau dinner for friends and family and we were able to attend Sunday night, along with several other Forum attendees. After 3 days of meetings from 9am to 10pm, it was so nice to relax on a beach and eat terrific Hawaiian food with loving members.

Alternate Delegate Pacific Regional Forum & November 2016 Quarterly Assembly Report Combined

Hello OR Area, it's good to be with you again! My name is Vera F. and I'm an alcoholic. My sobriety date is Sept. 19, 1989 and my home group is Attitude Adjustment in Bend. This is my Pacific Regional Forum & November Quarterly Report Combined.

Shortly after our September Assembly I traveled to Waikoloa, HI to attend my first Pacific Regional Forum! I have heard about these forums for years and was excited about going. Regional Forums are basically road shows for members of the General Service Board, A.A World Services, A.A Grapevine Corporate Board, GSO, and Grapevine staff along with the trusted servants of a specific region, in this case the Pacific Region. Regional Forums are designed to improve communication. They are intended to be sharing sessions, so there are no formal actions taken. The agenda for the forum included general sharing sessions, an ask it basket, presentations and workshops. There were six delegate presentations and the delegates were given the opportunity to choose their topic. One of the presenters was our Delegate Reilly K. As I listened to Reilly's presentation, "Bringing the Concepts to Life", it became increasingly clear that she is one of the few remaining direct links to Bill & Lois W, and the rest of the pioneers of A.A. And how fortune we are in OR Area to have her with us!

Some of the other presenters were Eva Sanchez, GSO Staff coordinator, she explained staff assignments at GSO. Scott Huyghebaert, Trustee At Large Canada shared his experience as a trustee at large. David Morris, General Service Board Treasurer presented on GSO finances, complete with charts and handouts. We were invited to ask questions on all the presentations. Some of the workshops included "Making AA Message More Accessible", "Financing AA's Vital Services", "AA & Mental Health", and "Concept Nine: Leadership in AA." I attended AA & Mental Health workshop where I heard stories about how members are supporting members in their home groups with mental health concerns, including sponsorship.

The General Sharing Sessions were open mic times for anyone to ask questions, make comments and share experience. I enjoyed this informal way of engaging in sharing of information. The folks from GSO were responsive to all questions and typically answered them immediately or came back quickly with the answers. The GSO staff came with tons of literature. The walls in the conference room were lined with tables filled with all kinds of literature. Some of it was available as handouts and some was for display only, like the Big Book in Braille. This book is so big it comes in seven volumes! There was also a copy of the 12x 12 in Braille (2 volumes) and a Braille Daily Reflection (3 Volumes). These books were produced by Associated Services for the Blind and are available to members who are visually impaired at the same cost as we pay for our books. This is possible because of the 7th tradition contributions A.A. members and A.A. groups send to GSO. To me this is an awesome example of carrying the message to alcoholics. I have pictures if anyone is interested!! We also previewed the new Corrections video "New Freedom".

In his opening remarks, Joel C. our Pacific Regional Trustee invited us "to have an experience rather than take notes". At first I was delighted to receive permission NOT to take notes. However, as the day went on I heard many things that moved me to put pen to paper. I'd like to share with you some of what I learned and what I heard.

Some Things I learned:

- Trustees for the GV do not have to be alcoholics
- on the Corporate board (AAWS) all but 1 director are alcoholics
- PI trustees are looking at options to enhance google presence online, they were requested to submit a plan to establish a twitter account
- CPC trustees are working on looking at LinkedIn account
- A survey was sent out to NA and Al-Anon to gather information on their experience with using social media platforms with the intent to use this information to see what we don't want AA to do
- In 1947 the A.A. preamble was written by GV's 1st editor and it was inspired by the foreword of the 1st edition
- In 2015 there were 12.7 million visits to AA website. With an average of 22,000 hits daily on the daily reflections
- Class A trustees(non-alcoholics), are our public faces/voices. Because they don't have issues of personal anonymity, they can and do carry the message of AA, what AA is and what it is not AND they have worked the steps.
- 42 thousand A.A members subscribe to the GV quote of the day
- In the July Board Report---it was decided the work of the Feasibility Study should go forward in some form, increase the size of committee to add a few more trustees, analyze the suggestions and priorities, and a new name for F.S to something more positive

Things I heard at the mic during general sharing:

- "Our literature is intended to describe our shared experience not rules.....suggestions"
- "I didn't get into general service until 12-13 yrs. sober, I had no idea. I just took it for granted that all this was here and that you do what you want to do."
- "I'm amazed at how A.A. allows for more when you're ready for it."
- "I am moved by the service and devotion GSO staff."
- "Just as AA is for the individual who wants sobriety----the AA service structure is there for those who want AA in the future."
- "To be effective in service I must surrender to something greater than myself."
- "I'm leaving with a full and grateful heart"

Overall it was a wonderful experience and time does not permit me to share it all with you. I am very grateful to OR Area for including attendance at Regional forums as part of Area Officers ongoing education and growth in AA!!

Soon after returning from the Regional Forum, Reilly and I visited the Mill Creek group at Oregon State Penitentiary where Reilly gave her post conference Report. We were treated to some huge cinnamon rolls and coffee! In April Reilly facilitated a sharing session with the Mill Creek Group on the Correction Agenda item concerning replacing the video "It Sure Beats Sitting in A Cell". So, it was especially rewarding to return in October with the new video for their review. The Mill Creek members loved it. They felt it was realistic and carried the message in ways they could related to. I was stuck by the level of passion the Mill Creek members demonstrated. Their interest in what's going on in A.A is exciting and contagious. Two GSR schools filled out the month of OCT. I want to thank District 4, Salem for inviting me to present a GSR school. I met an enthusiastic group of GSRs and future GSRs! The food and fellowship was fabulous. We had a wonderful exchange of ideas and information. The conversations and the feedback forms indicated people came away with a renewed commitment to service, an understanding of our 3 legacies, and a better understanding of the role of a GSR.

Next I traveled to Hood River, District 14. The drive over was an amazing spectacle of fall foliage and Mt. Hood was glorious. There I met up with Past Delegate Ann M. who agreed to co-present with me. We were treated to a warm welcome and a tasty potluck. Many of the participants were future GSRs seeking to increase their knowledge about the position and General Service. They were engaged and had some great questions. I enjoyed my visit with District 14 and look forward to seeing some of those future GSR at an assembly soon.

My next project is Area Orientation which will be held on Saturday Jan 14, 2017. Please mark your calendars and plan to join us in Eugene. Fliers are available on the tables. I hope to see you there!

Friday night's sessions also included General Service Board presentations from our class B, Alcoholic, Pacific Regional Trustee Joel C. and Class A, nonalcoholic, Trustee Ivan L. Friday evening ended with a general sharing session.

Saturday morning began with Delegate presentations. Chery N., Panel 65, Area 17 Hawaii, spoke on the meaning of "I Am Responsible." Scott M., Delegate Panel 65, Area 05 Southern California, topic was "Group Inventory." If you wish to do so, please complete a New Group Form and submit it to the Registrar to complete the process.

As we transition to the new positions, I would just like to remind anyne who is completing a form to submit it either online at the Oregon Area website or directly to the Registrar. Do not send forms directly to GSO, especially New Group Forms, as the information does not get back to the Registrar immediately and sometimes the District number had not been provided. Some of you probably recall my contacting you about certain groups to verify their District number.

So this is it, I am rotating out at the beginning of new business from my position as your Treasurer. I have been a part of Area service for 10 years now, starting with being a GSR and I can honestly say I was the last person that thought I would be here today rotating out as your Treasurer. My gratitude is tremendous; my love for you servants of Oregon Area will always bring me pride and respect to have served among you.

I want to give a huge thank you to those that came before me as Treasurer; especially Teffany and Gus who were always willing to answer questions and guide me when I cried out for help, and this my very last financial statement gave me some grief like I've never had. I was \$11.58 cents off in balancing the statement with the checkbook. I was a wreck, how could this happen to me now? I have had almost 2 perfect years with no major money mistakes. I couldn't stomach the thought of standing up here and telling you I couldn't find the mistake. I could not rest until I found the money I was sleepless in Eugene! I called one of my mentors for help, he helped me narrow down the search and calmed my nerves, but he also mentioned that it might be that the universe is mad at me for "giving the finger" to the Area. It wasn't helpful I should have called Teffany instead! I'm delighted to say I found my mistake and I will go over that when we look at the financial statement.

Moving on I want to say it has also been my honor to work with John A. for the last 2 years, John and I have different styles but we have the same love of service to Oregon Area that united us and I believe made us a very good team. Your Treasurer elect John is going to do an awesome job, his commitment to you and Oregon Area is strong. I have learned so much from him that I will carry with me and his experience as past finance chair has be extremely valuable and I'm truly going to miss working with you John.

On a lighter note some of you may not be aware that there is yet another service position available with my rotation, and that is the need for another member of the "Gus Assistance Program". My dear friend Gus is being left at the curb, he travels well he does bring baggage but disguises it in the form of experience strength and hope. And he always carry's a long list of great places to eat. This isn't an elected position this is a voluntary position, basically its service work. But because Kirk and I love him so much, we are currently accepting resumes so drop yours off to either Kirk or myself.

Finally let's get on with it, my favorite part of the business meeting the Area finances!

I have distributed 300 copies of the 4th Quarter Financial Statements on your tables this morning, I do my best to give enough copies to each District but if you don't have enough at your table please ask your neighboring District if they have extra. The heading reads Q4 2016 Oregon Area Financial Statement.

As the dates show the 4th Quarter began on September 16th – the Friday of our last Assembly to November 17th the day before this Assembly.

Let's start in the upper right side; we started the 4th quarter with a Cash in Bank of \$38,088.12; now moving to the first section in the center is our Income and we will be looking at Q4 which is printed in bold. The income section totals \$14,290.26, which John went over in his report. You might notice that this is where I made the adjustment for the additional \$11.58. As the asterisk explains, at the bottom in very tiny print there was a refund from a voided check of \$35.00 and unreported PayPal fees of \$23.42 from Q3. Yes, even I am less than perfect!

The next section is our expenditures the largest part of this financial statement; again we will be looking at the Q4 column in bold print.

The first section of our expenses shows Officers and Service committee reimbursements for the work they do for the Area. The next section is for Travel, which you can see is down considerably from Q3 since the Officers commitments to PNC and Regional Forum are now over. There's an expenditure of \$210.00 for DCM's travel to Assemblies, while it is the responsibility of each District to fund their DCM, this line item is intended to help those Districts that cannot fully fund their DCM.

The last section is our Administrative expenses; it shows we paid the Archives repository rent of \$795.00. \$310.99 to purchase a new projector for the Alternate Delegate; \$146.18 for our annual Go Daddy web hosting, which includes additional Internet security. The \$300.00 on the Miscellaneous line item was from the motion passed in September to send a one time contribution to the first annual National Corrections Conference.

These expenses for the 4th Quarter of 2016 totaled \$15,419.94. Shown at the bottom of the Q4 column and in the right hand margin.

Expenses were down by 32% from last quarter and just 2% higher compared to the same quarter in 2015.

So, our Ending Balance coming into this Assembly is \$36,958.44 which shown the last box on the right hand margin.

The very last section is the Outstanding Assembly Advances, totaling \$2,700.00. These advances are given to Host committees as seed money, and are returned to the Area at the conclusion of their Assembly.

As a reminder the financial statement will be include in the Assembly minutes posted on the Area website.

As always we want our Area Treasury to be transparent, and we will keep you informed of our checkbook balance during the assembly. Normally I say here if you have any questions later on you may email or call me, but this time, if you have any questions later on you may email or call John, his information is in the Area Roster and you can also find his email on the Area website under Finance, Treasurer.

Thank you again for the honor and privilege of serving Oregon Area.

Accessibilities

My name is Lisa and I am an alcoholic and your outgoing Area 58 Accessibility Chair. My sobriety date is 11/09/93. My home group is Sober on Sunday in District 10.

Last assembly I attempted to use a hearing application through my phone for hearing assistance. If you are attempting to use an app for hearing assistance, there are two kinds of hearing apps. One is for people who do not have hearing aids and the other is for people who do have hearing aids.

Last assembly a member from District 8 asked about hearing support that could be used at a group level. Yesterday members took turns using a low tech device called SuperEar. This device is for a personal user. It amplified sounds. After some usage the consensus is the device is best for small spaces without a lot of background noise and for people without hearing loss. This device can be good alternative for listening assistance at the group level. If you would like to know more about the SuperEar contact the Access Chair.

The FM System is here and being utilized. This hearing assistance is available for any member to use during the assembly. To check out equipment contact the Host Committee. There is also a second FM System and radios that can can to be checked out for events. Contact the Access Chair to schedule use.

Access can include so many things from child care to taking meetings into retirement communities. Each group can view the Area 58 Access website resources: hearing survey, Handicap Survey and General

Access Survey. These are good documents to use for conversations and new practices at the group or district level.

Many people have expressed an interest in this committee your information has been passed on the the next chair.

Lastly, Portland Deaf Access Committee provides translation for deaf members to attend AA meetings of their choice. The group meets the second Sunday of the month at 6:30 pm in Portland at the Alano Club. PDAC continues to need support. If you have questions ask present PDAC members or myself.

GRAPEVINE REPORT GUS P 11/20/16 (the long form)

Hello Oregon Area! My name is Gus P and I am an alcoholic. I am currently serving you as your alcoholic Area Grapevine Committee Chairperson. My sobriety date is 12/1/93 and my Home Group is the Downtown AM Group in Eugene, where sobriety begins at 7 AM Monday through Saturday each week. Please join us whenever you are in Eugene.

This is the unabridged version of my long-form Grapevine report which will appear in the Area Minutes. This expanded report is offered because the 3-minute timed Assembly Business Meeting Report does not permit complete coverage of Grapevine topics.

This last quarter has gone by very quickly. It seems like it was just a few weeks ago that we were gathering in Redmond in District 5 for our General Assembly; and now we are meeting in Portland to conclude our Area business for the year 2016. During this last quarter, the Grapevine Committee made a presentation in Salem at the District 4 business meeting in November. It was a pleasure to be in District 4 again and to answer the very thoughtful questions that the District GSRs had for me about the Grapevine. My thanks go out to DCM Tresa J for inviting me to your District and to all the GSRs present for patiently listening to me. I had a great time being with all of you.

Also during this quarter, I attended this year's Sky Camp Men's Retreat in Little Fall Creek; and later travel with my sponsor to Corvallis and listen to him give a wonderful AA pitch stressing that hope available to all of us in sobriety.

During this past quarter, the Tuesday Night Men's Workshop continued its work on the Steps using the Big Book Workbook. The 12 participants are taking this journey through the Steps using the Big Book as our main literature tool, and we are nearly finished with Step 12. As our next Workshop topic, we have chosen the Twelve Traditions and I can hardly wait to get started!

The AA Grapevine has recently published a new book entitled "Our Twelve Traditions", and is available online for \$10.99. The book contains a chapter on each of our 12 Traditions; with anywhere from 7 to 10 stories offered for each Tradition. These stories have been previously published in the Grapevine magazine; and several of the stories are reprinted in the November 2016 issue of the Grapevine.

I have not read the book in its entirety yet, but I have read the articles that were republished in the current Grapevine magazine issue. I am trying hard to not read the stories in the book because the Tuesday Night Men's Workshop has decided to study the Traditions again as a group and we will be including this book is part of our assignments. I don't want to read ahead and appear to be overly studious because the boys are very sensitive and I am smart enough to not give them an opportunity to hassle me.

There is a new Grapevine Subscription App, from which you can now subscribe to the magazine. You can then access the magazine on your tablet or smartphone monthly (\$1.99 per issue or \$23.99 for a 12-month subscription). You can download your issue for offline viewing, archive past issues, get a sample audio story or selected video and email your favorite articles to friends. The app for iPhones and iPads is available now; with access for Android phones and tablets, Microsoft 10 and Amazon Kindle Fire coming soon.

The AA Grapevine "Grow Your Grapevine" Contest is continuing and complete details of this contest can be found in current issues of the Grapevine magazine and on the AA Grapevine website. Complete rules for the Contest can be found on the website. When the contest ends on February 28, 2017, stories from the Area with the largest number of Arbor Cards submitted will be featured online and in the Grapevine magazine sometime in 2017.

In the Contest, individuals and/or teams are asked to complete specific GV activities and then submit an Arbor Card. Individuals and/or teams may submit multiple Arbor Cards.

There has been some misunderstanding about submitting your Arbor Cards. You do not need to fully complete all the tasks listed on the Arbor Card before you submit it for our Area's tally. Just do what you can. When you complete one or more of the tasks, fill out an Arbor Card and submit it.

It's easy to submit an Arbor Card. All you need do is go online at the AA Grapevine website, click on the "Grow Your Grapevine" Contest dialog box and you can fill out and submit your Arbor Card electronically. You can also mail in a Card to Grapevine using the form found in current Grapevine magazines. There are copies of the rules and the Arbor Card available at the Grapevine display.

Besides the Area winner, 5 other winners will be selected by random drawings and receive valuable GV prizes.

So far in the current Contest, Area 86 Western Ontario is leading in the contest with 547 Arbor Cards submitted; Area 34 Michigan Western is in second place with 209 cards. Area 58 Oregon has only submitted 11 Arbor Cards to date. I know we can do better than that!

I read the Grapevine as soon as I receive it in the mail; and there were two issues printed since our last Assembly. I started being a Grapevine reader almost from the beginning of my sobriety; and I find something of value and interest in every issue. I enjoy reading the stories and letters from other AAs, and I find myself silently identifying with most of the stories that I read. The Grapevine has increased my awareness of AA principles and their practice in everyday life by enhancing my ability to be a compassionate and spiritual sober man. It is an essential AA tool for me. The October issue's main theme was "Atheist and Agnostic Members" and included five stories from AA members and one entitled "We Share Common Ground" from Trustee Emeritus (nonalcoholic) Ward Ewing who is a past Chair of the General Service Board and an ordained Episcopal priest. All the stories were interesting and informative and I particularly enjoyed the one entitled "Open-Minded"; and the article from Ward Ewing was inspirational and uplifting.

Also in this issue was an article entitled "Study Buddies" in which I found a level of dedication to learning all one can about the AA program that made me question whether my once a week session with the Tuesday Night Boys is doing all I could in this regard. The author of the story certainly got me to start thinking about creating additional study groups. The article "I'm Getting Thirsty" was a terrific reminder about our singleness of purpose and I enjoyed reading it.

The November Grapevine had as its main theme the AA Traditions and included four stories from the new AA Grapevine book on Traditions. All the stories were good, and as I said earlier I can't wait to read the rest of the book. There is also a very good article on Step 11 entitled "Spending Time with God". I liked it a great deal and I found a quote which describes my experience with the Steps perfectly: "As I progressed through the Steps, I began to trust in something outside of myself. I began to have a book of God moments and God signs that made it harder to doubt there was something else out there."

The "Happy Sweltering Thanksgiving" article reminded me of the many drunken Thanksgivings I had since high school before I got sober. My last drunken Thanksgiving was only six days before my last drink, and it was critical in me having a moment of clarity. The article also reminded me of all the wonderful Thanksgivings I have had ever since with my family and friends.

I remain hopeful that we will be able to build an active Area Committee of Grapevine Representatives and other AA members who love the Grapevine; and that I will be able to pass on these names to the next Grapevine Chairperson. I am still gathering names of any member willing to join in this effort. My goal is that every Group and District in the Oregon Area that does not have a Grapevine Representative yet will create such a position and fill it with a member interested in growing our Grapevine.

Thank you, Oregon Area for this opportunity to serve you as your Grapevine Representative. I remain extremely grateful for all the help, encouragement and fellowship I receive from all of you; and I am anxiously looking forward to visiting your Districts throughout the year to deliver either a Grapevine presentation, a Grapevine Article Writing Workshop or any other assignment you may have for me. And as always, I travel well, work cheap and enjoy visiting you on your home turf. Thank you for being patient with me and for the opportunity to serve the Oregon Area.

Translation Committee Chair Report September 2016

Greetings, fellow AA service geeks. The September Assembly is less hectic than February or May, because there are no District, Intergroup or Committee reports to translate. The committee's main activity this summer was providing translation for PNC in Pendleton. Dorothé, Martha G. and I travelled to Pendleton; unfortunately Karla G., the only oral interpreter available early Friday evening and Sunday morning, cancelled at the last minute for health reasons. There was good attendance by Spanish speakers. PNC paid for a hotel room and meals for two people. Lorena V. gave an excellent panel presentation on the topic of service, in Spanish. It was valuable for everyone there to have her perspective. Overall it was a very informative conference.

Vera approached us for translation of a Power Point presentation for a Concepts workshop for the Hispanic Districts. Dorothé provided written translation of the slides. We have been asked about Spanish language materials for GSR school – some were created a few years back; Dorothé is trying to locate a laptop computer which she recalls as having these and other translation committee files, to be updated if necessary. Reilly gave me the text of outline notes for her Delegate's Post-Conference report, which I translated for the benefit of our interpreter in Eugene (District 6, 19 and 20) on June 11. 

The new web site was turned on in September of last year, so we now have one year of usage statistics. Over the past year, the site has been visited by about 6,000 people per month, at an average rate of about 1200 visits per day. We no longer have access to the statistics from the server we used for the old site so we can't compare them, but it does seem that we are reaching a large number of people. The graphs below provide an overview of the past 12 months:



Users are graphed in orange, visits are in yellow.

The new site uses a popular content management system called "WordPress" which, because of it's popularity, is a common target for hackers. We have good security features installed on the site but, based on current information and advice, we have added another layer of protection, at the cost of \$146.18 per year, which is still well within the web site budget. We also make weekly backups of the site in case we need to restore it because of hacking or a server crash.
