AGREEMENT 2018

SPONSOR RESPONSIBILITY (PRINCETON EQUESTRIAN LEAGUE)

- 1. PROMOTION: Each horse show will be named in all advertising listing the qualifying events and the League Finals.
2. STANDINGS: The standings in each division will be updated and the results published.
3. MAILING: The League will provide access to an up-dated mailing list of League Members upon request.

SHOW RESPONSIBILITY (HORSE SHOW)

- 1. DUES/RESULTS/REGISTRATION: The Horse Show must send the following to the League Office within ten (10) days of the conclusion of the event:
A. DUES: For shows that send ShowPro electronic results compatible with PEL's OrgPro, remit \$25 per show. For shows that send paper or electronic results not compatible with PEL's OrgPro, remit dues of \$40 per show. Results will not be processed until payment is received.
B. RESULTS: Complete results must include Horse, Owner and Rider. When classes are combined, results must indicate in which section points are to be awarded. Show or Class results not received within 20 days of the conclusion of the show will be considered to have been canceled.
C. MEMBERSHIP: Completed League rider membership forms and membership fees must accompany results.
D. ADDRESS LIST: A list of all Owner and Rider addresses and emails must be sent.
2. SPECIFICATIONS: League specifications must be posted at the Show Office for exhibitors. Each class must follow the rules and regulations as set forth in the Specifications.
3. PROGRAM/PRIZE LIST: The League will receive two (2) full-page black & white advertisements in the horse show prize list and/or program:
A. The Princeton Equestrian League Application (REQUIRED). Available online at: princetonquestrianleague.com
B. The Princeton Equestrian League Advertisement (REQUIRED). Available online at: princetonquestrianleague.com Please download and use the most current application and advertisement from princetonquestrianleague.com
4. LEAGUE PROMOTION:
A. Member Shows will make available to exhibitors the current membership forms, specifications, and other promotional materials made available to the horse show by PEL.
B. Member Shows will provide PEL with public announcements during each day of the event.
5. AWARDS PRESENTATION: The League will have the opportunity to make the official presentations to the winning riders.
