HR711 (Equal Treatment of public servants act)
Bill deals with Social Security benefits for public safety retirees.

HR2318 (COPS improvement and revitalization act of 2015) Reauthorizes funding, as well as creates new grants for hiring.

HR731 (Justice of Mental Health Collaboration Act)
Authorizes AG to provide grants to establish or expand mental health / criminal justice programs for mentally ill.
