- ✓ I you decide to cancel your reservation you must call <u>72 hours</u> in advance of your booked trip and you will receive a refund minus a 3% merchant fee unless paid by cash or check.
- ✓ If Bob cancels the trip due to inclement weather or an insufficient number of participants, you will receive a 100% refund.
- ✓ Bob will hold 32 spots for GHC residents up to 72 hours in advance and after that will fill any remaining vacancies with outside people on his waiting list.
- ✓ If the dates we have booked for GHC do not suit your schedule you can ask Bob about different sailing dates he has open.
- ✓ This change should make it better for everyone including Bob. Last year there were a significant number of "No-Shows", partially filled seats or canceled cruises due to a low numbers of bookings certain days, making it difficult for him financially.

# Kayaking Adventure at Weeki Wachee

Come along with your friends and neighbors and experience the "Real Florida". This paddling adventure starts at Weeki Wachee Spring State Park and continues downstream for 5.5 miles. When we reach Roger's Park a mini-bus will pick you up and transport you back to the starting point. The Weeki Wachee River is a vision of picturesque beauty and crystal clear water; it meanders through miles of natural canopy. The water depth averages one to four feet and is a constant 72° F at its source. On your trip, keep on the look out for turtles, fish, various aquatic birds, eagles, deer, otters and manatee. 

# Rules & Regs Reminders:



As we have warmer days, more people are using the pool facilities. Please remember at no time are bathing suits, towels or any other article of clothing to be left to dry on chairs or hanging on any of the common areas (stairwells; walkways; grounds) outside of your condominium unit. They cannot be visibly placed outside of your unit for drying purposes. Thank you for your compliance.

## GENERAL RULES AND REGULATIONS

F. The hanging of laundry (including bathing suits and towels) anywhere outside the condominium units is prohibited. Any items such as, but not limited to, linens, clothing, curtains, rugs or mops, are not to be hung or shaken outside of any condominium unit.
