REORGANIZATION MEETING MINUTES

FEBRUARY 21, 2023

Chairwoman Napolitani called the reorganization meeting of the Warren County (Pequest River) Municipal Utilities Authority to order at 7:00 P.M. The meeting was held at the Authority's Administration building located at 199 Foul Rift Road, Belvidere, New Jersey.

Angelo Accetturo; Laurel Napolitani; Gerald Norton; and Joseph Roth were reappointed by the Warren County Commissioners. Mr. Tipton administered the oath of office and congratulated them.

Also, in attendance: Kim Francisco, Authority CFO; Brian Tipton, Esq., Authority Legal Counsel; and Susan Wright, Administrative Assistant.

Chairwoman Napolitani led everyone in the Pledge of Allegiance. Chairwoman Napolitani turned the meeting over to Mr. Tipton to read the Introductory Statement and conduct the Election of Officers.

REPORTS OF COMMITTEES

Finance Committee: Mr. Accetturo did not have any information to report.

Personnel Committee: Chairwoman Napolitani who chairs the committee, gave a brief synopsis of the Personnel Committee's activity during the past year, such as, replacing two of our operators who left, with two new licensed operators.

5-Year Capital Improvement Committee: Mr. Roth did not have any information to report.

ELECTION OF OFFICERS

Mr. Tipton opened the nominations for Chairperson.

Mr. Norton made a motion to nominate Laurel Napolitani for the position of Chairperson. Mr. Roth seconded. Mr. Tipton asked it there were any other nominations. There were no further nominations. The motion passed unanimously on a roll call vote.

The meeting was then turned over to Chairwoman Napolitani.

Chairwoman Napolitani opened the nominations for Vice Chairperson.

Mr. Accetturo nominated a new slate with Mr. Roth for Vice Chairperson, Mr. Norton as Secretary and Mr. Accetturo to remain as Treasurer. Mr. Roth seconded. All in favor, motion passed.

APPOINTMENT OF OFFICERS

General Counsel: Chairwoman Napolitani presented a resolution to award a non-fair and open contract for professional services to Florio Perrucci Steinhardt Cappelli Tipton and Taylor LLC, for legal services for the upcoming year. The rates are \$170.00 per hour, blended rate, for any attorney in the firm, and \$75.00 per hour for paralegals.

Mr. Norton moved to adopt Resolution #23-03, awarding a non-fair and open contract for professional services to Florio Perrucci Steinhardt Cappelli Tipton & Taylor, LLC, for legal services from February 21, 2023 to February 20, 2024. Mr. Roth seconded. All in favor, motion passed.

Consulting Engineer: Chairwoman Napolitani presented a resolution authorizing the award of a non-fair and open contract for professional engineering consulting services to Colliers Engineering & Design for the upcoming year. Various rates are in the agreement.

Mr. Roth moved to adopt Resolution #23-04, awarding a non-fair and open contract for professional engineering consulting services to Colliers Engineering & Design, from February 21, 2023 to February 20, 2024. Mr. Accetturo seconded. All in favor, motion passed.

APPOINTMENT OF COMMITTEES:

Finance Committee: Mr. Accetturo will remain as Chair and Mr. Norton will serve on the Finance Committee.

Personnel Committee: Chairwoman Napolitani will Chair and Mr. Inscho will serve on the Personnel Committee.

Capital Improvements Committee: Mr. Roth will remain as Chair and Mr. Godfrey will serve on the Capital Improvement Committee.

Chairwoman Napolitani introduced a resolution for the appointment of the Authority's Public Agency Compliance Officer for 2023.

Mr. Roth moved to adopt Resolution #23-05, authorizing the appointment of John Inscho as the Authority's Public Agency Compliance Officer (PACO) for 2023. Mr. Accetturo seconded. All in favor, motion passed.

Chairwoman Napolitani introduced resolutions to establish a schedule of meeting dates and designation of the official newspapers.

Mr. Roth moved, and Mr. Norton seconded to adopt Resolutions #23-06 and #23-07, establishing the schedule of meeting dates for 2023, and for designation of the Authority's official newspapers. All in favor, motion passed.

All regular meetings will be held on the third Tuesday of the month, and will start at 7:00 p.m., with the exception of the December 2023 and February 2024 regular meetings, which will immediately follow the Annual Rate Hearing and Reorganization Meeting that will start at 7:00 p.m.

The Board designated the *Star Ledger* as the Authority's official newspaper, and with *The Express Times*, as the two newspapers to receive notices of meetings.

Mr. Accetturo moved that the Reorganization Meeting be adjourned. All in favor, motion carried. The meeting was adjourned at 7:08 p.m.
