1. New Business:

- A. **Resignation of Officers** the club has received resignation letter from two (2) Officers of the Club, effective Thursday, December 22, 2016:

- B. The clubs current bank account must be closed within 10-days; a certified bank check for the funds shall be sent to the appointed designated replacement officer; using a service that requires a signature upon delivery

Any membership renewals received going forward, shall be sent to the appointed designated replacement officer; using a service that requires a signature upon delivery

Receipts for the shipments of any and all Club Treasury property shall be sent to the appointed designated replacement officer, for reimbursement from the club.

C. **Instatement of Officers – ARTICLE III** Officer and Directors; **SECTION 3.** Vacancies. Any vacancies occurring on the Board or among the officers during the year shall be filled until the next annual election by a majority vote of all the members of the Board; except that a vacancy in

the office of President shall be filled automatically by the Vice-President and the remaining vacancy in the office of Vice President shall be filled by the Board.
