#### **TRAFFIC CALMING CAMPAIGN**

Deb Jones has spearheaded an effort by the HOA Board to participate in the City of Aurora Neighborhood Services Traffic Campaign. The traffic calming campaign is designed as a support tool to encourage communication among neighbors about traffic safety and awareness. It is a bottoms-up, grassroots effort to ask drivers to voluntarily slow down. The program is intended for residents as an outreach tool to invite their neighbors to participate in lowering the speed of traffic in the neighborhood. You will be seeing signs posted in yards throughout Andover Glen reminding drivers to slow down and be alert while driving through the neighborhood. Neighbors will be asked for permission before the signs are posted in their yards. Signs will remain in the yards for 2-3 weeks. Please contact Deb Jones if you would like one of the signs or if you would like to volunteer to help place the signs. Marsha Osborn, City HOA Liaison, noted that nearby Shenandoah neighborhood recently conducted the traffic calming campaign over a two week period with measured success.
