On July 8, at 2:25am, Officer Ryan Noon was conducting speed enforcement on Route 208 South when he observed a vehicle pass his location at a high rate of speed. Upon stopping the vehicle, the investigation led to the arrest of the driver, Diana Tartaglione, Dumont, age 24. Ms. Tartaglione was charged with driving while intoxicated, exceeding the speed limit, failure to maintain lane and careless driving. She is scheduled to appear in court. Sergeant Michael DeMaio and Officer Kenneth Marcoux assisted.

On July 11, at 7:07pm, Officer Joseph Fullam was dispatched to the Boulder Run Shopping Center on Franklin Avenue to check the welfare of a driver inside a vehicle. Officer Fullam located the vehicle and the investigation led to the arrest of the driver, Bryan E. Gostissa, Franklin Lakes, age 32. Mr. Gostissa was charged with driving while intoxicated and reckless driving. He is scheduled to appear in court. Officer Kyle Ferreira and Officer Michael Flim assisted.

On July 17, at 5:51pm, Officer James Bakelaar had stopped a vehicle driving into the parking lot of the Wyckoff Shopping Center. The investigation led to the arrest of the driver, Bryan E. Gostissa, Franklin Lakes, age 32. Mr. Gostissa was charged with driving while intoxicated, reckless driving, possession of an open alcoholic beverage container and consuming an alcoholic beverage in a motor vehicle. Officer Kevin Pinches, Officer Ryan Noon, Officer William Christopher and Officer John Rafferty assisted.

On July 19, at 12:58am, Officer Kyle Ferreira was patrolling Franklin Avenue when he observed a vehicle in front of him with an equipment violation. Officer Ferriera stopped the vehicle and the subsequent investigation led to the arrest of Manmit Singh, Wyckoff, age 19. On July 23, at 11:09pm, Officer John Rafferty was dispatched to a reported motor vehicle crash on Mountain Avenue involving one vehicle and a utility pole. During the investigation, Officer Rafferty determined the driver of the vehicle to be intoxicated. The driver, Susan L Springer, Wyckoff, age 21, was arrested. Ms. Springer was charged with driving while intoxicated, failure to exhibit registration and insurance card, failure to maintain lane and reckless driving. She is scheduled to appear in court.
