#### EATHERS IN THE WIND

Perhaps it really began nine months before, but the explosion occurred around March 9th & 10th of 1949 when two neighbor ladies went to Mercy Hospital in Cedar Rapids to give birth to two baby girls, girls whose cries were heard all over the once sleepy (but no longer able to sleep) town of Homestead.

World War II had just ended a very few short years before and everyone thought that things could get back to normal. Little did anyone know that the "Baby Boom" was beginning and these two little girls were going to shake things up!

Born only about 12 hours apart the two would blaze a trail that would last for decades (if one knows where to look one may still find it, much like the original Lincoln Hwy. What follows is strangely reminiscent of a Stephen King novel).

One was short with dark eyes and perpetually skinned knees, the other was tall, blonde and blue eyed- obviously not related, yet somehow they could read each other's thoughts and were always following each other around - no one led - they just followed one another.

When you got right down to it you realized they didn't speak much. They didn't have to because they "sensed" what the other wanted to do.

They would just stare at people with those deep dark (seemingly pupil-less) and wide blue eyes never saying a word.

Those of us who knew the Fearsome Two would just know what they wanted, when, and how. If we did not "obey" they would turn and leave us in a flash leaving us slack jawed, open handed and wondering what had happened.

School came and off they would go to Kindergarten with a major change in the middle of winter when the school was moved from South Amana to the newly built "Lakeside" in Middle.

Theirs would be the largest class Amana ever had (over 40 with 5 girls from Homestead alone) It didn't phase these two because they had figured out how to tell their right from their left hands. Amana, Iowa, Thursday, August 04, 2022

This year they will be welcoming over 30 area artists all of whom will be showing and selling their work. From handcrafted jewelry to watercolors, landscapes, textiles, pottery, photography and paper art, woodcrafts and more, this is a juried show featuring the latest creative efforts of our best Amana Colony and eastern lowa artists.

There will be live music too and a special presentation at 3 p.m. that highlights this anniversary year for the AAG Summer Festival of the Arts. This year a handsewn quilt by Molly Kephart, South Amana, will be raffled. Raffle tickets will be available at the Gallery on Main or at the festival. Huston and his wife Sarah are natives of Wellman, lowa, where they currently reside with their three children, Caedyn (13), Adelyn (13), and Aftyn (7). Mike graduated from Iowa State University in 2004 with a degree in Agricultural Education. While his entire career has been dedicated to working in the seed industry and farming with his father, his love for history is something that he dedicates much of his spare time to. His interest in the Civil War started at a young age when he watched The Civil War, A Film By Ken Burns, documentary with his grandfather. Mike is the descendant of five federal Civil War soldiers and, in his spare time, he enjoys keeping their memory alive by participating in living histories and historical reenactments.

Mike collects images of Iowa Civil War soldiers with an emphasis on Washington County. In December of 2021, his article about a large photo composite of members of Company C 19th Iowa Infantry entitled "The Pride of Washington County" was published in Military Images magazine. He will also be contributing to another article about Iowa Civil War images that will be featured in the December 2022 issue of Military Images.

One way we all cool off is to sweat, but did you know that cattle only sweat at 10 percent the rate of humans? Also, because they are ruminants, cows actually generate extra heat just digesting their food. Surprisingly, sometimes in severe heat, cattle will actually bunch together in the field.

So, what's a cow to do? For answers, I went to Jennifer Sauers, Program Manager of Amana Branded Beef. Jen's background is in cattle, and she works closely with the cow/calf team. Jen told me that they have several strategies in place to help the livestock cope with extreme heat.

#### OBITUARY

Alex A. Meyer, 91, passed away in his home in Jacksonville, Florida, on Sunday, July 17, 2022, and is now at home with the Lord.

Alex was born on February 1, 1931, in Cedar Rapids, Iowa. He served in the U.S. Navy during the Korean Conflict. Once he was mature enough (as Alex liked to say), he graduated from the University of Iowa with a degree in Business Administration in 1956. While at the University of Iowa, Alex met the love of his life, JoAnn, and they were married in 1955. Few who knew Alex would not remember the way he looked at JoAnn, or his "bride" as he still called her after more than 60 years of marriage.

After graduating from the University of Iowa, Alex began working for Amana Refrigeration, Inc. He was a born salesmen and ultimately became Chief Executive Officer of Amana Refrigeration; retiring as Chairman of the Board in 1997. His career was an example of leadership in both profit and non-profit enterprises. In 1985 he was the recipient of the Oscar C. Schmidt Iowa Business Leadership Award. He served on many boards, including of Merchants National Bank, Toro Company, Mercy Medical Center, the Cedar Rapids Museum of Art, and Westminster Presbyterian Church, among many others. He was also the Founder and President of the Foerstner Scholarship Foundation, which provided scholarships for children of employees at Amana Refrigeration.

While he was born in Cedar Rapids, Iowa, Alex had adopted hometowns of Amana, Iowa; St. George Island, Florida; and Jacksonville, Florida. In those places, Alex adored spending time with his family and friends of all kinds, giving tours of the local establishments, and always making people smile. He spent many days hunting, fishing, and spending time outdoors, and enjoyed recounting stories of the same. Alex never met a stranger and, in his later years, enjoyed being about town; going to the Farmer's Market, his favorite restaurant with JoAnn (where you could always find them at lunchtime), and visiting with family. He was immensely proud of his children, grandchildren, and great-grandchildren.

Alex is survived by his wife, JoAnn Meyer, of 66 years; son, Jeff Meyer (Anne); daughter, Margee Michaelis (Peter); grandchildren, Forest Meyer (Shea), Scott Meyer (Lindsay), Alexa Worsham (Mark), and William Michaelis (Brooke); and, great-grandchildren, Alice Grace, Huntley, Beckett, Bodie, and Wells.

At the feedlot where it's more difficult for the stock to spread out, they have a monoslope barn, which is a structure with open sides that has a roof truss higher in the front and sloping toward the back. This feature pulls the air into the barn and down onto the cattle, creating a sort of natural fan. The monoslope barn, along with sprinklers, keep the cattle cool.

The herds out in the fields will seek shade and water in the creeks that run through the pastures. There are also water tanks in every pasture along with the naturally occurring waterways such as creeks and ponds.

The Cow/Calf team, led by Roger Byers, check the creeks regularly to make sure they are not running dry. If they have, the crew will deliver additional water to the cows in trucks. If the grass in the fields has dried out, they begin to haul hay to them. Talk about service!

I always learn so much when speaking with Jen, and I want to thank her specially for taking the time to speak with me.

That you invited someone who felt like a burden, a blight on life, a spot next to you in the grass. Soaking up the sunshine.

The days are far and few in between. Which is why you make the most of them, telling everyone you're there, that you care.

Even if you feel they won't do the same for you, but I promise they do care. Sometimes it's scary dealing with mental health.

For those out there, in that position of fear to help. Since you feel so powerless, you don't understand how to help. So you avoid them. You care- You just don't know how to help.

What you can try to do, is they know you can't fix them. You can't take away the pain; that you just don't have the answer.

They just want an ear. A shoulder to cry on momentarily. Honestly, they'd rather not talk about it. They just want a distraction from the situation. Maybe idle chatting about music, movies, a passion they haven't been able to accomplish.

Sometimes sitting in silence is enough. Because you've done what it seems no one in their life has done. You were there for them, even if it felt otherwise. You made an effort.

For that, we are forever grateful.

If no one has told you today, or lately, I love you. You are an astonishing individual. We have to get past the rains of April to see the flowers of May.

Remember that.

**Publisher's note:** We all know (even if we don't realize it) someone dealing with the hurt described in this letter. My daughter had a friend who committed suicide, something a young person should never feel was the only option left. Sadly, it happens every day.

Note that the Grant Review Committee on July 15, 2022 unanimous approval to recommend the grant. Total bid was \$1500, 75% is \$1125. \$1125 grant value applies. Grant request was reviewed and approved by HPC on July 25th.

d. GRANT REQUEST. Dan and Elizabeth Wood / 4521 220th Trail Amana / HP-C. Remove all caulking on cedar siding, and re-caulk with appropriate caulking. Remove and replace quantity two (2) water damaged corner boards. Remove and replace quantity two (2) water damaged window sill boards. Note Grant Review Committee on July 15, 2022 unanimous approval to recommend the grant. Total bid was \$1925, 60% (commercial property) is \$1155. \$1155 grant value applies. Grant request was reviewed and approved by HPC on July 25th.
