NOTIFICATION

In exercise of the powers conferred by clause (a) of sub-section (2) of section 3 of the Karnataka Electricity (Taxation on consumption or sale) Act, 1959 (Karnataka Act 14 of 1959), the Government of Karnataka, in supersession of Notification-I bearing No: EN 27 EBS 2013 dated No:24.11.2014, hereby specifies that ten paise (10 paise) per unit shall be levied and collected as electricity tax on captive consumption of electricity generated by the Captive Power Generating Plant having total installed capacity of above 500 KVA, with immediate effect until further orders.
