 Without state aid to education, state revenue sharing and state reimbursement for the Maine resident homestead property tax exemption, your tax bill would have been 29.38% higher.  
 If eligible, the Homestead Exemption reduced your bill by \$150.00, and the Veteran's exemption by \$90.00
