

Municipal Government Act RSA 2000 Chapter M-26

Part 10 Division 2 Property Tax

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE SUMMER VILLAGE OF YELLOWSTONE FOR THE 2021 TAXATION YEAR.

WHEREAS the total requirements of the Summer Village of Yellowstone in the Province of Alberta as shown in the budget estimates are as follows:

Whereas, the estimated municipal expenditures and transfers set out in the budget for the Summer Village of Yellowstone for 2021 total \$407,940.00; and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$114,986.00 and \$98,202.00 from "Special Tax" and the balance of \$194,752.00 is to be raised by general municipal taxation; and

Whereas, the Council of the Summer Village of Yellowstone is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

Whereas, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the *Municipal Government Act*, and

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Summer Village of Yellowstone, in the Province of Alberta, enacts as follows:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Summer Village of Yellowstone:

The minimum amount payable as a "Special Tax" shall be \$588.04 per taxable property (which includes a **Waterworks Tax \$2,000.00**, a **Sewer Tax & Sewer Facility Maintenance Tax \$32,000.00**, a **Fire Protection Area Tax \$17,300.00** and a **Recreational Services Tax \$46,902.00**) total parcel count of 167 for a total estimated revenue of \$98,202.00.
3. THAT this BYLAW shall come into force and effective for 2021 taxation on the date of the third and final reading.
