Safe and Fear Free **Environment Inc.**

Safe and Fear-Free Environment Inc (SAFE) is a victim advocacy organization operating throughout the Bristol Bay region since 1982.

Our purpose is to prevent violence, provide services, and promote the well-being of victims of domestic violence, sexual assault, and related abuse.

SAFE's service area includes Dillingham and the 33 villages and tribes in the Bristol Bay Region, an area roughly the size of the state of Ohio. The year-round permanent population base of about 8,000, the majority of whom are Alaska Natives, primarily Yupik Eskimo.

Our Vision, Mission & Philosophy

Vision: Bristol Bay, a culturally empowered community of healthy, connected individuals.

Mission: The mission of Safe and Fear-Free Environment (SAFE) is to provide individual and system advocacy that prevents, reduces, and eliminates interpersonal violence in Bristol Bay.

PHILOSOPHY: SAFE is committed to the right of a person to have power over their own life and to make informed choices about whether, when and how to seek or receive services in a manner that honors their dignity, sovereignty, and sense of self-worth.


Services Provided

Sexual Assault Accompaniment: Accompanying a participant at the hospital or CAC, usually for a forensic exam.

Shelter Nights: Providing safe and confidential housing. It can include safe house and hotel accommodations.

System Advocacy: Network with other service providers to offer comprehensive services within Dillingham, regionally, state-and nation-wide. It includes helping an

individual with public or tribal assistance, finding employment, housing, as well as applying for: food stamps, Violent Crimes Compensation board, child protective services, and adult protective services.




Coming to SISTRS - I go to AA too, but there are things I feel comfortable talking about in front of just women.

Eligibility

SAFE services are free and available regardless of a person(s) gender, race, age, color, ethnicity, mental or physical health status, religion, sexual orientation, marital status or any other condition or circumstance that does not directly preclude the ability to receive services.

However, specific program or services may be limited by law and/or funding source constraints to a specific group or category of clients (children services, SISTR program, etc.).

Emergency Transportation: Transportation paid for by program to remove an individual from an unsafe situation.

Nonemergency Transportation: One-way transportation provided by program to allow access to non-emergency services, such as appointments or support groups.


Crisis Phone Call: Calls received by a program's hotline in which crisis intervention and counseling are the primary purposes of the call.



SISTRS Women's Support Group: Attendance at group education or support sessions.

Individual Advocacy: In-person or telephone contacts in which the primary purpose is to provide advocacy.

Legal Advocacy: Assistance with legal paperwork and navigation of the civil court system, including accompaniment to a protection order hearing or other civil proceeding.



Other Services: Other services include traditional steam (maqi), subsistence fishing and harvesting, providing clothing, as well as tutoring through Myspace Youth Wellness Center.

This year there was Summer Culture Camps in Dillingham, Chignik Lake, and Clarks Point. Children learn subsistence skills and dancing and culture along with prevention activities. Gregg Marxmiller joined Deanna in Clarks Point where the youth made lip balms with Chythlook and Yarrow. There were two large events in conjunction with the Summer Youth Services Program in Dillingham. The Independence Day Celebration brought out more than 200 people in Dillingham and the Traditional Potluck where youth gift elders salmon from the harvest filled the DHS Gym.


The weather was perfect, which is not always the case, but it was this year, gorgeous fall day for strolling, walking, running and biking.
