1. J. Boeck – Status of towing agreement with Sheriff’s Department.
2. S. Schwehofer – Blight issue on Briggeman Road.

4) Clerk Skonieczny read correspondence from D&J Emunson thanking St. Clair Township for the Euchre Party in February.

5) Moved by Clerk Skonieczny. Seconded by Trustee Kays to approve the annual agreement between St. Clair Township and BMJ Engineers and Surveyors. Roll Call: Yes-Trustees Kays and Hovis, Treasurer Hanrahan, Clerk Skonieczny & Supervisor Boulier. No-Trustee Boeck. Motion Carried.

6) Discussed Comcast Agreement. Trustee Hovis requested a representative of Comcast attend our next meeting to answer concerns.

7) Jon and Don Chopp, DPW, addressed the Township Board regarding issues concerning the Township Pump Stations. Check valves, dehumidifiers, fans and sump pumps have been replaced. Also discussed repairs and maintenance that will be needed for the other pump stations.

8) Supervisor Boulier gave an update on Blight issues:

1. Allen Road – Sent information to Township attorney. Court will order to cleanup. If not cleaned up within a certain time, Township has the right to clean up and put fees on tax bill. Property owners fined \$170.00.
2. Mercy Holdings – 1480 Wadhams Road fined \$170.00. Windows were boarded. Michigan Underground Tank Division is investigating. Storage tanks were redtagged.

9) Matt Kandell, St. Clair County RESA, addressed the Township Board regarding running a fiber line to the Township for internet. The cost of the fiber line to run to the Township Hall is \$22,699.58. If DTE denies use of their poles, there will be an additional cost of \$8,023.16. The cost for internet after installation would be \$125.00 a month. Moved by Trustee Hovis. Seconded by Treasurer Hanrahan to have DTE do an evaluation of the actual cost for the project with the cost of the evaluation not to exceed \$1,500.00. Roll Call: Yes-Trustees Hovis, Boeck, Kays, Treasurer Hanrahan, Clerk Skonieczny & Supervisor Boulier. Motion Carried.
