## Some Local Merchants Re-Open Now Some Taking it Slowly

With her May 6 proclamation, lowa Governor Kim Reynolds has allowed for the reopening of retail stores in lowa County, Linn, Johnson, Benton and those counties that had been impacted by the "stay at home" order of mid-April.

To read the entire 8-page order go to the lowa Homeland Security and Emergency Management page on the internet and look for the Governor's Disaster Proclamation date 5/06. Restaurants may reopen (with control measures in place) after midnight on May 15, but bars are to remain closed for now.

It states that a retail business may reopen "but only to the extent that it limits the number of customers present to 50% maximum legal occupancy capacity and implements reasonable measures under the circumstances of each establishment to ensure social distancing of employees and customers, increasing hygiene practices and other public health measures to reduce the risk of transmission of COVID-19 consistent with guidance issued by the lowa Department of Public Health."

This means that business owners follow guidelines issued by the Department of Public Health, while monitoring the number of people who are shopping in their stores.

Finding those rules and implementing them can be bewildering, two shop owners told us last week.

"I am confused, but have been doing a lot of research to try and find out what we need to do exactly," said one Williamsburg merchant.

"It's a little overwhelming, I'm going to be doing my best. I want to have the right information," a colony merchant told us.

After doing some on-line research we discovered that the Quad Cities Chamber of Commerce has prepared an "Opening Your Business in the Age of Covid-19 Toolkit" sponsored by Shive-Hattery that is available free online via the Quad Cities Chamber website. It's a well written, well organized booklet that has recommendations and tips for all kinds of businesses from hair salons to motels and general retail shops, plus signs you can use in your business and resources you can access online.

Aj's Copper Garden, Fern Hill Gifts and Quilts, the Amana Colonies Golf Club, the Amana Colonies RV Park and Event Center and Heritage Designs were open this past weekend.

Hahn Bakery, Yana's, the Amana Colonies Bakery, Fireside Winery and Ackerman Winery will be opening again May 15.

The Amana Heritage Museum is planning to re-open the week of June 1, noted Jon Childers, Amana Heritage Society director.

Nearly all local businesses we talked to plan to be open on or before June 1.

The past two months have been very difficult for area merchants. While many are well prepared to handle a slow winter, no one was ready to see their shops closed completely March 13 through May 8. "I won't lie – it's been tough," one Amana shop owner said last week. "I can handle a slow winter – but being totally closed is something else and the bills just keep coming in for rent, for insurance, for heat, taxes, my health insurance."

Several colony merchants were successful in receiving the COVID-19 CARES Act (Corona Virus Aid, Relief and Economic Security) small business grants or loans. Some business owners applied for unemployment insurance payments previously unavailable to business owners. Some owners relied on their savings and on carryout or online sales.

"We'll do everything we can to keep our customers and ourselves safe. And it will be a big relief to be open again and see my customers. I will be wearing a mask and we'll go through a lot of hand sanitizer, I'm sure! But we'll be open and I hope people will be around and shopping," said an antique shop owner said Friday.

"I know it won't be like last May, but I think people will be wanting to get out and about a little, I hope," she concluded.

### A Few Tips for Shopping During a Pandemic

Doing research for the above story and reading the guidelines noted by various websites, including the Small Business Administration Help-Line for COVID-19, here are just a few tips for shopping these days. Just as a reminder to us all.

How to shop during the COVID-19 pandemic.

- Wear a mask.
- Wash your hands frequently using hot water and soap. Use a hand sanitizer frequently. Carry hand sanitizer with you. Use sanitizer before and after shopping.
- Avoid touching any surfaces. Do not pick up items when shopping unless you plan to buy them. If you touch something and do not buy it please

# Old Creamery Theatre to Suspend 2020 Season

The curtain has closed on the Old Creamery Theatre's 2020 season.

lowa's oldest professional theatre company announced Tuesday that they are suspending their remaining 2020 Main Stage, Youth Theatre and special events in 2020.

The 2020 Prelude to Christmas Show at the Price Creek and a fall dinner theatre production (TBA) at a Cedar Rapids location remain on the schedule at this time, explained co-artistic director Keegan Christopher.

He and wife, Katie Colletta, who serves as co-artistic director, notified employees and were calling members of the media Tuesday afternoon following the the OCTC board's decision Monday night.

"Thinking about our theatre's long term health and hoping to celebrate a 50th season next year, the board made the decision last evening to suspend the 2020 season," Christopher reported.

The Old Creamery Theatre has been closed since mid March when social distancing policies were put into place to help combat the COVID-19 pandemic. The spring shows were cancelled and the remainder of the season was put on hold.

This week with contracts and agreements looming to secure artistic licensing and staff for the upcoming season, the board took a look at the Creamery's budget and agreed it was not prudent to make deposits, book shows and send out binding contracts to produce shows that might not happen. All theaters are closed in lowa and group events and gatherings are suspended until further notice.

The Creamery's fulltime staff of 8 will be employed through June, Christopher noted.

"It certainly breaks your heart. We, Katie and I, have been so blessed to be able to create theatre here in lowa and when you look around and think that the Old Creamery is going to be 50 years old, that's just not seen. You don't see 50-year-old professional companies out there. It was important to do this now to protect the future of the company. . We're looking down the road and really we want to celebrate a 50th and a 51st season so that's the decision that needed to be made," he added.

This is particularly heartbreaking for Ashley Pirsig Shields who was hired this winter to be the OCTC's executive director. Previously, she served as Director of Advancement for Barrington Stage Company in Pittsfield, MA and Director of Development for Flat Rock Playhouse – the State Theatre of North Carolina. She and the company had positive plans for advancing their artistic reach and scope this year.

Season ticket holders will receive a notification on how to redeem their season tickets for next's year's production. Or another option would be to donate the season ticket to the Old Creamery and help the Creamery weather this bleak season. There are other options available to season ticket holders and they may call the OCTC box office for details on all those options. 319-622-6262.
