Southern University economic development program wins national award

The Center for Economic Development Administration of the Southern University College of Business recently won the Judges Award for Overall Best Practices at the University Economic Development Association national summit in Milwaukee,

Wisconstn.

During the competition, 80 universities in five categories presented innovative programs designed to make a difference in economic opportunity. Southern University competed in the nummit as the only historically black college or university with an EDA grant with the U.S. Department of Commerce.

The award winning research project, Creating Neighborhood. Developers, is an accredited program through the College of Business at Southern University, a news release said. Presented by Sung No, assistant professor; Donald Andrews, dean of Southern University's College of Business; and Eric Porter, senior managing partner of ComNet LLC, the project has been adopted as a model by many communities across the state to decrease the high number of blighted properties, to create developers and homeowners, to decrease crime rates and improve neighborhood climate, and to create economic development.

"This program has been provided by the University as an outreach to the community," said Donald Andrews, dean of Southern : University's College of Business. 'We have put on the neighborhood developers program, which includes 10 instructional sessions that cover topics related to economic development, real estate, financial literacy; and project. management. It serves as an opportunity for North Baton Rouge to participate in the development of their own communities."

'In creating this project, it was modeled after a previous program. that was used during recovery efforts of Hurricane Katrina in New Orleans," Porter said. "As a Southern University alumnus, I wanted to co-partner with the university to spur economic development: and create an entrepreneurship ecosystem within North Baton Souge."







- You are free from direction and control in performing your job, AND
- You perform work that is not part of the usual work done by the business that hired you OR is not performed on the business's premises, AND
- You are customarily engaged in an independently established trade, occupation, profession or business.

Louisiana State Licensing Board for Contractors

The Louisiana State Licensing Board for Contractors (LSLBC) was created in 1956 by Act 233 and is governed under Title 37:2150-2192 of the Louisiana Revised Statutes, Chapter 24.

The LSLBC mission is to protect the general public and the integrity of the construction industry.

Through the Commercial Board and its Residential Subcommittee, the LSLBC regulates commercial, industrial, and residential construction projects.

Commercial License

What does Commercial License cover?

- Commercial projects with a value of \$50,000 or more
- Subcontractor/Specialty Trades for commercial projects with a value of \$50,000 or more
- Exceptions:
 - Electrical/Mechanical/Plumbing exceeding \$10,000
 - Hazardous materials with a value of \$1 or more
- Hire licensed subcontractors
- ► More than 19,000 licensed commercial contractors



Commercial License

What are the requirements for licensure?

- Complete and submit an application
- Financial statement with \$10,000 net worth
- Applicant must pass Business & Law exam
- Applicant must pass trade exam, if applicable
- Business entities must be registered with the Louisiana Secretary of State

Electrical, Mechanical & Plumbing Work

Electrical/Mechanical/Plumbing projects exceeding \$10,000 (material and labor combined) requires a Commercial license from the Louisiana State Licensing Board for Contractors.

For Plumbing contractors, contractors must provide a copy of their Master Plumbing License from the State Plumbing Board of Louisiana





Residential License

What does Residential License cover?

- Residential construction or home improvement projects exceeding \$75,000
- Subcontractors/specialty trades for residential projects where the labor and materials exceeds \$7500 for the following specialty classifications: Residential pile driving; residential foundations; residential foundations; residential roofing; residential masonry/stucco; and residential swimming pools
- More than 4,000 licensed residential contractors
- Hire licensed subcontractors



Residential License

What are the requirements for licensure?

- Complete and submit an application
- Financial statement with a minimum of \$10,000 net worth
- Applicant must pass Business and Law exam
- Applicant must pass trade exam, if applicable
- Provide proof of general liability & workers' compensation insurance
- Business entities must be registered with the Louisiana Secretary of State



Licensing Requirements for Building Homes

Residential Building Contractor License

- Single family homes
- A single duplex, triplex, or fourplex

Commercial Building Construction License

- Three or more single family homes built under the same contract in the same subdivision
- Two or more duplexes, triplexes, or fourplexes
- Apartment buildings or condominiums



Residential Specialty Classifications

Effective January 20, 2016, residential subcontractors who bid or perform work in one of the **six new specialty areas** listed below must be licensed for that specialty when the work exceeds \$7,500 (including labor and materials) on any **new** single family residential home, duplex, triplex, or fourplex.

Residential pile driving
Residential foundations
Residential framing
Residential roofing
Residential masonry/stucco
Residential swimming pools



Residential Subcontract Labor Only Specialty Classifications

Subcontractors working under the direct supervision of a licensed residential building contractor may obtain a **Subcontract Labor Only** specialty classification by:

- Completing and submitting an application
- Submitting an affidavit executed by a licensed residential building contractor that attests to the subcontractor's quality of work and character
- Passing the Law, Rules, and Regulation Exam
- Providing proof of current general liability and workers' compensation insurance

Home Improvement Registration

What does this registration cover?

Home improvement projects with a value exceeding \$7,500 but not in excess of \$75,000

What are the requirements to obtain registration?

- Complete and submit an application
- Provide proof of general liability & workers' compensation insurance
- Business entities must be registered with the Louisiana Secretary of State
- More than 2,200 registered home improvement contractors



Mold Remediation License

What does this license cover?

 Mold Remediation projects with a value of \$1.00 or more including labor and materials

What are the requirements for licensure?

- Complete and submit application
- Financial statement with a minimum of \$10,000 net worth
- Applicant must pass Business and Law exam
- Applicant must complete Louisiana's Unfair Trade and Consumer Protection Law seminar
- Applicant must provide proof of Mold Remediation certification
- Provide proof of general liability & workers' compensation insurance
- Business entities must be registered with the Louisiana Secretary of State
 - More than 200 licensed mold remediation contractors

Penalties for Violating Licensing Law

- Unlicensed contractors up to 10% of contract value (Commercial & Residential)
- Licensed contractors
 - Maximum of \$1,000 per violation
 - Suspension
 - Revocation of License
 - Probation
- Home Improvement up to 25% of contract value
- Other legal remedies: cease & desist orders, permanent injunctions, and court costs
- Contractor Fraud May be imprisoned up to 5 years when convicted by a law enforcement agency

UNEMPLOYMENT TAX GUIDELINES
FOR EMPLOYERS:
Independent Contractors

THREE FOLD TEST (INDEPENDENT CONTRACTORS) R.S. 23:1472(12)(E) I, II, III

Services performed by an individual for wages or under any contract of hire, written or oral, expressed or implied, shall be deemed to be employment subject to this Chapter unless and until it is shown to the satisfaction of the administrator that:

- 1. Such individual has been and will continue to be free from any control or direction over the performance of such services both under his contract and in fact; and
- 2. Such service is either outside the usual course of the business for which such service is performed, or that such service is performed outside of all the places of business of the enterprise for which such service is performed; and
- 3. Such individual is customarily engaged in an independently established trade, occupation, profession or business.

CAUTION: Although you may not be subject to the Federal Unemployment Tax Act (FUTA), you may be subject to Louisiana Employment Security Law.

GUIDELINES

A. The following factors indicate that the relationship is employment:

- 1. The individual's services are performed on the business premises of the company.
- 2. The individual has no financial investment in an ongoing business related to the services he is performing.
- 3. The company provides supplies, materials and necessary tools and equipment for the individual.
- 4. The company provides training to the individual in the performance of the services.
- 5. The company's duties to third parties would require that the company maintain control over the individual's performance of services.
- 6. The individual uses the company's business name in the performance of the services.
- 7. The individual is required or expected to personally perform the services.
- 8. The individual is required to report on a periodic basis the services performed, the amount of time the individual performed the services or other details as to the performance of services.
- 9. Effective operation of the company's business requires that the individual be supervised or controlled in the performance of his service; there is need for supervision of the individual.
- 10. There is representation (explicitly or implicitly) by the company to customers or the general public that the individual is an employee of the company.
- 11. There is no written contract or agreement between the company and the individual.
- 12. The company can terminate the individual's services at any time without liability for damages.
- 13. The individual does not have a separate business address or telephone number.
- 14. The individual is prohibited from competing with the company either during the time he is performing services for the company or for any period thereafter.
- 15. The service performed is of an unskilled nature.

- 16. The type of service performed by the individual is the only service, or a major part of the service, which the company provides.
- 17. The individual has no separate insurance coverage for liability in connection with the services performed.
- 18. The individual has no other similar relationships with companies for which he performs similar services.
- 19. The individual is paid on a piece-rate or hourly basis rather than for a short-term project or job.
- 20. The arrangement is for ongoing, continuous services rather than for a short-term project or job.
- 21. The individual is established to the extent that he is financially dependent on the company, and cannot survive economically if he ceases to provide services for the company.
- 22. The individual is required or encouraged to keep regular hours or to perform services only during the company's regular hours.

B. The following factors indicate that the relationship is as an independent contractor:

- 1. The individual has his own place of business separate from that of the company.
- 2. The individual provides his own equipment, supplies and facilities.
- 3. The individual pays for his own expenses for travel and entertainment, licensing and occupational permits.
- 4. The individual has other similar arrangements for the performance of services with other companies.
- 5. The individual receives payment by lump sum or contract rate rather than by an hourly or piecework basis.
- 6. The individual holds himself out to the public as available to perform similar services for others and does in fact perform such services for others.
- 7. The services are of a professional or technical nature, the details of which are outside the usual course of business and best left to the discretion of the individual.
- 8. The arrangement between the individual and the company is in the form of a written agreement which has a specific contract amount and a definite term.
- 9. The individual advertises for the performance of services.

C. In determining how these criteria may be applied, the following considerations will be taken into account:

- 1. Factors must be weighed. Each case has to be considered on its own facts, and the various factors tending to indicate one or the other relationship have to be weighed.
- 2. General control is sufficient to consider the relationship as employment. It is not necessary that the employer actually direct or control the manner in which the services are performed; it is sufficient if the employer has the right to do so.
- 3. Written contract. The existence of a written contract is indicative, but not determinative, of independent contractor status. A written contract does not mean there is an independent contract relationship nor does the absence of a written contract indicate that it necessarily is an employment relationship.
