2021 HOLIDAY PARTY

FRIDAY, DECEMBER 10, 6 to 10 p.m. OAKMONT YACHT CLUB

In light of the continuing presence of Covid, we sent out a survey to all the folks on CHCA's email list to gauge the interest in having a holiday party this year. In response, 43 people said they would want to attend. So the party is on! Because it was such a success, we are planning to return to the Oakmont Yacht Club (OYC), 11 Washington Avenue, Oakmont, PA. This club is the oldest inland yacht club in the United States. It is a beautiful white two-story building sitting next to the Allegheny River.

Some features of the club that will help with making this a safe event:

- We will have exclusive use of the second-floor ballroom with our own bar and bartender. Be prepared to climb stairs as the OYC is an historic building and there is no elevator. But the good news is the restrooms are also on the second floor.
- We will seat as few as six at each round table, depending on your preference.
- The ballroom is spacious.
- The caterer's serve the buffet meal to each guest.

Because the CDC recommends mask wearing in mixed groups, we are asking that only vaccinated people attend.

The catering will be provided by Garda's Restaurant located in Ford City. This is the same caterer as last time.

Park Notes - Jan Kukucka

Improvements made/to be made:

- In early October, about a dozen neighbors repacked the walking trail with 14 tons of limestone dust. Among the volunteers were Russ Biedrzycki, Ed Blazina, Andrea and Jim Getsy, Tom Shuetz, Grace and Brian Edwards, Tom and Judy Conroy, Samantha Moik and Alex Smedburg. This bi-annual job was made easier by Josiah Leisher and his front-loader.
- Three redbud trees were planted as a memorial/beautifier in the park. Another tree task that was less attractive (but no less important) was the removal of several dead or fallen trees. Neighbors removed some of the smaller branches but a private contractor removed the larger pieces. Another tree near the storage shed will be removed before the end of the year. The contractor also will shred piles of sticks and branches collected from around the park.
- The new spring rider, a cute zebra donated by Mimi and Bob Wilson, will be installed.

While Crescent Hills Park is open year around, there are a few different procedures for the winter:

- The portable toilet will be removed at the end of November and will be returned in April.
- There's no snow removal from the parking lot or the walking trail in the winter, so enter at your own risk!

CODE ENFORCEMENT

Neighborhood maintenance and upkeep is a top priority with the Crescent Hills Civic Association.

Crescent Hills is but one part of the larger community of Penn Hills. Setting an example with clean streets and well-maintained homes could potentially inspire our neighbors and those just passing through to do the same.

Code enforcement is one tool that the municipality offers its citizens to obtain building permits or report issues of property neglect.

An easy access web address offers a code enforcement and permitting portal at:

Once the web page opens, you will see the phone contacts for members of the code enforcement department.

This page also includes email links for the above members and documents relating to building permits, occupancy permits, and numerous other items homeowners can access.

A second option to report code issues exists using the web portal.

Step 1. Click the "OPEN PORTAL" box on the webpage then opens a new tab.

Crescent Hills Champions

Sadly, this summer we lost two of CHCA's champions, both of Hathaway Court. Roberta (Bobbie) Moore and William (Bill) Perer died within a month of each other.

We reported Bobbie's passing in our last newsletter, but not the fact that Bobbie was the anonymous Challenge Fund Donor. Her donation, the largest in our history, enabled us to double the park's budget and significantly increase the number of donors.



Bobbie chaired two hugely popular holiday house tours in 2014 and 2019. Those of us on her committee looked forward to each meeting at Bobbie's beautiful home where she, although being from New York, notably displayed Southern hospitality and charm. Bobbie tackled all her projects with passion and joy and it was a delight to be in her presence.

Bobbie's neighbor Sue Beikman remembers Hathaway Court ladies gathering to watch Masterpiece Theater's Downton Abbey series, hosted at times at Bobbie's. Bobbie called the group the Downtonettes. Susan Chikalla also of Hathaway tells about Bobbie's love of her rescue cat Winston who hung out

with Susan's cat Beau. The two ruled the neighborhood. When Bobbie passed after suffering two strokes, her neighbor Nancy Reynolds adopted Winston so the best friends could remain together.



Our other champion, Bill Perer, came with his wife Rosie to Crescent Hills over 10 years ago. They both immediately became active participants in the civic association. Bill became CHCA's cashier for all ticket sales at luncheons, picnics, and other fund raisers. He was enthusiastic about this responsibility, usually first to arrive at the event and always engaging residents as he handled the transactions. By the time of his death, Bill had been battling Parkinson's disease for 30 years. Rosie said that he was considered the "poster child" for the Parkinson's Foundation, showing that the disease could be managed with vigorous exercise. Rosie repeatedly told her friends that Bill was her hero.

Susan Chikalla says that Bill was always happy. Sue Beikman confirmed that Bill did not let Parkinson's get him down. He always had a smile and a twinkle in his eye and would say, "What are you going to do?" Both neighbors described the pleasure he took from feeding the birds and squirrels from his back deck. Susan said that Bill adored his family and that he and Rosie had a beautiful love story that she admired. Bill loved his home on Hathaway Court with the woodsy backyard. Susan observed that he wouldn't have been happier living in a palace and it was apparent that Bill had peace on earth.

Hathaway Court and Crescent Hills have suffered a big loss with their passing. But we shall remember our friends for the times we shared and the blessings their presence brought.
