-  Vendors are responsible for leaving the space in a neat and clean condition.
-  Event is a "Rain or Shine" event.
-  Vendors are asked to be courteous to their neighbors regarding music/noise.
-  It is the responsibility of the vendor to comply with all state, county and local laws.
-  Acceptance of application is subject to approval by the committee. The committee reserves the right to make changes to above rules. All decisions by the Committee will be final.

Sales Tax and Health Code Requirements

All vendors will be responsible for applicable taxes and/or State Health permits. FOR-PROFIT AND NON-PROFIT FOOD VENDORS WILL BE ALLOWED. For-profit food vendors must have a Food Vendor Permit.
