Nomination Guidelines

MID-SHORE CNA OF THE YEAR

Nominees must be a Maryland “CNA” or “CNA/GNA” and in good standing on the Maryland Nursing Assistant Registry.

Nominations will be reviewed by a selection committee comprised of MSNAAC members. The recipient(s) will be chosen based upon criteria on a scale from 0 to 100 points accumulated from:

- Letter of Reference (60 points maximum)
- Nomination Form (40 points maximum)

The Nomination Form - must also be signed by the representative of the facility employing the nominee. The Letter of Reference and the Nomination Form do not have to be completed by the same person. Each document may also be signed by more than one person. The form should reflect your evaluation of the nominee in the 6 areas noted below.

The Letter of Reference – Please describe specific examples of how the nominee demonstrates aspects of the 6 following areas in his or her work as a CNA or GNA and what sets your nominee above others in this field. Anecdotes and/or examples to support or illustrate the statements are also very important:

1. Work ethic
2. Leadership skills
3. Professionalism
4. Compassion for others
5. Teamwork and getting along with coworkers
6. Dedication to healthcare

All nominees and the “CNA of the Year” will be announced at the nursing assistant recognition ceremony. **Submission deadline is April 13, 2020.**
