

**Minutes of Regular Meeting
Liberty Township, Licking County, Ohio
May 11, 2020**

- The regular monthly meeting of the Liberty Township trustees held on Monday, May 11, 2020 via teleconference over Zoom. Bill Siegel, township trustee chairperson, called the meeting to order at 6:30 p.m. He stated the meeting is being recorded, and then led the Pledge of Allegiance.
- Roll call was taken with the following answering as present: Bill Siegel, Bill Bogantz and Dave Cole.
- Bill Bogantz made a motion to approve the minutes from the March 9, 2020, regular trustee meeting. Dave Cole seconded the motion and it passed with all yes votes.

New Business

- The two proposed homes to be built by Developmental Disabilities were discussed. Jason Umstot gave an overview of the homes with input from Carolyn Carnes and Mike Cloud. Ed Wasem, the zoning inspector, stated that the zoning resolution mentions single family dwellings, but not group home. Carolyn Carnes stated that case law considers group homes as single family dwellings and can provide examples. Additional traffic caused by the group homes and the effect on property values were also discussed.
- Melodie Bogantz brought up the need for the township to have a compliance officer for the Credit Card. Bill Bogantz nominated Bill Siegel as the compliance officer. Dave Cole seconded the nomination. The vote: Bill Siegel abstained. Bill Bogantz and Dave Cole voted YES. The motion passed. Bill Siegel is the credit card compliance officer for the township credit card with Park National Bank.
- Bill Siegel updated the trustees on the culvert issues in the township.






- Trustees discussed chain link fencing around the cemetery.
