

UPDATED COVID POLICIES

EVENT, ARTS, AND ENTERTAINMENT

Beginning April 2, 2021, event, arts, and entertainment venues were allowed to reopen at 33 percent capacity with up to 100 people indoors and up to 200 people outdoors. If all attendees present proof of negative test prior to entry, capacity may increase to 150 people indoors and to 500 people outdoors. Social distancing and face coverings are still required by all attendees, as well as strict adherence to all applicable Department of Health (DOH) guidelines.

VACCINATED DOMESTIC TRAVELERS

Domestic travelers to New York State (NYS) who have been vaccinated no longer have to quarantine or test out within 90 days of their full vaccination. The NYS DOH still recommends quarantine after domestic travel as a precaution. Mandatory quarantine remains in effect for international travelers. All travelers must continue to fill out the <u>Traveler Health Form</u>.

RESIDENTIAL GATHERINGS

Beginning March 22nd, residential gatherings of up to 25 people were allowed outdoors. Indoor residential gatherings remained capped at ten people.

So, Gladie, God Bless You in your retirement! We hope you sit back and enjoy the club events from now on.



DEVELOPING A FRAMEWORK FOR LAKE-WIDE SEPTIC INSPECTIONS

As we reported in our March 2021 issue, a group of citizens concerned about Lake George water quality is asking the boards of the eight towns around Lake George to adopt a resolution requesting that the Lake George Park Commission (LGPC) develop a framework for a lake-wide septic inspection program.

At its April 13, 2021 meeting, the Hague Town Board voted 3-2 to adopt this resolution. The non-binding resolution simply demonstrates to the LGPC that local governments want them to take on this responsibility.

The need for a lake-wide septic inspection program has been identified by multiple task forces, watershed

coalitions, surveys and initiatives since the 1980s. And the LGPC is the right authority to act on this. The NY State Environmental Conservation Law empowers the LGPC to adopt rules and regulations for the collection, treatment, and discharge of wastewater within the Lake George Park.

In January 2019, the Town of Queensbury established a local septic inspection program upon property transfer for waterfront residential areas.

Since then, Queensbury has found that about 60% of the septic systems inspected did not pass. Many required relatively minor repairs. However, without the repairs, the systems could be endangering the lake. The state and federal government have invested millions of dollars into sewer systems in several towns on Lake George. This is definitely a step in right direction.

But now, we also need to ensure that properties that are not on a sewer

system also have properly functioning septic systems.

How old is your septic system? Are you performing proper maintenance? When was the last time you had it pumped? These are all important questions not only to help keep Lake George clean, but also to extend the life of your septic system. To learn more about proper septic system maintenance, click HERE.

NON-RESIDENTIAL GATHERINGS

Beginning March 22nd, non-residential social gatherings of up to 100 people were allowed indoors and up to 200 people were allowed to occur outdoors.

WEDDING RECEPTIONS AND CATERED EVENTS

These are now allowed statewide. All venues must follow the state's health and safety protocols, including:

- Venues are restricted to 50% capacity, with no more than 150 attendees per event.
- All attendees must have proof of recent negative test result or proof of immunization prior to the event.
- Sign-in with contact information is required to assist with potential contact tracing.
- Venues must notify local health departments of large events, above the social gathering limit in advance.
- Masks will be required at all times except when seated and eating or drinking.
- Ceremonial and socially-distanced dancing allowed in designated areas.

LGPC REPORT OF THE 2020 REGULATORY PERMIT PROGRAM

The Lake George Park Commission (LGPC) is charged by NYS to protect the natural resources of Lake George to the best of its ability, within its granted authorities. These authorities include oversight and permitting of all marinas, docks, moorings and tour boats on the lake, public safety through its Marine Patrol Division, stormwater management from land development activities, invasive species prevention and management, and other activities.

Deputy Permit Administrator Joe Thouin, PH, CPESC, who is the director of water quality and an environmental analyst, prepared the 2020 report of the Regulatory Permit Program. The report includes information on:

ZONING BOARD OF APPEALS - 3/25/2021

Chairman Robert Goetsch and Board Members Maureen Cherubini, Jon Hanna, Ray Snyder, and alternate Cathy Clark were present. Linda Mury was absent. For the first time, new ZEO Michael Auerbach was in attendance.

ENGLER (43.5-1-26) 9077 Lake Shore Drive (HP)

The applicant is seeking to replace an existing legal non-conforming commercial structure (currently occupied by Made in Hague) with a two-story, mixed-use commercial/residential structure. A variance for sq. ft. increase of more than 25% is requested for a lawful non-conforming structure (proposed 69% expansion). Prior to the meeting, the owner requested that the matter be tabled. The scheduled public hearing was held. No one spoke in favor. Numerous people raised concerns about the negative impact on traffic and pedestrian safety both at Rt. 9N and at the blind driveway on Overbrook. Also mentioned was the perception that the proposed plan would be an undesirable change to the neighborhood behind the building and that the increase in size was too great for a lot size that under current code would not allow a structure. The public hearing will remain open until the ZBA meeting on April 22nd. The board requested that the new ZEO re-review the application.

MILLER (26.14-1-8) 11 Birch Point Lane (TRIR)

The APA had reversed the previously-granted variance due to insufficient information, requiring a resubmission. The board reheard the variance application for constructing a retaining wall, patio, and a four-foot walkway along the lakefront. See *The Hague Chronicle* (October 2020 and March 2021) for details. The board reviewed the details and determined, "The size of the project would be close to an even exchange when completed, but a vast improvement of the environmental conditions of the area with a positive impact." The board also said the variance would provide safer access for the elderly to the lakefront and would improve the appearance of the lot from the lake and neighborhood properties. The board unanimously approved the application with specific conditions.

BOSI (93.12-1-4) 7955 Lakeshore Drive (TR 1)

At the September 24, 2020 Zoning Board Meeting, the board unanimously approved the applicant's variance to construct a retaining wall along their lakefront ten feet back from the MHW. See *The Hague Chronicle* (October 2020) for details. The APA reversed the previously-granted variance due to insufficient information, requiring a resubmission. The applicants requested that the board entertain a motion to rehear a variance application. The board unanimously approved a rehearing and put it on the April 22nd ZBA agenda.

PLANNING BOARD - 4/1/2021

Chairman Dick Frasier, Board Members Dan Belden, Judy Gourley, Meg Haskell, and Pam Peterson were present.

PARLIN (59.-1-11) 3 Dot and Jack Lane

(RC/OCII/TR-1/TR-1R) The applicant is seeking to subdivide an 80.89-acre parcel into two lots. The parcel comprises four zoning districts. The proposed division line follows the contour of Route 9N. A public hearing was held with no one speaking for or against. Discussion was tabled until next meeting.

ENGLISH (60.13-1-11) Red Fox Lane (TR-1) The applicant is seeking to construct a principal dwelling on a vacant lakefront lot. The applicant is obtaining approval from Arcady Bay Association, which has not acted on the application. A public hearing was held with no one speaking for or against. The planning board will hold off discussion until after Arcady has acted on the application and additional information is available. This will be added to the May 6th planning board meeting agenda.

LEWKE (76.20-1-26) 8127 Lake Shore Drive (TR-1R/OCII)

The applicant is seeking to convert its existing three-bedroom cabin into an accessory structure (detached home office) by removing the kitchen and shower. The proposed plan leaves a half-bath in place. The applicant has plans to construct a new four-season home on their 3.4-acre lot. Town Code prevents two residences on one lot. The reclassification of the existing structure is an attempt to salvage the building. A public hearing was held. Three neighbors expressed concern based on events they observed last summer related to a deeded waterfront access tied to a nearby property also owned by the Lewkes. This separate property has a narrow-deeded access to water frontage. Renters appeared to use the waterfront access despite the access not being deeded to the property they rented. Neighbors are concerned that allowing a new larger home to be built while leaving the existing cottage as an accessory structure would put additional strain on the shared water access. Two separate properties owned by others also have deeded rights to this same waterfront. A fourth neighbor was unable to review the lot layout prior to the meeting and expressed concern about the location of the new home and setbacks. The public hearing will remain open until May 6th meeting. An on-site wastewater treatment system needed for the proposed new home is in the process of being re-designed and will need to get approval from the town board. The planning board tabled the reclassification of the existing structure until the May 6th meeting.

BRENNAN (60.5-1-1) 15 Sentinel Pines (TR1)

The applicant is seeking to subdivide a 4.05-acre lakefront parcel into two lots measuring 1.2 and 2.8-acres. The requested survey has been received. The sub-division was unanimously approved.

McLOUGHLIN (76.8-1-6.2) 252 Silver Bay Road (HS-R)

The applicant is seeking to expand the square footage of an existing legal non-conforming structure in excess of 25%. The local Board of Health is reviewing an application for an upgraded on-site wastewater treatment system. A site visit was scheduled. A public hearing will be held at the next planning board meeting on May 6th.

AMERICAN BALLET THEATRE REHEARSES AT SILVER BAY

After nearly a year of isolation and ZOOM rehearsals, some of the world's best ballet dancers, who are with the The American Ballet Theatre, came to Hague last fall to rehearse at Silver Bay YMCA.

The company sent seven dancers, two choreographers, and one staff member to Silver Bay, where they lived in the cottages. They rehearsed in a conference room that had been converted to a dance space with the

installation of a special floor.

At first, the dancers practiced and rehearsed separately, wearing masks, and staying apart. By the second week and after numerous negative COVID-19 tests, they formed a COVID-19 "bubble" so



they could practice together in person.

Their choreographer, Alexei Ratmansky, is one of the best known and busiest choreographers in all of ballet. The troupe rehearsed Ratmansky's new ballet, "Bernstein in a Bubble," which is set to Leonard Bernstein's "Divertimento."

They found Silver Bay YMCA to be an idyllic spot in that it is on a lake, surrounded by forests, and was then blanketed in snow. Ratmansky stated, "It's like a dream come true." Of course, those of us who live in Hague all know that!

In mid-February, the dancers and choreographers left our little bit of heaven and returned to quarantining in New York City. The American Ballet Theatre hopes to be back on stage this fall, touring the country and the world, thanks, in part, to their time rehearsing and relaxing here in Hague at Silver Bay YMCA.

LGA MEMBERS APPROVE MERGER WITH THE FUND

The members of the Lake George Association (LGA) approved the merger of the LGA with The FUND for Lake George (The FUND) to create a new, preeminent lake protection organization. Ninety-eight percent of LGA voters (745 of 760) said yes to the union. The approved merger plan will now go to the Office of the New York State Attorney General for final review and approval. The newly-created organization will retain the LGA name.

The LGA is the longest-serving lake protection organization in the country, having been founded in 1885. "The future of Lake George protection is brighter than ever," said Pete Menzies, current president of the LGA board of directors. "We are thrilled and thankful to the LGA membership for their tremendous vote of confidence in what these two outstanding organizations will be able to accomplish together."

Jeff Killeen, current chairman of The FUND and the chairman elect of the new organization, said, "We are incredibly grateful for the opportunity and responsibility that has been granted to us. With so many water

quality threats looming, Lake George has never needed us more — and I can say without hesitation that our combined staff, board of directors, members, and many community partners are up for the challenge. The new LGA will bring our lake's already-unrivaled level of protection to new and essential heights."

The new LGA will be focused on action, working collaboratively with public and private sector partners, to achieve breakthrough performance in water quality protection programs that are guided by world-class science and supported by community education, awareness, and advocacy.

Protection programs will focus on the lake's most pressing threats: harmful algal blooms; nutrient loading from wastewater and stormwater runoff; invasive species, both aquatic and terrestrial species like hemlock wooly adelgid; and road salt contamination — all of which are compounded by the effects of a changing climate.

Mounting pressure on the lake's water quality was a driving factor in bringing

the two organizations together.

The new LGA will be led by Eric Siy, currently executive director of The FUND, who will become president of the new LGA, and Walt Lender, currently executive director of the LGA, who will

serve as senior vice president.

The following officers and directors have been elected to the new LGA board from among members of the existing LGA and The FUND boards: Chairman Jeffrey M. Killeen; Vice-Chairman Peter Menzies; Treasurer William Creighton; Secretary Roy Davis; Executive Committee Members Dr. Mary Caravella, Keith Ferguson, Thomas West, and I. Robert Wolgin; and Directors Bob Bailey; Lucinda Bhavsar; James Casaccio; Geoff Cook; Charles Crew, William Dutcher; Dr. Linda Schadler Feist; George R. Hearst III; Victor Hershaft; Blair Keller; Dr. John E. Kelly III; Ginger Henry Kuenzel (from Hague); George Morris, Dennis O'Connor; and Ken Parlin (from Hague).

NATURALLY SPEAKING

It is no surprise that the Northern Cardinal is instantly recognizable by most people. The male cardinal is completely red in color and the female has tan feathers with a red wash across the chest, although the intensity of the wash may vary. Cardinals mate for life and will spend much time together. The female lays three or four eggs, which are incubated for 12 to 13 days.

A cardinal couple likes to sing together and duets are not uncommon, but usually the male and female sing for different reasons. The male sings to attract a mate or ward off intruders. The female typically sings to signal the male to bring food to the nestlings.

Cardinals do not migrate, so you can see them all year. They prefer to live

within a mile of where they were born. Cardinal pairs aggressively defend their territory in the warmer months, but in winter cardinal pairs may temporarily band together to form flocks to more easily find food. A flock of cardinals is called a college, radiance, conclave, or Vatican.

The Northern Cardinal's name dates back to the time of the United States' founding colonists, stemming from the similarity of the males' vibrant red plumage to the red biretta and vestments of Catholic cardinals.

Native Americans believe these graceful birds have strong ties to their ancestors, so they believe cardinals to be messengers of the spirits. There are also beliefs about cardinals in Christianity. Some see the bird as representing the blood of Christ while others believe cardinals to be a sign sent from our departed loved ones.

Superstitions abound as well. Usually, the cardinal is a sign of positivity and



good news, but not always. Some people consider a cardinal hitting your window as a bad omen and this hitting relates to the death of someone in the house.

LOOKING BACK

NLGYC's long history grew from several roots, the oldest of which was the Lake George Yacht Club (LGYC), organized in 1888. In the 1920s and 1930s,


there was competitive sailing at the northern end of the lake at Glenburnie and Rogers Rock. The Rogers Rock Yacht Club, organized in 1932, conducted regular weekend races until 1939, when it was found to be impractical to continue and it was believed that no single community could maintain a continuous program of racing.

Around that time, a sailor of the Star Class laid out racing courses in Hague Bay. The idea that the communities at the northern end of the lake should band together to create one yacht club began to develop. In 1940,

representatives from Rogers Rock, Glenburnie, Huletts, and the Adirondack Camp met and merged their existing yacht clubs, forming the NLGYC.

The location of NLGYC was the subject of much study and discussion. Properties in Heart Bay, Glenburnie, and Hague were considered. For seven years, the activities of NLGYC

were conducted from the Friends Point property of Monsignor Keegan, who officiated most of the races. But, the conclusion of WWII brought an increase in membership and activity, and because of the monsignor's failing health, it became clear that the club needed to have its own quarters. The sum of \$14,000 was raised by subscription and it was decided to use the Cook Estate, the property on which the NLGYC now stands.



The simple, but charming, clubhouse has been host to numerous weddings and social events, offering waterfront Adirondack camp charm.

Have you ever wondered what a burgee is? It's a triangular flag that represents a sailing club. The NLGYC's burgee is one of the oldest burgee designs in the country and was created for the LGYC in 1888. In 1941, after the LGYC's dissolution, the flag was transferred to the NLGYC by Miss Helen Simpson, the LGYC's Commodore's daughter. It has flown proudly at the NLGYC to this day.



THE NLGYC HAS MUCH TO OFFER HAGUE

Have you ever looked out at the lake just off the Waltonian Islands on a summer weekend morning, noticed groups of sailboats, heard cannons firing, and wondered what was going on? A bit of investigation reveals it's a hidden gem, the

Northern Lake George Yacht Club (NLGYC), an intergenerational club of over two-hundred families, nestled in a quiet cove on Friends Point. Each summer, members return to this special place, whether they live just down the road or across the country.

Chat with any of the club's lifelong sailors and they will give you a history of the club's different sailboats from 14-foot Akroids to

Comets and Thistles, to the Ferrari-quality Stars, to Lasers, and, of course, a burgeoning sailor's first boat, the bathtub-like N-10. On any given day, small sailors in training can be seen floating in the bay in easily-maneuvered Opti's, honing their skills.

Regular weekend races provide an early-morning routine for sailors, young and old, novice, or experienced. Even during the oppressive days of the COVID-19 summer of 2020, families and friends took to the water and fresh air.

The tennis courts are filled with players, offering another arena for community and playful competition. The recent addition of pickleball lines on the tennis courts has added another fun and exciting activity for ball and racquet enthusiasts.

The annual Commodore's Dinner, where members gather to award club trophies and sailing honors, including the somewhat

dubious "Bottoms Up" award, is held in August and features an annual slide show put together by club member Seddon Beaty.



Potential future club members make lifelong friendships in the NLGYC Junior Program. Campers fill their days with screen-free events, often mingling with friends of various ages, something akin to a rural,

one-room classroom. Where one friend can teach you how to tie a sailor's knot, another will be your partner in an FJ, offering bodyweight to "hike out" in a strong wind. The Junior Program's objectives are to:

- Develop life-long skills in sailing, swimming, and tennis
- · Foster sportsmanship, seamanship, and racing skill
- · Continue the heritage of the NLGYC community
- Nurture an appreciation and respect for Lake George

Guests are encouraged to purchase tickets online in advance by visiting www.fortticonderoga.org.

"Fort Ticonderoga is a must-see destination, a center of learning, and an interactive, multi-faceted experience," said Beth Hill, Fort Ticonderoga president and CEO. "It's exploring the beautiful gardens, finding adventure in our signature events, touring Lake Champlain aboard the Carillon boat, marching with the Fifes and Drums, and learning about a historic trade. It's a visit through the reconstructed fort, a stroll on Carillon Battlefield hiking trail, and an unforgettable view from the top of Mount Defiance with a sweeping vista of Lake Champlain and Vermont's Green Mountains."

2021 highlights include:

1774: Guests will see daily weapons demonstrations and explore programs, new exhibits, gardens, historic trades, and other family adventures.


