

**PETITION FOR SPECIAL ELECTION TO FILL A VACANCY ON THE GOVERNING BOARD OF THE  
IRVINE UNIFIED SCHOOL DISTRICT**

We, the undersigned registered voters of the Irvine Unified School District of Orange County, California, hereby petition for the calling of a special election pursuant to Section 5091(c) of the Education Code, to fill the vacancy on the Governing Board of the Irvine Unified School District created by the resignation in office of Dr. Gavin Huntley-Fenner effective November 21, 2013, and the provisional appointment of Ira Glasky on November 21, 2013. This petition shall be submitted to the Orange County Superintendent of Schools, 200 Kalmus Drive, Costa Mesa, California. The cost for conducting the election called for in this petition is estimated by the Orange County Registrar of Voters to be \$392,779-\$443,329 if the election is a stand-alone election.
