Andover Glen is an HOA Covenant neighborhood. If you need to review the covenants, you can

find them on our website at www.andoverglen.org but here are just a few reminders to help keep our community beautiful:

- A vehicle that is inoperable, partially or totally dismantled, or is wrecked or damaged to the extent that it would be unlawful to operate on public streets may not be stored outside on any public or private property.
- Motor vehicles must be currently registered and display a valid license plate.
- It is unlawful to conduct major auto repair outside on private property or on public streets.
- It is the responsibility of the owner to cut and/or remove all weeds over 8" in height.
- Also, the city of Aurora requires that trash containers must be screened from view.
