5. Received complaints of barking dogs on Taylor Rd, Animal Control has been contacted and residents have been informed that nothing can be done unless they hear the dogs barking. Also Department of Agricultural & Rural Development have been contacted to look possible manure runoff possible into the River Raisin.
