1. MAIN LINE OF ACTION 2015

LIFE PROTECTION PICTURE IN THE EU

European and National overview

CONDUCT THE STATE-OF-THE-ART ON THE PROTECTION OF LIFE IN EACH COUNTRY: LEGAL, JURIDICAL, POLITICAL, SCIENTIFIC, MEDIA AND SOCIAL PERSPECTIVE

- Elaboration of the Annual statistics by Member's Organisations
- Life protection situation detail picture in each country with the thorough work from the NATIONAL COORDINATORS and NATIONAL ENTITIES
- Standard tools to elaborate the statistics and for its development: Executive Committee will provide the tools to unify the criteria
- December 2015 celebration II General Assembly to present the situation in a 10 minutes intervention by each member State. Presentation first publication annual book of the Life situation in Europe. Place: France

2. MAIN LINE OF ACTION 2015

Preparatory acts (Public Debate support)

THE MAIN LINE OF ACTION SHOULD BE PRECEDED BY A SET OF INTERMEDIATE AND PREPARATORY ACTIONS AIMED TO THE MAIN ACTION

1. Open a public debate on the rejection of the initiative from the perspective of justice, science and politics.
2. Document of accession elaborated by Mr. Carlo Casini must be circulated nationwide by the coordinators and Entities.
3. Collect support/adhesion from 1) scientific, 2) political and 3) legal communities
4. June 2015 closing the collection of supports
5. Organize a Mass Media Event at National and European Level to present the supports.

Preparatory acts (Marches for Life)

SUPPORT TO **MARCHES FOR LIFE**

- Visibility, presence and support of the Federation in all the Marches for Life organized by the countries.
- Promoted by National Coordinators and Entities together with the Federation Executive Committee
- Coordination among the members

5. MAIN LINE OF ACTION **2015**

Preparatory acts (Singular Events)

SINGULAR EVENTS 2015

- ANNUAL EUROPEAN AWARD FOR LIFE.
Annual grant to individuals or Social Entities with widely recognized prestige in defence of Life. (December 2015, Anniversary of the Human Rights Declaration)

6. MAIN LINE OF ACTION 2015

AD HOC AND TO-THE-POINT ACTIONS IN MEMBER COUNTRIES

Preparatory acts (Extraordinary meetings)

- In countries where specific legal, juridical or scientific situations require an *ad hoc* support and visibility of the Federation
- Action to be promoted by National Coordinators and Organizations when required by ad hoc situations

7. MAIN LINE OF ACTION 2015

COMMUNICATION

BUILDING ON THE PILLARS OF THE FEDERATION AND THE DESCRIBED MAIN LINE OF ACTION THE COMMUNICATION PLAN MUST

- strengthens the network,
- develop alliances
- reach as many supports as possible with the message of “One of Us”

Internal Communication keys

- Maintain strong links and dialogue with National entities
- Remain loyal to the core message and mission
- Enhance resources and organization
- Enhance internal communication and coordination

External Communication keys

- Maintain strong contacts with the EU Institutions
- Maintain links with major players/stakeholders
- Maintain links with the citizens’ supporting One of Us Initiative
- Be present in all debates related to mission.
- Build alliances

8. MAIN LINE OF ACTION 2015

NETWORKING

MEMBERS IN ALL EU MEMBER STATES or REPRESENTATIVES

- THE CENTRAL OFFICE based in Brussels together with the EXECUTIVE COMMITTEE will work in 2015 to ensure that all European Member States are represented in the Federation
- If this is not possible, the goal will be to establish and ensure a point of contact to the Federation.
- Reinforce connections with the Members of the European Parliament (MEP's).
