City Council Minutes

July 5<sup>th</sup>, 2016

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe and Ron Doll were present, Dan Krueger was absent.
