- F. Coach report:

 - b. There have been multiple complaints of out of hand parents and the coach not controlling them on team U19C04. Mike Biezdad will talk with the coach.
 - c. Team U12B03 had to forfeit their game because not enough players showed up on time.
 - d. The mid-season coaches meeting for divisions U10-U19 will be at Auburn Rusty's on November 2nd at 6:30pm.

 - a. Mike Biezdad motioned, Mike Uribe seconded, that BRYSL accept Lee Rangel's U12 club team under the BRYSL name. Lee Rangel will also become a voting board member. Motion passed unanimously.

- B. Cal South Representatives Hector Tovar and Jorge Sotello came by to give us the information on the Commissioner's Cup.
 - a. The U10 division will be 7v7 on a small sided field.
 - b. The U12 division will be 11v11 on a standard sized field.
 - c. The U14 coed division will be 11v11 on a standard sized field.
- C. The league will be sending 10 teams to the Commissioner's Cup.
 - a. 2 U10 Boys and Girls
 - b. 2 U12 Boys and Girls
 - c. 2 U14 Coed teams.
- D. BRYSL guidelines for a team to qualify for the Commissioner's Cup are:
 - a. All volunteers must be fulfilled and the team must have a sponsor. In addition, the team referee must have refereed a least 5 weeks' worth of games.
 - i. Mike Biezd motioned, Mike Uribe seconded, that in order for a team to qualify for the Commissioner's Cup, they must have met all of BRYSL guidelines; motion passed unanimously.
